

Proposed state of Jefferson



Post World War III Courtesy of the UN




The above map is the UN plan to divide America in the event of a World III gone bad for the United States in which America is carved up like the proverbial Thanksgiving turkey.



Back in the late 1960s, after Pat Brown ceded the governor's mansion to Ronald Reagan, Brown went into private law practice. Among his clients was Pertamina, Indonesia's state-owned oil and gas company.



Keep in mind that in the late 1960s, Indonesia was governed by the repressive Suharto regime, which had seized power in 1965 from the leftist Sukarno in a bloody coup that ultimately killed half a million people. To see Pat Brown's name – inextricably wound up with California's progressive politics – linked to Suharto's is a shock indeed.

Anyway, Walters reported that Brown helped Pertamina's boss Ibnu Sutowo get \$13 billion in loans, which went into default after Sutowo got busted for corruption.



"Brown's reward was a concession to market Pertamina's oil in the United States," Walters reported. "Brown's law firm also represented Indonesia as a lobbyist in Washington."



According to Walters' reporting, the elder Brown insisted that his son, Jerry, rejected any financial interest in Brown's Indonesian oil venture (though apparently daughter and former state treasurer Kathleen Brown did). But that doesn't mean Gov. Jerry Brown didn't have his own Indonesian troubles.



Indonesia's LNG Plants

In the late 1970s, “A powerful coalition of business and labor interests began promoting a project to ship liquefied natural gas to California in huge tankers from Indonesia and Alaska and then-Gov. Jerry Brown launched an all-out drive to win approval of the LNG terminal,” Walters reported in the Mar. 15, 2001 *Sacramento Bee*. Pat Brown lobbied heavily for the terminal, which was to sit near Santa Barbara. Though approved, it was never built – concern over earthquakes and suddenly abundant LNG supplies brought about by industry deregulation ultimately killed the deal, reported Walters.

But that wasn't the end of the story. Concurrent with the LNG terminal push, the California Air Resources Board (CARB) "adopted new requirements for the sulfur content of fuel oil," Walters reported back in 1990. As a result, power plants had to buy their oil from Indonesian supplies, which had lower sulfur levels than that of, say, Alaska.

"Jerry Brown angrily denied suggestions that those actions were a conflict of interest, insisting that he had no personal involvement with Perta or Pertamina, although Perta and its executives had loaned or contributed some \$70,000 to his 1974 campaign for governor," Walters reported in 1990.

***Sacramento Bee* political columnist Dan Walters spent months researching the source of the Brown family wealth. After Jerry's father, Pat, left the governorship in 1967, he was introduced to the Indonesian generals who had just overthrown the country's post-colonial dictator, Sukarno, and set up a military junta. The former governor was able to put together a consortium of banks that lent \$12 billion to the junta to expand the immense Royal Dutch Shell petroleum holdings in Indonesia, which Sukarno had nationalized.**



The grateful generals then set up two trading firms—one in Hong Kong and one in California—that handled the oil-exporting paperwork and were rewarded with a fee for each barrel. Pat Brown was given 100 percent ownership of the California brokerage and half-ownership of the Hong Kong office.



Jerry Brown received his cut of the family oil business when he left office as Governor in 1983. Walters told the *Washington Times*, “He just hates the idea that people will bring it up because what it is, is the Brown family is in partnership with these corrupt, murderous dictators. It’s not something that a Jerry Brown wants to be associated with.”



Despite Brown's latest "presidential tirade" against fossil fuels, he has been very supportive of the California oil industry while governor. He pushed through and signed pro-fracking legislation in late 2013, known as Senate Bill 4. He also quietly accepted \$1.72 million in political donations over the past several years from oil and natural gas interests to his statewide political campaigns for attorney general and governor, along with his Proposition 30 ballot-measure campaign in 2012.





In recent years Brown has quietly built a small fortune in real estate and stock holdings, in part by going into business with prominent Oakland developers whom he once regulated as that city's mayor, a Bay Area News Group analysis of Brown's personal investments shows.


While Gov. Brown was busy over the last four years frugally balancing California's budget, the state's chief executive was actively building up his multimillion-dollar real estate portfolio. Just two years ago, he invested in an \$11 million office building near Oakland International Airport in an area that is being considered for a massive "Coliseum City" redevelopment project that could include new baseball and football stadiums.

And earlier this year Brown and partners broke ground on a 100-unit apartment building on prime real estate they bought in 2007 on the Oakland-Emeryville border.



This newspaper found Brown has stakes in millions of dollars of East Bay real estate with developers Phil Tagami — who did a lot of business with Oakland when Brown was mayor — and John Protopappas, who was Brown’s landlord.

He also drew up to \$100,000 in income last year from a Beverly Hills investment firm, is part-owner of his family's sprawling Colusa County ranch and owns up to \$1 million worth of stock in a medical office software firm, while his wife owns more than \$1 million in Jack in the Box stock.


Jerry Brown's woes regarding his family land outside of Williams, CA. in Colusa County may just be getting started. Earlier this week allegations of wrong doing regarding the private use, by Governor Brown, of public employees and funds surfaced in California Media.

It was alleged that Governor Brown had used a public agency and public monies to investigate the geological composition of his ancestral homestead. The validity of these allegations began to strengthen later in the week when Jennie Catalano, a mapping specialist for the California Department of Conservation, applied for whistleblower protection status.

Researching further into public land documents, it has been discovered that the ranch in question has been held as a private trust, Rancho Venada Inc., since 1962 with Ann Gust Brown listed as the primary trustee.

It is believed the Rancho Venada Trust is comprised of beneficiaries Jerry Brown as 27% share holder, another 27% Brown family share member, believed to be Kathleen Brown (former treasurer of the State of California who has ties to Royal Dutch Shell Oil through her father "Pat" Brown) and an as yet still elusive 46% minority shareholder.



Tax “Typo” Lead to Governor Brown Land Deal Questions, More Questions Arise



The Lantern has acquired copies of the original 1962 deeds of the 6 parcels that originated the Rancho Venada Inc. land trust of which Governor Jerry Brown is a 27% minority stake holder. Those documents refer to parcels 016-040-013, 016-040-014, 016-100-010, 016-110-002, 016-110-003 and 016-110-004 and confirms Browns claim that parcels# 016-100-002, 016-100-003 were never part of the Rancho Venada trust.






The Governor's office had initially denied the reports and categorically dismissed Ms. Catalano's allegation. Later that day the head of the California Department of Conservation produced a 52 page report detailing geological information of the property, including satellite imagery and detailed soil surveys, that had been completed at the Governor Brown's behest. Many believe the surveys were to assess the possibility of shale oil and natural gas deposits. Publicly available shale oil maps clearly show the Brown homestead strategically placed atop an assumed large shale deposit of frack-able oil.

Under further investigation the Shasta Lantern reported statements claimed to be attributed to a Brown ranch employee that the wells were in fact to irrigate California's first Public/Private Marijuana farm.


Calexit vs. the State of Jefferson




Amnesty Groups Fight to Hide California Gang Database From Trump

Immigration advocacy groups are asking California Attorney General Kamala Harris to “block federal access” to the database containing names of gang members in the state.


The operational plan consists of three options:

Ryoichi Sasakawa: the allied forces opened a file on him as a Class A war criminal after the unconditional capitulation of Japan during World War II. Ryoichi Sasakawa was locked up in the Sugamo prison in the outskirts of Tokyo.

Ryoichi Sasakawa organized an army of 150 000 militiamen who participated in plundering operations in China, sometimes collaborating with the Kodama Kikan, a fascist organization led by his friend Yoshio Kodama. It's all about officially controlling the production and export of strategic resources.

Thus, the «lords of the war» amassed a large fortune in Manchuria and Mongolia with the support of the imperial government. Sasakawa and Kodama, thanks to their private armies - Sasakawa even created an airborne unit with 20 airplanes and an airport in Osaka -, defrauded rich Chinese dealers and traffic in opium on their own.

At the end of the world war, the “lords of the war” were imprisoned with the other “Class A” inmates of the Sugamo prison. Kodama and Sasakawa would often visit Nobusuke Kishi, future key man of the Liberal Democratic Party, and Shiro Ishii, who directed the experiments of Camp 731. The Liberal Democratic Party was indeed a single organization that ruled Japan since their defeat with Washington's approval.



The Majority of Class A War Criminals Not Tried but Released. Most regrettably was the fact that, of the 70 Japanese apprehended for Class A war criminals, only the first group of 28 people were brought to trial, the rest which was divided into the 2nd and 3rd groups awaited to be tried in Sugamo prison of Tokyo.

Ryoichi Sasakawa: One of the leading Fascists and Militarists of Japan organized his private army of 15,000 men equipped with 20 warplanes and dressed in black shirt to emulate that of Mussolini, his idol after "September 18, 1931" Incident. Following the outbreak of the Pacific War, his army massacred thousands of innocent Chinese and Malaysians for which he earned the name of "Tiger of Malaya." After the war, he kept his Mafia business in Japan involving drug trafficking, pornographic enterprises, gambling, and usury that made him the super rich, with which he had become the leading philanthropist of the world; he showered handsome donations to the United Nations, President Carter's Library, and one million dollars each to the leading universities of America.

Moreover all the uncondemned Class A war criminals were set free by Gen. MacArthur in 1947 and 1948. Most of them immediately returned to the Japanese political arena, which was again dominated by the same Fascists and militarists though clad in democratic cloak in disguise.



SUGAMO PRISON

A.P.O. 500

The regiment 731 of the Japanese imperial army settled in the Chinese city of Harbin in 1931. The prisoners' camp of Harbin served as a laboratory for experimentation on human beings. Japanese scientists used Chinese prisoners and, from 1942 on, they also used American and Soviet prisoners in experiments trying to determine if human resistance to certain mortal diseases had to do with the "race" of the ill ones. Three thousand human beings were used as guinea pigs and had horrible deaths caused by typhus, the bubonic plague, cholera and syphilis in the experiments of the Japanese Mengel whose real name was Shiro Ishii. When the Soviet Red Army freed Harbin, the last surviving "laboratory human beings" were gassed and the Japanese tried to erase any evidence of such experiments in the Camp 731. Shiro Ishii returned to Japan. The American secret services offered him his freedom in exchange for the results of his experiments in Harbin. Shiro Ishii peacefully dies in 1959 and he was never bothered for his past.

Sasakawa claimed to be the leader of an eight-million men army. He headed numerous associations that served as a cover for his mafia activities. His karate and saber dance clubs included more than 3,500 000 members he similarly headed groups that were openly fascist like the International Federation for Victory over Communism (IFFVOC) that declared 160,000 members. This army turned Sasakawa into one of the most respected yakuas in Japan. He and his friend Kodama controlled the mafia world and solved conflicts among rival gangs.

On the other hand, in 1963 Sasakawa became the main advisor of Reverend Sun Myung Moon. He encouraged the expansion of the Church of the Unification (Moon sect). With Moon and Chang Kai Chek he founded the World Anti-Communist League (WALC), a result of the merger between the Anti-Communist League of the Asian Peoples (APALC) and the Anti-Bolshevik Nations Bloc (ABN). The organization, that brought together the extremist factions of the Taiwanese, South Korean and American secret services, was behind military interventions in South America and Asia. Sasakawa facilitated the coup d'état against Indonesian leader Sukarno and supported Philippine dictator Marcos through a mutual assistance association



The political leverage of Ryoichi Sasakawa, combined with his mafia activities, allowed him to build a huge empire with the consent of the US authorities. Thus, he immersed himself in a philanthropic career, investing part of his fortune in a foundation, the richest before the powerful Ford Foundation. He, who was proud of being «*the richest fascist of the world*» never hid his desire of obtaining, like his friend Jimmy Carter, the Nobel Peace Prize, but he had to content himself with the Helen Keller International Award, the Linus Pauling for Humanitarianism and the Peace medal granted by the United Nations.

In February 1978, by means of his naval construction foundation, he transferred half a million dollars to the United Nations and, in 1979, a million dollars to the United Nations Educational, Scientific and Cultural Organization (UNESCO), thus becoming the most important sponsor of the UN institutions. However, this generosity had another face. The Sasakawa clan, Ryoichi and his three sons) tried to control the organizations that receive their donations.





US President Jimmy Carter runs with Ryoichi Sasakawa, who was his main financing source for his post-presidential political campaigns and programs.

Once more, the Sasakawa clan was accused of organizing corruption. Nakajima, in recognition, erected a statue of his benefactor Sasakawa in the lobby of the WHO in Geneva. The powerful Japanese foundation, main private donor of the WHO, knew how to become indispensable: in 1996 it deposited 10 million dollars for a program to fight leprosy

In 1999, when the election of an Egyptian lawyer ahead of UNESCO seemed definite, African representatives voted against their candidate and guaranteed the election of Japanese diplomat Matsuura. All the indications were that the Sasakawa Foundation promised «donations» in exchange for the votes of the African delegates.

Ryoichi Sasakawa died in 1995 without the so much coveted Nobel Peace Prize.

His three sons replaced him at the powerful Sasakawa Foundation and continued his businesses with the same networks and practices of their father.

Yohei is the president of the Foundation : he chairs the administrative council of the French subsidiary and he has met on several occasions with the friend of the family Jimmy Carter. Takashi has relations with the underworld and he has tried to buy the Shelburne Hotel Casino of Atlantic City so as to introduce himself into gambling in the United States.

The Lantern has acquired copies of the original 1962 deeds of the 6 parcels that originated the Rancho Venada Inc. land trust of which Governor Jerry Brown is a 27% minority stake holder. Those documents refer to parcels 016-040-013, 016-040-014, 016-100-010, 016-110-002, 016-110-003 and 016-110-004 and confirms Browns **claim that parcels# 016-100-002, 016-100-003 were never part of the Rancho Venada trust. However the parcels 016-100-002 and 016-100-003 were purchased from Sanwa Bank's Southern California holding company in 2005. The now defunct Sanwa Bank was a Multinational based out of Osaka, Japan that was ultimately absorbed by the Bank of Tokyo-Mitsubishi.



Mitsubishi is headed by Takashi Sasakawa son of now deceased Ryoichi Sasakawa, a notorious Japanese war criminal responsible for many atrocities and theft in Manchuria from 1931-1945. That's just the unfunded pension liability; the state also has significant unfunded liabilities for retired government worker health benefits.

No More Federal Money For California's High-Speed Choo Choo To Nowhere

California's high-speed rail project has become a comedy of errors that will certainly be a major part of Gov. Brown's legacy, though not in the positive way that he envisioned. Projected to cost \$30 billion when it was first approved by voters in 2006, it's now optimistically estimated that a train connecting Los Angeles and San Francisco will ultimately cost in excess of \$60 billion.

Meanwhile, as homelessness drops nationwide, it has increased in California.




GHOST CITIES
