



Founded in 1968 by Italian industrialist, Aurelio Peccei, the Club of Rome is a global think tank that deals with a variety of international political issues. Originally, the Club of Rome had defined the three major concepts that have formed the Club's thinking ever since: a global perspective, the long term, and the cluster of intertwined problems they called "the problematique".

The Club of Rome is perhaps at the apex of the New World Order pyramid, a [Neo-Malthusian](#) organization with interlocking membership with European power elite groups such as the [Committee of 300](#) (a secret society founded by the British aristocracy in 1727) and the [Bilderberg Group](#).

[Thomas Robert Malthus](#) argued that population was held within resource limits by two types of checks: positive ones, which raised the death rate, and preventative ones, which lowered the birth rate. The positive checks included hunger, disease and war; the preventative checks, [abortion](#), birth control, prostitution, homosexuality, postponement of marriage, and celibacy.

Psychopathy Among Elites - As psychopaths they have no conscience, lust for power and control and are literally capable of anything.



Key Tactics

False Flag Operations / Government Sponsored Terror-
The attacks of September 11, 2001 and the London Bombings on 7/7/2005 are a couple of the most recent false flag operations. (You can add in Boston Marathon and Sandy Hook)

Agent Provocateurs - Governments throughout history have a habit of hiring agent provocateurs in order to discredit legitimate protest.

Key Tactics

Hegelian Dialectics (i.e. Problem/Reaction/Solution) -
The Hegelian Dialectic is, in short, the critical process by which the ruling elite create a problem, anticipating in advance the reaction that the population will have to the given crisis, and thus conditioning the people that a change is needed. When the population is properly conditioned, the desired agenda of the ruling elite is presented as the solution.

Five families, in particular, have made a killing off killing — from the enormously lucrative business of debt it creates to the industries feeding off the plundering of world resources — and therefore control the world.




Morgan - Morgan controlled the U.S.' gold supply — allowing him the flexibility to then finance the creation of U.S. Steel, after an offer to buyout Andrew Carnegie for a price in excess of the U.S. government's entire budget. After threatening Westinghouse — which had employed Nikola Tesla's electricity using alternating current — with a patent infringement lawsuit, Morgan gained control of the emerging electric light industry and formed General Electric.

And his attempts to profit while exerting influence didn't stop there. In an investigation afterward, it was revealed America had entered World War I, not for political and policy concerns, but for the profits of the banking and munitions industries. Recent rumors have suggested a far comfortable relationship than the public would prefer, between what is now JP Morgan Chase and the Federal Reserve.



Du Pont - DuPont began manufacturing dynamite, growing to such incredible proportions — through collusion with its competition in the “Powder Trust” to fix prices. Its ventures as military munitions supplier expanded from that point, and the company played a key role in the Manhattan Project’s development and production of the first atomic bomb — which the U.S. readily used to decimate Hiroshima and Nagasaki during World War II. DuPont reportedly produced 4.5 billion pounds of military explosives used over the course of that war.

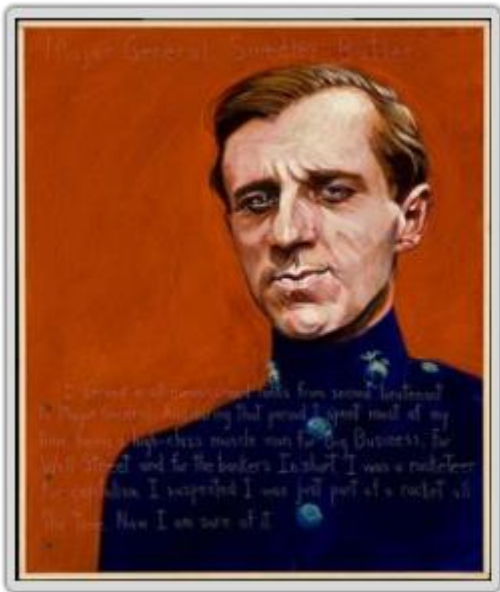

Major General US Marine Corps, Antiwar Activist : 1881-1940

"I served in all commissioned ranks from second lieutenant to Major General. And during that period I spent most of my time being a high-class muscle man for Big Business, for Wall Street and for the bankers. In short, I was a racketeer for capitalism. I suspected I was just part of the racket all the time. Now I am sure of it."

Received 16 military medals, 5 for valor. Is one of 19 men to receive the Medal of Honor twice.

Wrote the 1935 exposé that linked business and the military titled "War Is A Racket."

Ran for Senate as a Republican in 1932.

At the time of his death, Major General Smedley Darlington Butler, also known as "The Fighting Quaker", was the most decorated Marine in US history; he was the only person to be awarded a Marine Corps Brevet Medal and a Medal of Honor for two separate military actions. He had also become an unrelenting voice against the business of war.

***War is a Racket* grew out of a series of speeches Butler gave to whatever group wanted to hear his views. Though he faced criticism, Butler was steadfast in his beliefs about war, US imperialism, and a growing Pro-Fascist movement. He spoke frankly and honestly about his experiences and opinions, and was very popular with the American public.**

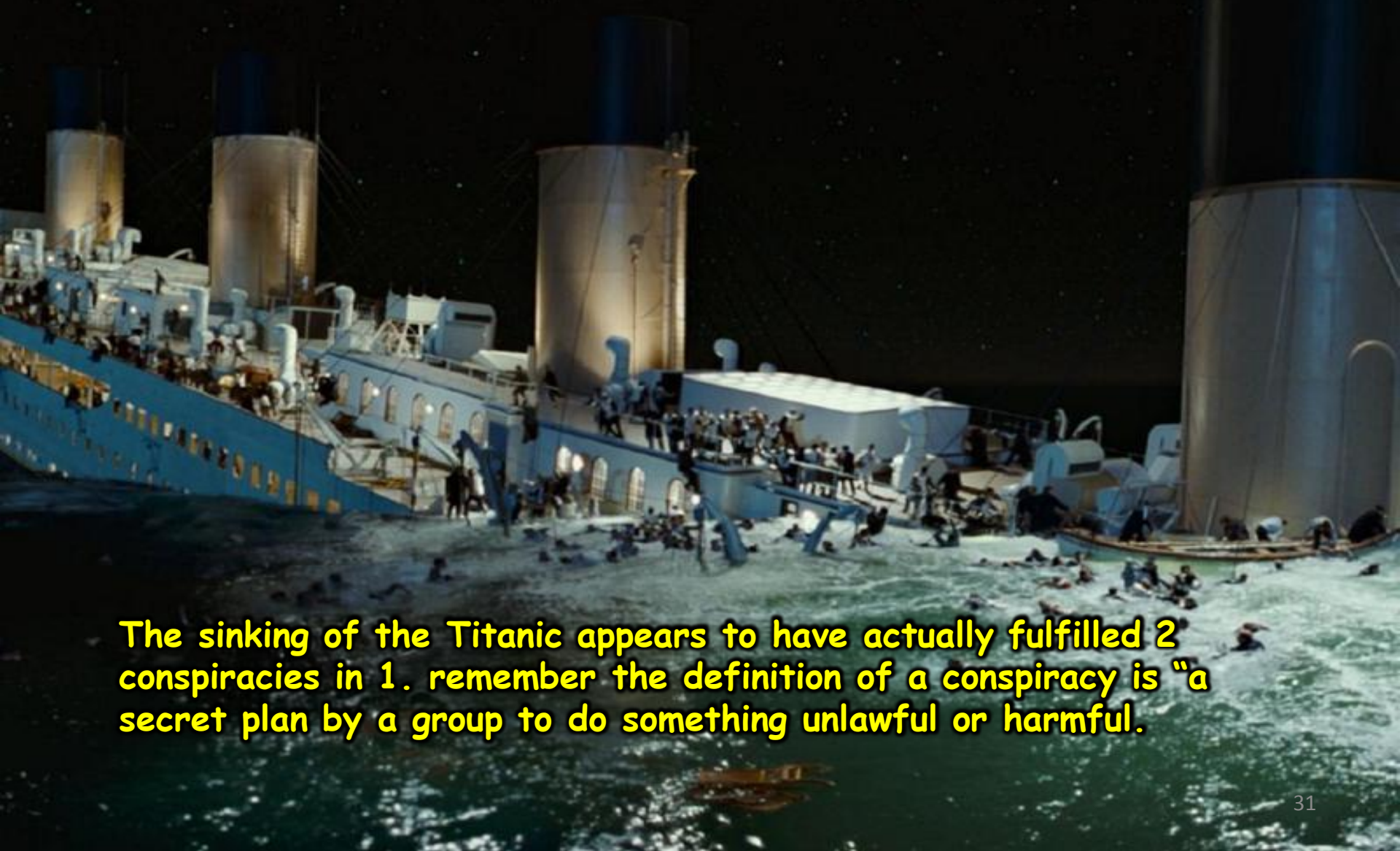
War is a racket. It is the only one international in scope. It is the only one in which the profits are reckoned in dollars and the losses in lives.

In 1934, Butler went before the House Un-American Activities Committee (HUAC) to expose a conspiracy against the government. He had been recruited by a group of wealthy Pro-Fascists who had hoped to use him in a coup against President Franklin D. Roosevelt. He went along, gathering intelligence about the plot, and took it to Congress. Butler's assertions were not aggressively pursued, and the matter was largely dismissed. However, an internal report to Congress from HUAC confirmed the veracity of the plot.

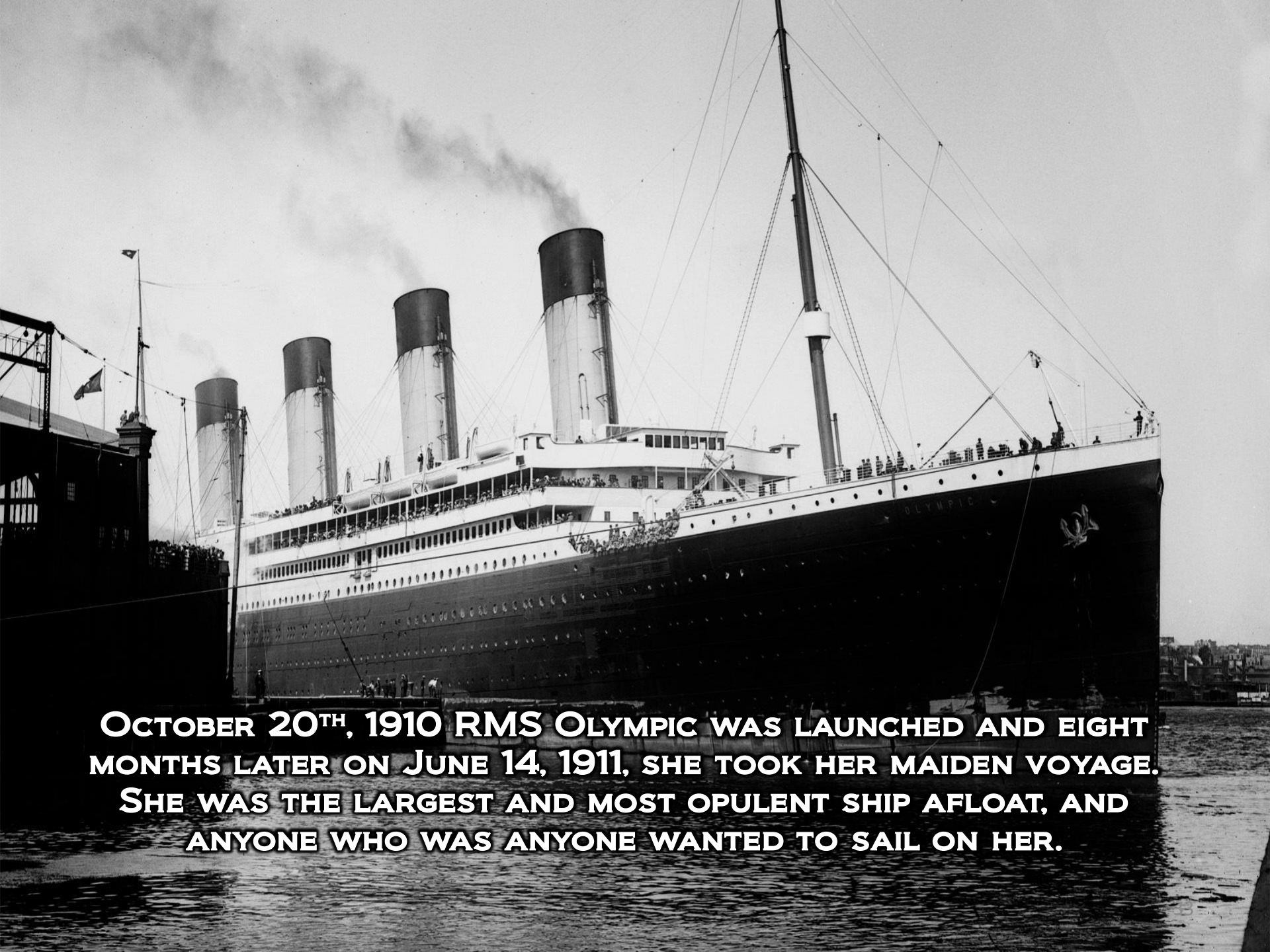

THREE MONTHS LATER THE OLYMPIC MET YET ANOTHER COLLISION, THIS TIME WITH THE BRITISH ROYAL NAVY EDGAR CLASS CRUISER HMS HAWKE, OFF THE ISLE OF WHITE.



Olympic's first major mishap occurred on her fifth voyage on 20 September 1911, when she collided with the British cruiser [HMS Hawke](#) off the [Isle of Wight](#). The collision took place as *Olympic* and *Hawke* were running parallel to each other through the [Solent](#). As *Olympic* turned to starboard, the wide radius of her turn took the commander of the *Hawke* by surprise, and he was unable to take sufficient avoiding action.^[29] *Hawke's* bow, which had been designed to sink ships by [ramming](#) them, collided with *Olympic's* starboard side near the stern, tearing two large holes in *Olympic's* hull, above and below the waterline, resulting in the flooding of two of her watertight [compartments](#) and a twisted propeller shaft. HMS *Hawke* suffered severe damage to her bow and nearly capsized. Despite this, *Olympic* was able to return to [Southampton](#) under her own power, and no one was seriously injured or killed.^{[14][30]} *Hawke* was repaired, but sunk by the German U-boat [SM U-9](#) in October 1914.

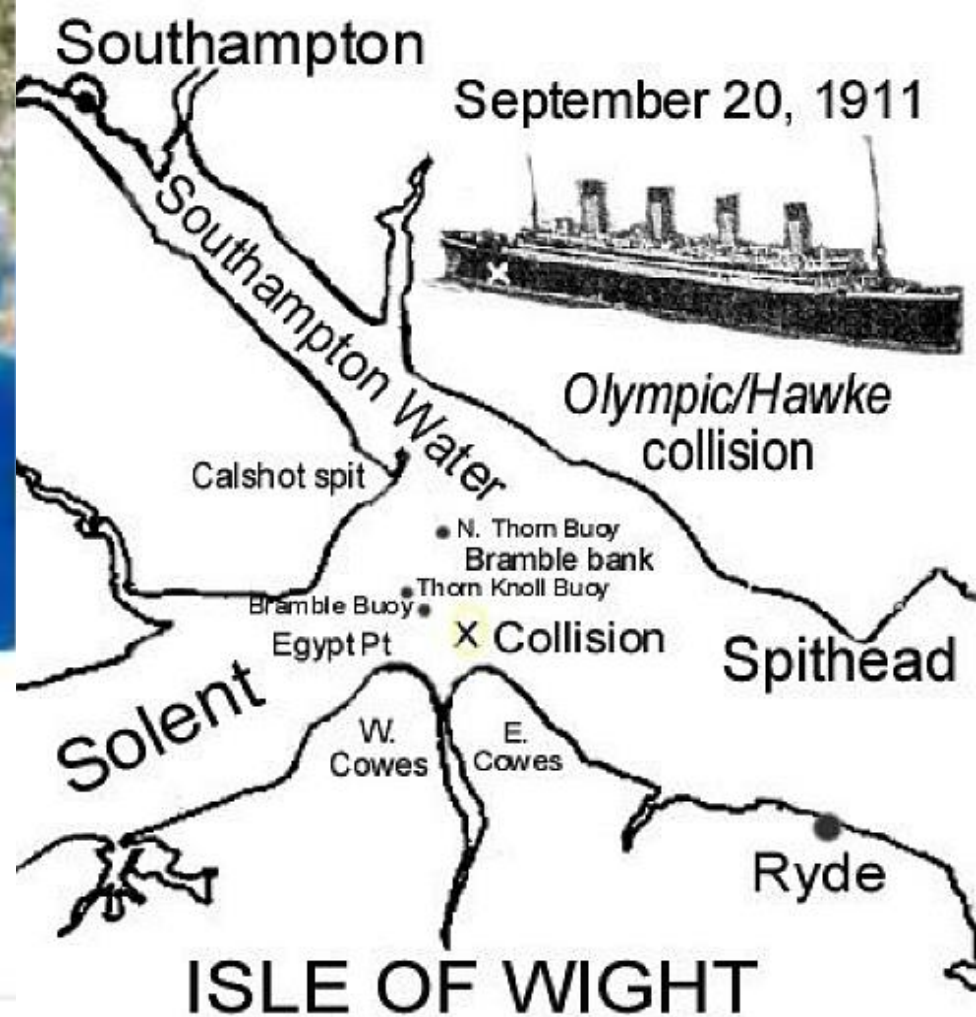

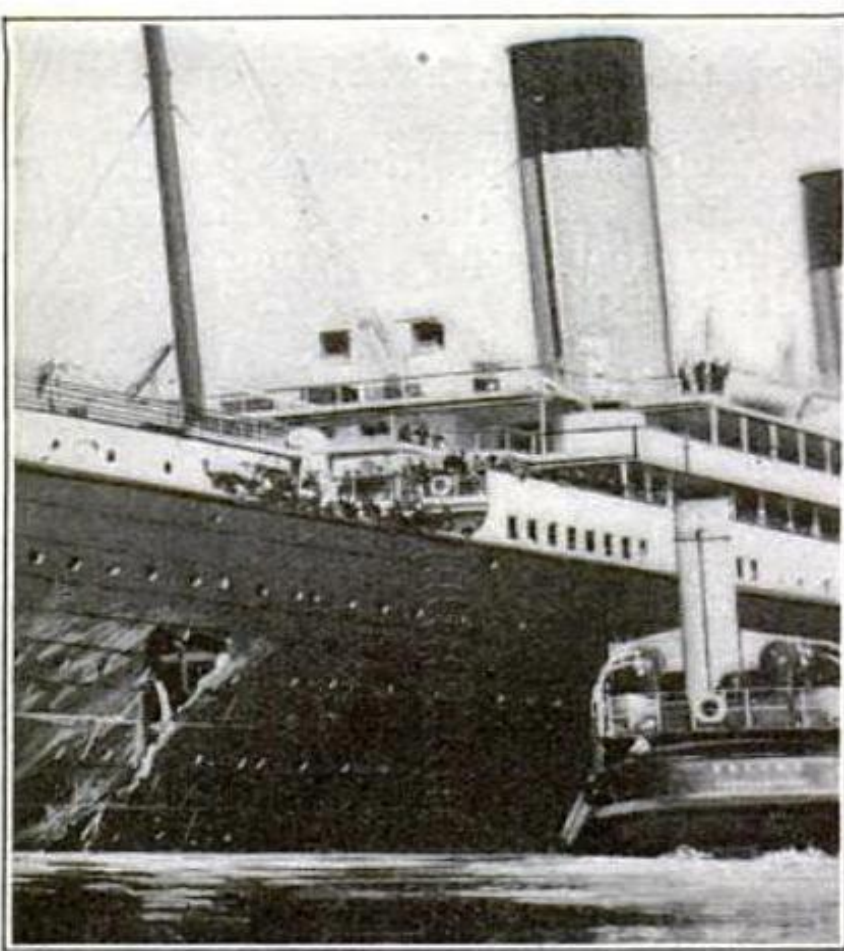

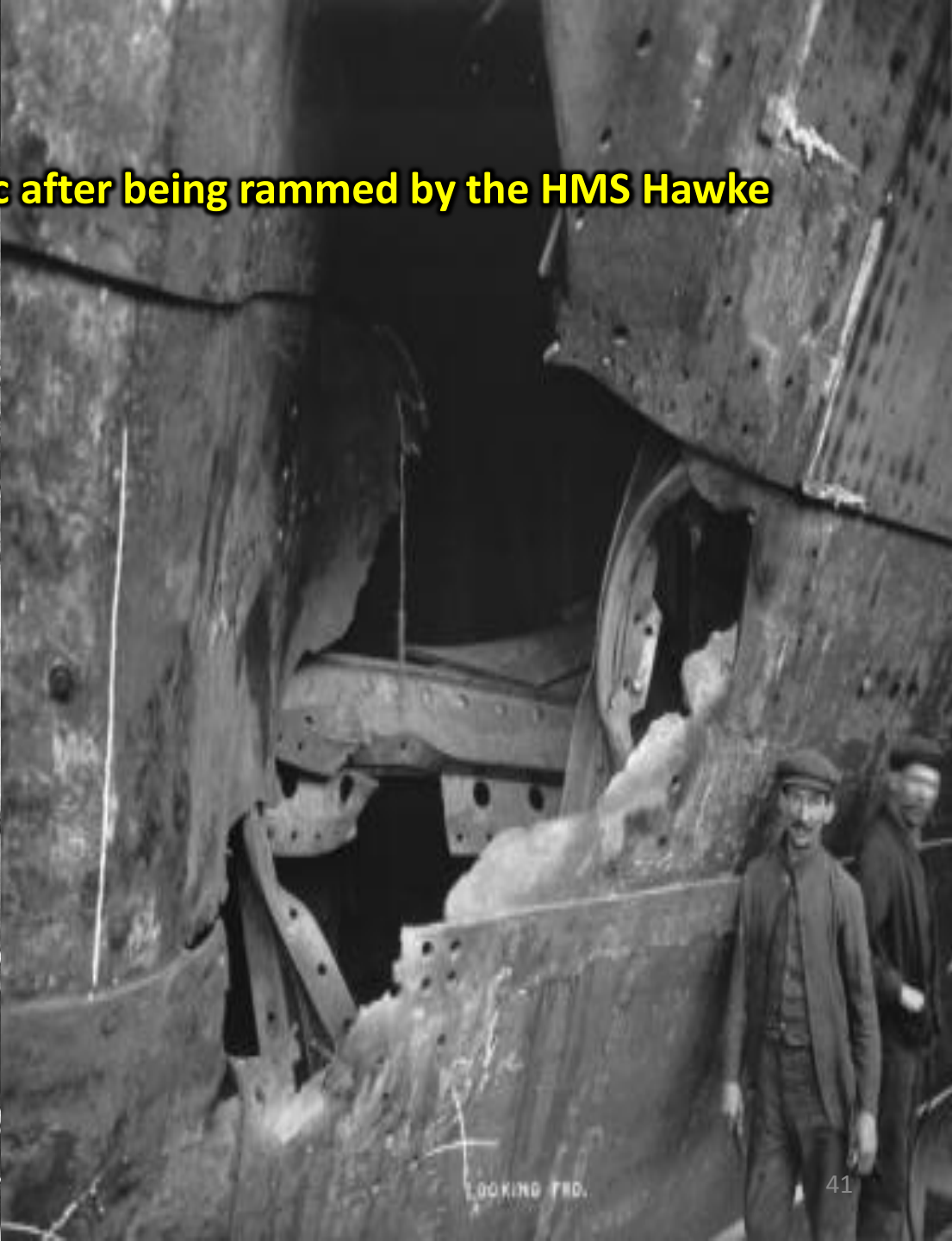
The Hole in the "Olympic," the Damage Below the Waterline being Much Greater Than That Above

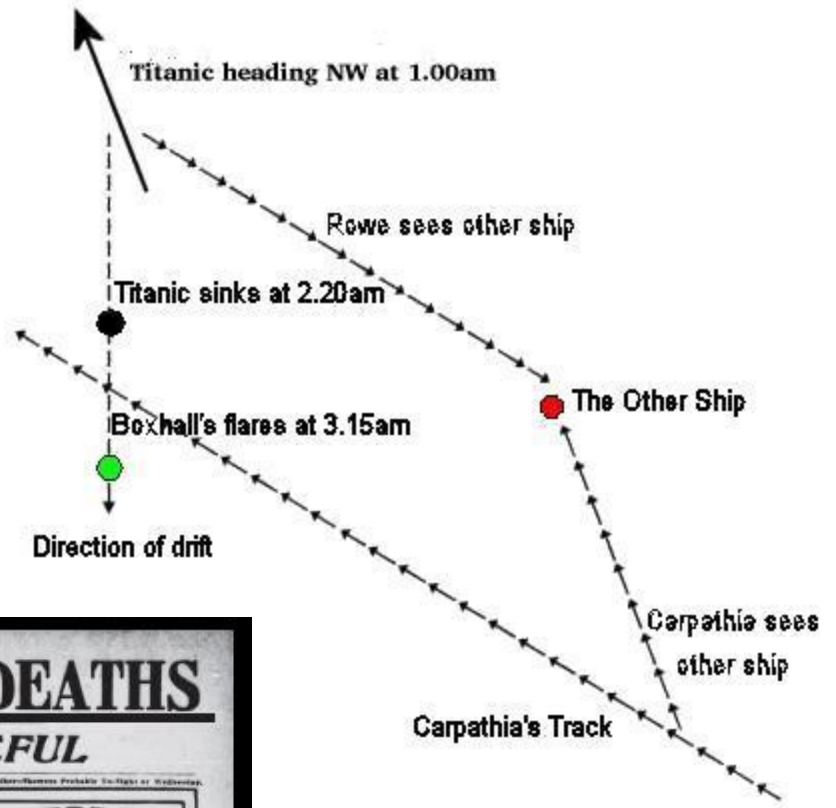

Incision Made Similar to That by Can Opener in Box of Sardines
20 SPEND NIGHT ON RAFT
Ported to Keep Others Off Because of Danger of Swamping

New York, April 18.—Cecil Arthur Wood, U. S. A., who jumped from the upper deck of the Titanic to the sea and swam about until he found a cork life raft and there found several others who had jumped into the water, told today of his experiences. "The Titanic was struck by the berg on her port side," Cecil Arthur Wood said. "She was ripped from nose to stern by the iceberg, after the fashion of a can opener opening a box of sardines. The hull was pressed inward and the compartment closed as if no position under the circumstances. "The interval between the collision and the sinking of the ship was ten hours and 55 minutes, timed by my watch, which lay open on the breast of the water, stopped at 1:15 a. m. when I jumped into the water. I was awakened in my cabin at midnight. "I feared being killed to death. "After sinking into the ship, I attempted to get up as it was pressed down upon me. "The night was dark."

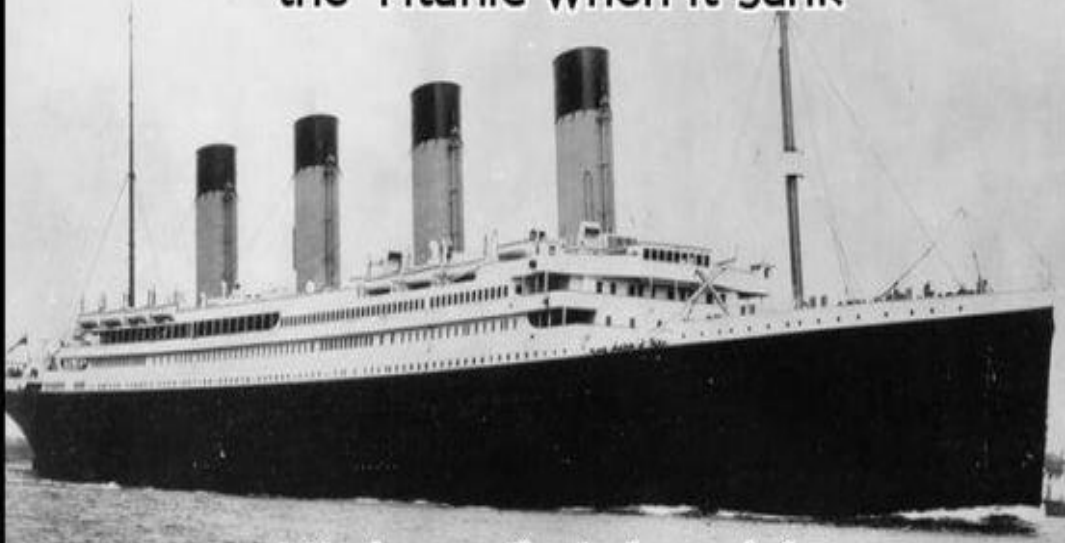

WASHINGTON, April 26.—A sworn statement that the captain of the liner Californian refused to go to the aid of the Titanic, although only a few miles away, today was filed by Ernest Gill, wireless operator on the Californian, with the senate committee.

Gill said the distress rockets were visible from the deck of the Californian, and must have been visible to both the bridge and the lookouts.

He tried to organize a committee of the crew to go to the captain and protest against his course, but said the men "were afraid they'd lose their jobs."

Benjamin Guggenheim, born in Philadelphia, Pennsylvania, was an heir in the wealthy Guggenheim family. He took up the family mining business, gaining the nickname "Silver Prince". Following a trip to Europe, he decided to sail on the maiden voyage of the Titanic after missing a trip on the Lusitania. Guggenheim died in April 1912 after the ship hit an iceberg and sank.

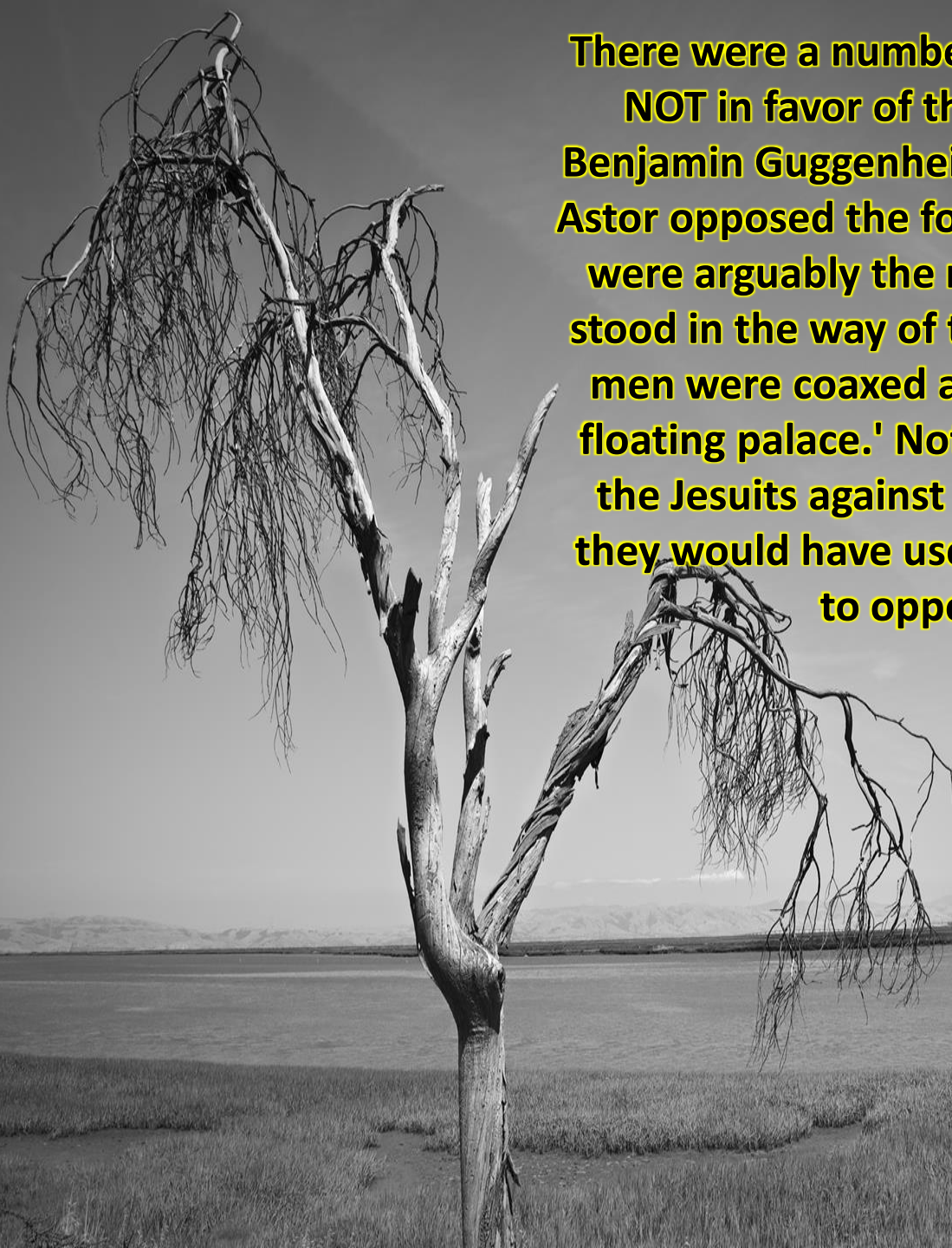
John Jacob Astor IV was born on July 13, 1864, in Rhinebeck, New York. He became active in real estate development, building the Astoria section of the Waldorf-Astoria Hotel in 1897. He built several other notable New York City hotels, including the St. Regis, which some have said was his greatest achievement. Astor drowned in the sinking of the *RMS Titanic* in 1912.

Mr Isidor Straus, 67, was born in Rhenish Bavaria on 6th February, 1845. In 1862, the Straus family moved to Columbus and Lazarus Straus opened another dry-goods business. Isidor went to work for a company that engaged in blockade running for the Confederate States (it was the time of the American Civil War). After the war, Isidor moved to New York and with his brother Nathan, became involved in the firm of R.H. Macy & Co. Finally acquiring ownership of the firm in 1896. In addition to his business enterprise he served as a Congressman for New York State between 1895 and 1897.



On the night of the disaster, as the call to board the lifeboats went out, Isidor escorted Ida to Lifeboat 8 and prepared to say goodbye to her. Ida, however, refused to enter the small boat, saying, “We have lived together for many years. Where you go, I go.” Instead, she sent her newly employed maid, Ellen Bird, in her place, after first wrapping her in a fur as protection against the cold.

There were a number of powerful men who were NOT in favor of the Federal Reserve System. Benjamin Guggenheim, Isa Strauss and John Jacob Astor opposed the formation of a F.R.S. These men were arguably the richest men in the world and stood in the way of the Jesuits' plan. 'These three men were coaxed and encouraged to board the floating palace.' Fourteen years later, with uncanny similarities, the real ship Titanic re-created what happened in the novel: The two ships had almost identical names; both ships were designated unsinkable; both were touted as the largest ships at sea; both collided with icebergs in April; both resulted in many deaths due to a shortage of lifeboats. Plus, both had strikingly similar floor plans and technical descriptions. Benjamin Guggenheim, Isador Strauss, the head of Macy's Department Stores, and John Jacob Astor, probably the wealthiest man in the world were all killed when it sank. Those three men were the main opposition to the creation of the U.S. Fed. By April, 1912, all opposition to the Federal Reserve was eliminated. In December of 1913, the Federal Reserve came into being in the United States controlled by the Illuminati Banksters.

In 1912 Henry P. Davison, who was a Morgan partner, put it bluntly when he told a congressional committee: “I would rather have regulation and control than free competition.” John D. Rockefeller was even more to the point: “Competition is a sin.”



Before the Fed came in existence there was no income tax, tariffs and duties on import, and excise taxes on purchases like alcohol cigarettes, and gas paid for the entire government. 
