As right as Gates is not to trust the FDA with this matter – or any matter, really – hearing this skepticism coming from him is a case of the pot calling the kettle black. The FDA might actually be slightly more trustworthy than Bill Gates on vaccines, but it's a very low bar indeed.

Now this is what came into email – looking at this, you'd think that Trump is the one that convinced Gates to become a skeptic – BUT when you read the article, there is NO confirmation that happened, so WHY say this?



Gates said the FDA has lost credibility in his mind in recent years. In particular, he cited recent comments made by FDA Commissioner Stephen Hahn, who has been accused of exaggerating a Mayo Clinic study's findings on the benefits of convalescent blood plasma as a coronavirus treatment.



“We saw with the completely bungled plasma statements that when you start pressuring people to say optimistic things, they go completely off the rails. The FDA lost a lot of credibility there,” Gates said.



Of course, Gates failed to mention an even bigger problem with Hahn, which is his insistence that hydroxychloroquine is causing harm to patients despite scientific and anecdotal evidence to the contrary from doctors who have successfully used this treatment. That's probably pretty convenient for his mass vaccination agenda, so we won't see him criticize anyone suppressing HCQ any time soon.





The FDA will have to approve any coronavirus vaccine before it can go to market. Gates told CNBC that of all the pharmaceutical companies working on a vaccine, only Pfizer has the potential to deliver one in a matter of weeks. Not surprisingly, the [Gates Foundation owns shares of Pfizer.](#)



***Can this be over, please?***

People are also losing faith in the CDC. In March, 86 percent of voters said they trusted the CDC to provide accurate information about coronavirus; that figure now stands at just 54 percent. There have also been drops in those who trust their state's governor, President Trump and the media for accurate information about the disease compared to this spring.



Meanwhile, when asked [in a Gallup poll](#) if they would be willing to get a COVID-19 vaccine that had been approved by the FDA and was given to them at no cost, 35 percent of Americans said they would not.

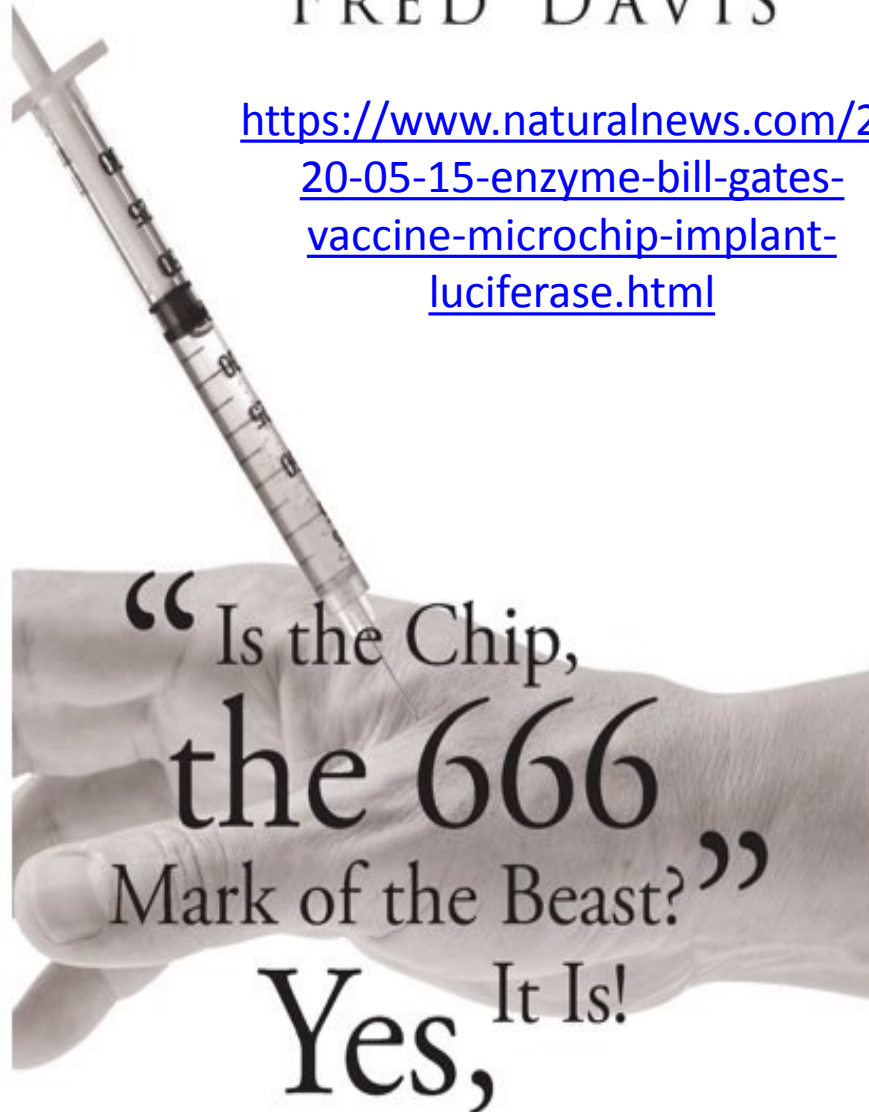



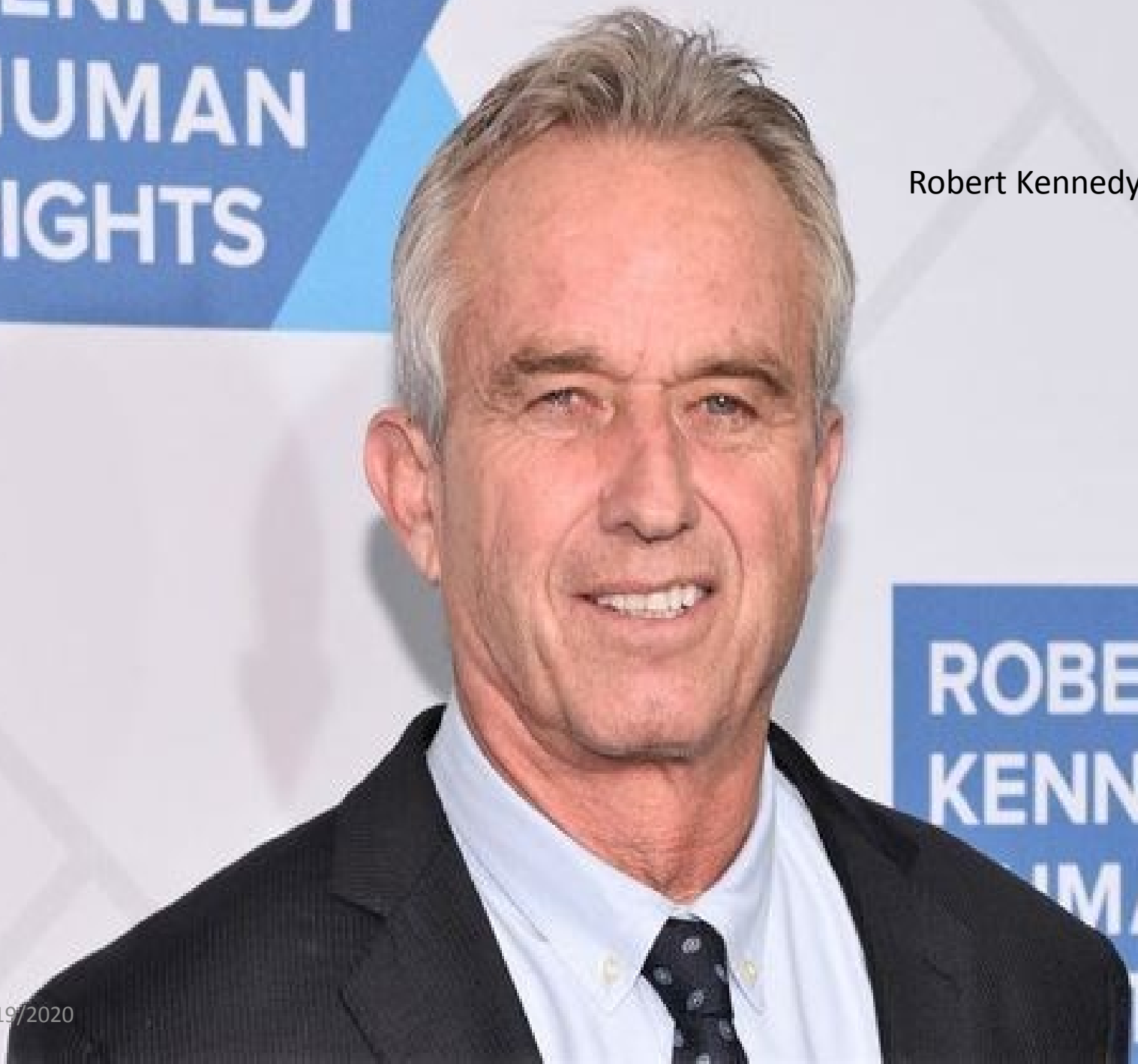

The “Appeal,” primarily authored by Archbishop Carlo Maria Viganò, former papal nuncio to the U.S., was signed by more than 80 people, including prelates, theologians, journalists, doctors, lawyers, and associations. The American signatories include Dr. Robert Moynihan, editor-in-chief of this publication, as well as Robert F. Kennedy, Jr.

The three-page open letter contains a call to action for all Catholics, religious, and all people of goodwill, in view of radical measures being forced upon much of the world's population:

“The facts have shown that, under the pretext of the COVID-19 epidemic, the inalienable rights of citizens have, in many cases, been violated and their fundamental freedoms, including the exercise of freedom of worship, expression, and movement, have been disproportionately and unjustifiably restricted.

Public health must not, and cannot, become an alibi for infringing on the rights of millions of people around the world, let alone for depriving the civil authority of its duty to act wisely for the common good.”



Regarding vaccines, the “Appeal” goes on to say, “We ask the scientific community to be vigilant so that cures for COVID-19 are offered in honesty for the common good.

Every effort must be made to ensure that shady business interests do not influence the choices made by government leaders and international bodies. It is unreasonable to penalize those remedies that have proved to be effective, and are often inexpensive, just because one wishes to give priority to treatments or vaccines that are not as good, but which guarantee pharmaceutical companies far greater profits, and exacerbate public health expenditures.


Let us also remember, as Pastors, that for Catholics it is morally unacceptable to develop or use vaccines derived from material from aborted fetuses.”



**In 2017, the life ethics arm of the Catholic Church issued a statement that: Catholic parents could vaccinate their children with a "clear conscience" that "the use of such vaccines does not signify some sort of cooperation in voluntary abortion".**

**Earlier this year and in the context of the coronavirus vaccine race, John Di Camillo, an ethicist with the National Catholic Bioethics Center, confirmed: "One is allowed to make use of [vaccine derived from foetal tissue] where there's a serious threat to the health or life of the individual, or of the greater population.**

**"This does not amount to a strict obligation to use it, but it certainly can be a legitimate choice in conscience if there's that serious reason, and there's no other reasonable alternative."**



ROBERT F. KENNEDY, JR.: That raises a number of ethical issues. Also, it raises a question: what do we know about vaccine safety and efficacy?

That is a threshold question because vaccines are not safety tested, and people find that hard to believe, but unfortunately, it's true. And that is an artifact of CDC's (CDC stands for "Centers for Disease Control and Prevention") legacy of the public health service, which was originally a quasi-military agency. That is why CDC officials have military ranks such as "Surgeon General."

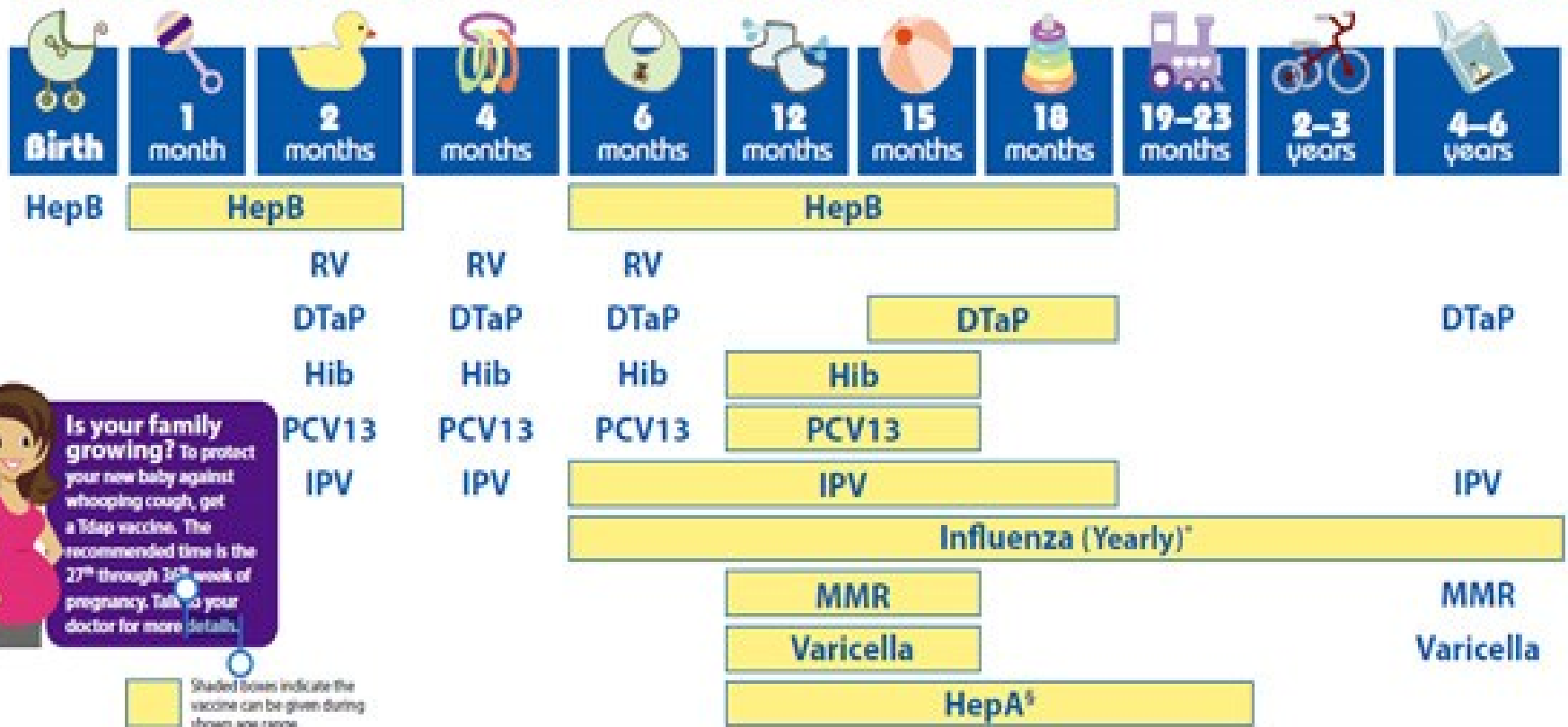

The vaccine program was conceived as a national security defense against biological attacks on our country by the Russians or other Cold War enemies.



The military objective was to be able to fabricate and deploy a vaccine very quickly to 200 million Americans without regulatory impediments. The regulators and generals understood that testing medicines for safety takes years, so they opted to call vaccines by a different name — “Biologics” — and exempt biologics from safety testing.

As a result of that decision, none of the 72 vaccines now mandated for American children have ever been safety tested against a double-blind placebo.

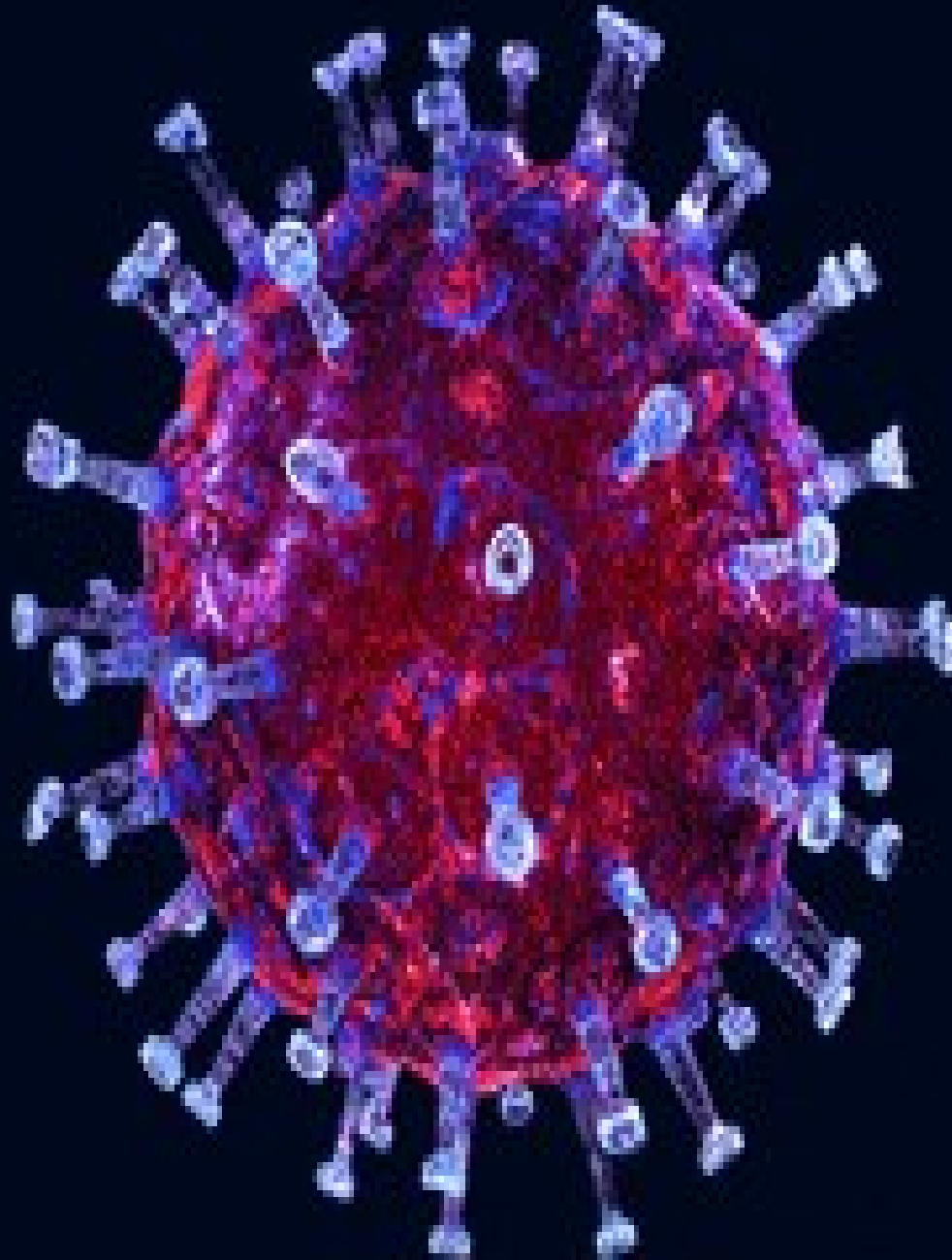
Which means nobody knows the risk profile, and nobody can say with any certitude that the vaccine is averting more problems than it's causing. That is why I say it's a "threshold" issue because the ethical questions become much more clouded if we don't even know if the vaccine is actually serving the greater good.

**According to the World Health Organization, there are 70 vaccines in development — three of which are in clinical trials.**

**What do you think about the push for the rapid development of a COVID-19 vaccine? Is it okay to skip animal trials and go straight to human trials? Can those human volunteers truly have informed consent?**



**KENNEDY: No.**  
What we know about coronavirus from 30 years of experience is that a coronavirus vaccine has a unique peculiarity, which is any attempted making of the vaccine has resulted in the creation of a class of antibodies that actually make vaccinated people sicker when they ultimately suffer exposure to the wild virus.





Following the SARS epidemic that began in 2002, China launched a concerted effort to develop a coronavirus vaccine. They succeeded in developing 30 promising models, and they chose the four “best in class” to fabricate and then test on ferrets, the animal most analogous to human beings when it comes to upper respiratory infections.



The ferrets all developed admirable, robust, and durable antibody responses, and the scientists believed they had hit the jackpot. But then, when the animals suffered exposure to the wild virus, something frightening happened. The vaccinated animals sickened and died with body-wide inflammation. The vaccine had created a condition known as paradoxical inherent immune response, which amplified the injury caused by the illness rather than preventing it.

The scientists at that time recalled a similar occurrence from the 1960s where the NIH had conducted studies on a vaccine for RSV, an upper respiratory illness very similar to coronavirus.

The 35 children in that study had developed a strong antibody response but had become terribly ill upon exposure to wild RSV. Two of the children died. Remembering this incident, the scientists in 2012 abandoned their efforts to create that vaccine.

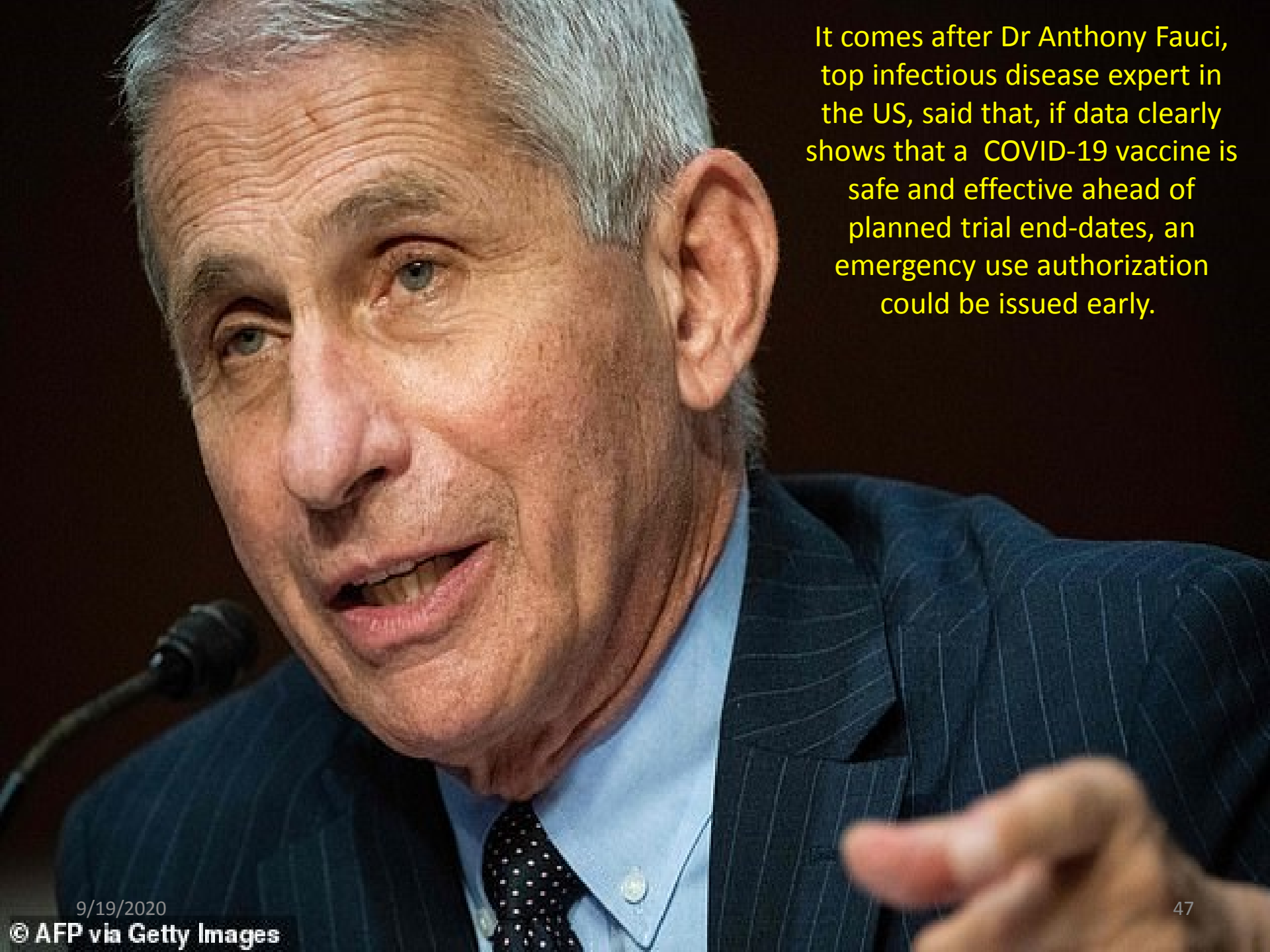


**Currently, the vaccines being developed by Moderna and Pfizer are the furthest along in their clinical trials, with AstraZeneca's close behind.**

Documents suggest that, if 'Vaccine A' is given emergency use authorization by October, two million doses will be shipped then, with as many as 50 million additional doses going out by year-end.



For 'Vaccine B,' up to one million doses could be shipped by the end of October, and up to 35 million by year-end, according to the documents issued last Wednesday.



It comes after Dr Anthony Fauci, top infectious disease expert in the US, said that, if data clearly shows that a COVID-19 vaccine is safe and effective ahead of planned trial end-dates, an emergency use authorization could be issued early.

The Trump Administration launched Operation Warp Speed in an effort to expedite vaccine development via billions of dollars of investment in partner companies.

Operation Warp Speed has homed in on five lead candidates, of which three - those being made by AstraZeneca (with Oxford University), Moderna and Pfizer (with BioNTech) - are in their final-stage trials.



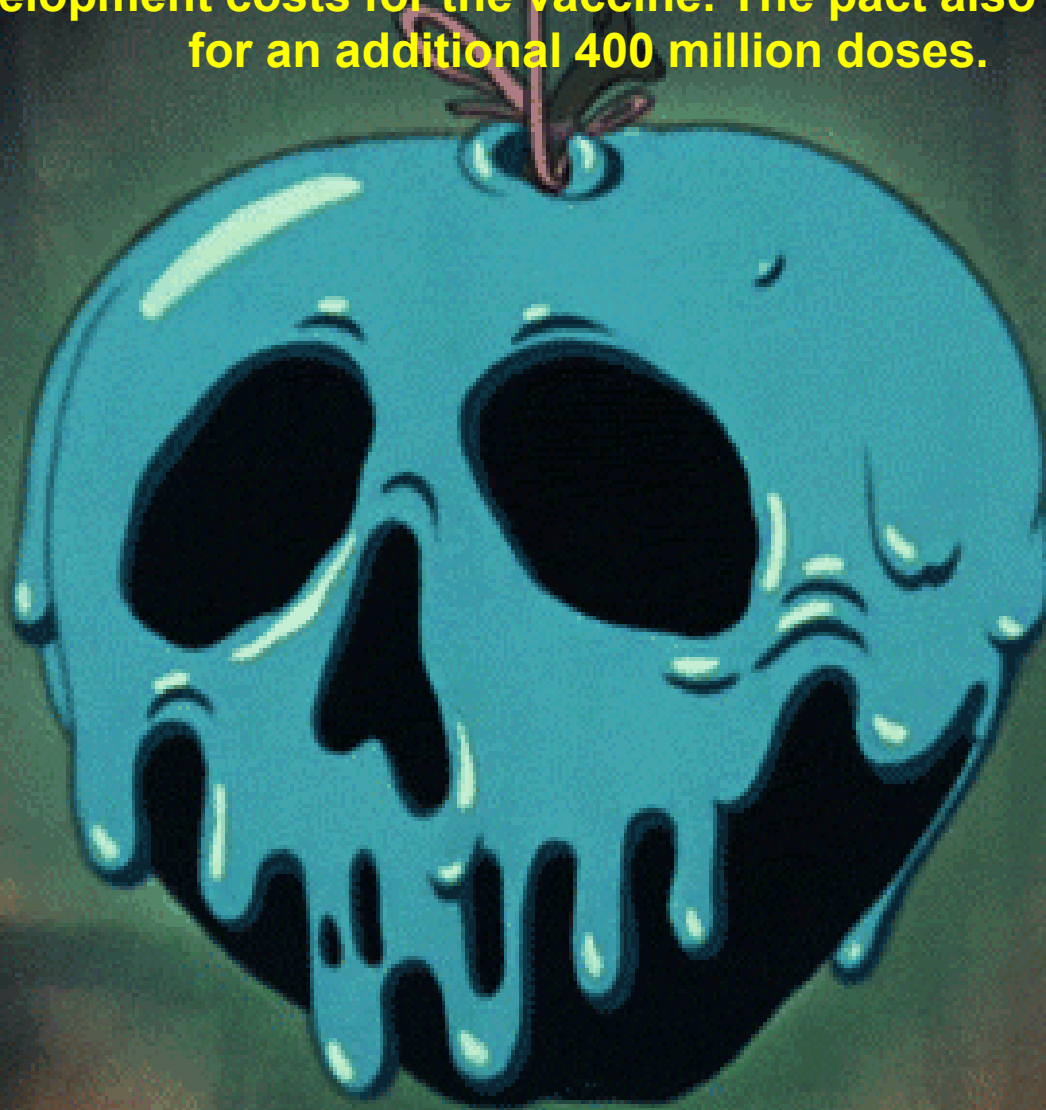
## McKesson signs up with Warp Speed to distribute COVID-19 shots in U.S.

Under a 2016 childhood vaccine deal, the CDC had an option to draft McKesson to distribute vaccines in case of a pandemic, according to a Department of Defense release. While financial terms of the option weren't disclosed, Bloomberg reported the overall deal could be worth up to \$300 million.

**Last week, the government reached a \$1.5 billion work order with Moderna for 100 million doses of its mRNA-based COVID-19 shot—after spending almost \$1 billion in development costs for the vaccine. The pact also includes an option for an additional 400 million doses.**



The Moderna order follows a suite of Warp Speed deals in recent weeks:



Sanofi and GlaxoSmithKline **scored** \$2.1 billion to develop and deliver 100 million doses

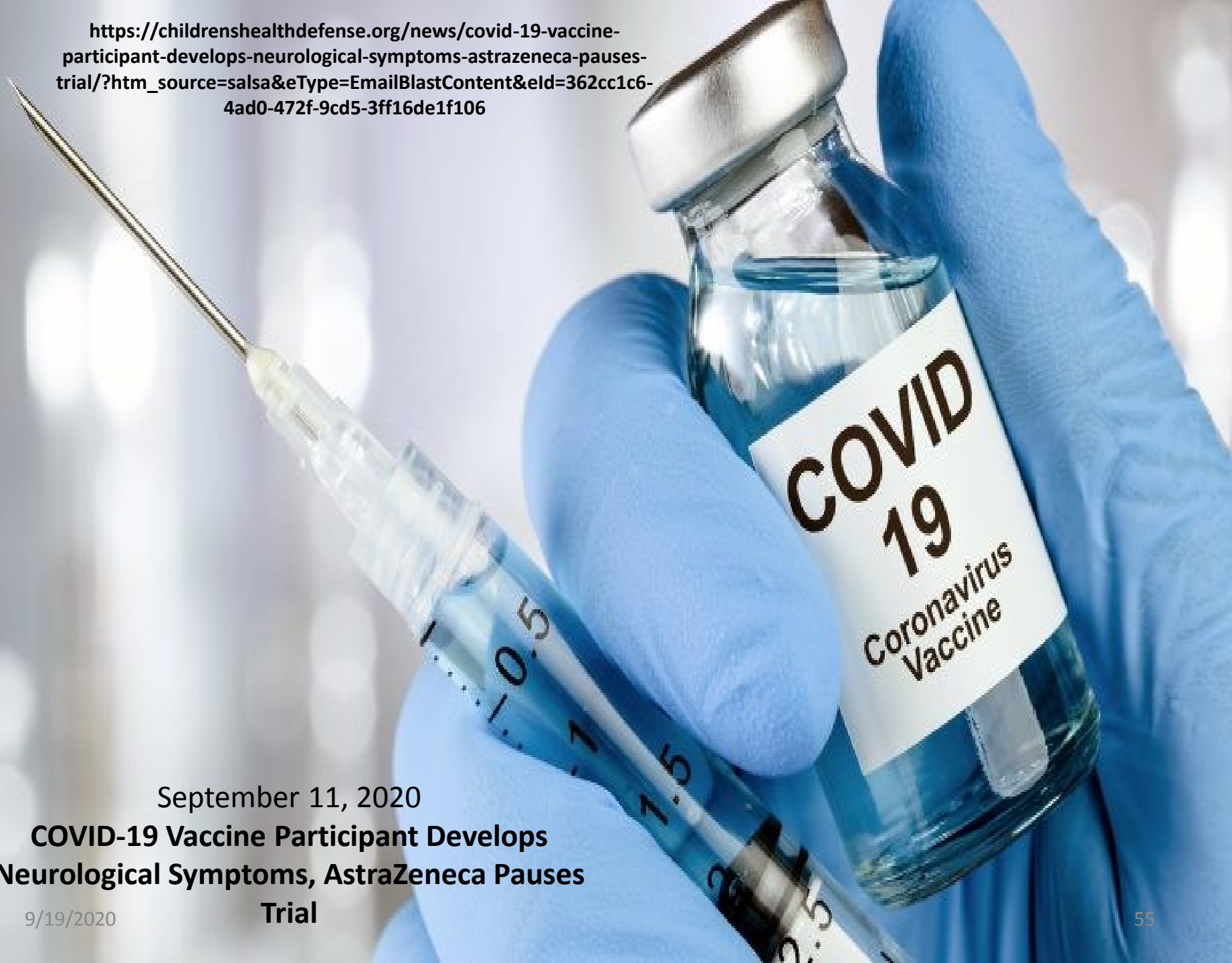
Pfizer and BioNTech's would **rake** in \$1.95 billion for its shot;

Novavax **snared** \$1.6 billion from the initiative.

Johnson & Johnson also **locked** in a deal for \$1 billion for 100 million doses of its shot

AstraZeneca is on the hook for 300 million doses in a \$1.2 billion deal.

On Tuesday, AstraZeneca [announced](#) a pause on its experimental COVID-19 vaccine trial after a woman in the UK developed a [“suspected serious reaction.”](#) The company is also conducting trials in the U.S., South Africa and Brazil, with enrollment in all these countries on hold for now. AstraZeneca is partnering with researchers at Oxford University to develop this vaccine, and is testing it on children as young as [5 years old](#). The World Health Organization’s Chief Scientist Soumya Swaminathan called the project a COVID-19 vaccine race [“frontrunner”](#) earlier this year.





While AstraZeneca says the woman has [not been officially diagnosed](#), an anonymous source [told](#) the New York Times that the woman's symptoms were consistent with transverse myelitis (TM). TM is a neurological disorder characterized by inflammation of the spinal cord, a major element of the central nervous system. It often [results](#) in weakness of the limbs, problems emptying the bladder and paralysis. Patients can become severely disabled and there is currently [no effective cure](#).

Concerns over associations between TM and vaccines are well known. A review of published case studies in 2009 [documented 37 cases of transverse myelitis](#) associated with vaccines, including Hepatitis B, measles-mumps-rubella, diphtheria, pertussis, tetanus and others in infants, children and adults.

**The researchers in Israel noted  
“the associations of different  
vaccines with a single autoimmune  
phenomenon allude to the idea  
that a common denominator of  
these vaccines, such as an  
adjuvant, might trigger this  
syndrome.”**

**Even the New York Times piece on the recent AstraZeneca trial pause notes past “speculation” that vaccines might be able to trigger TM.**





Perhaps the most infamous example of this phenomenon is the [case of Colton Berrett](#). Berrett received Merck's HPV vaccine at age 13 after doctors advised his mother it would help prevent cervical cancer in his hypothetical wife down the line.



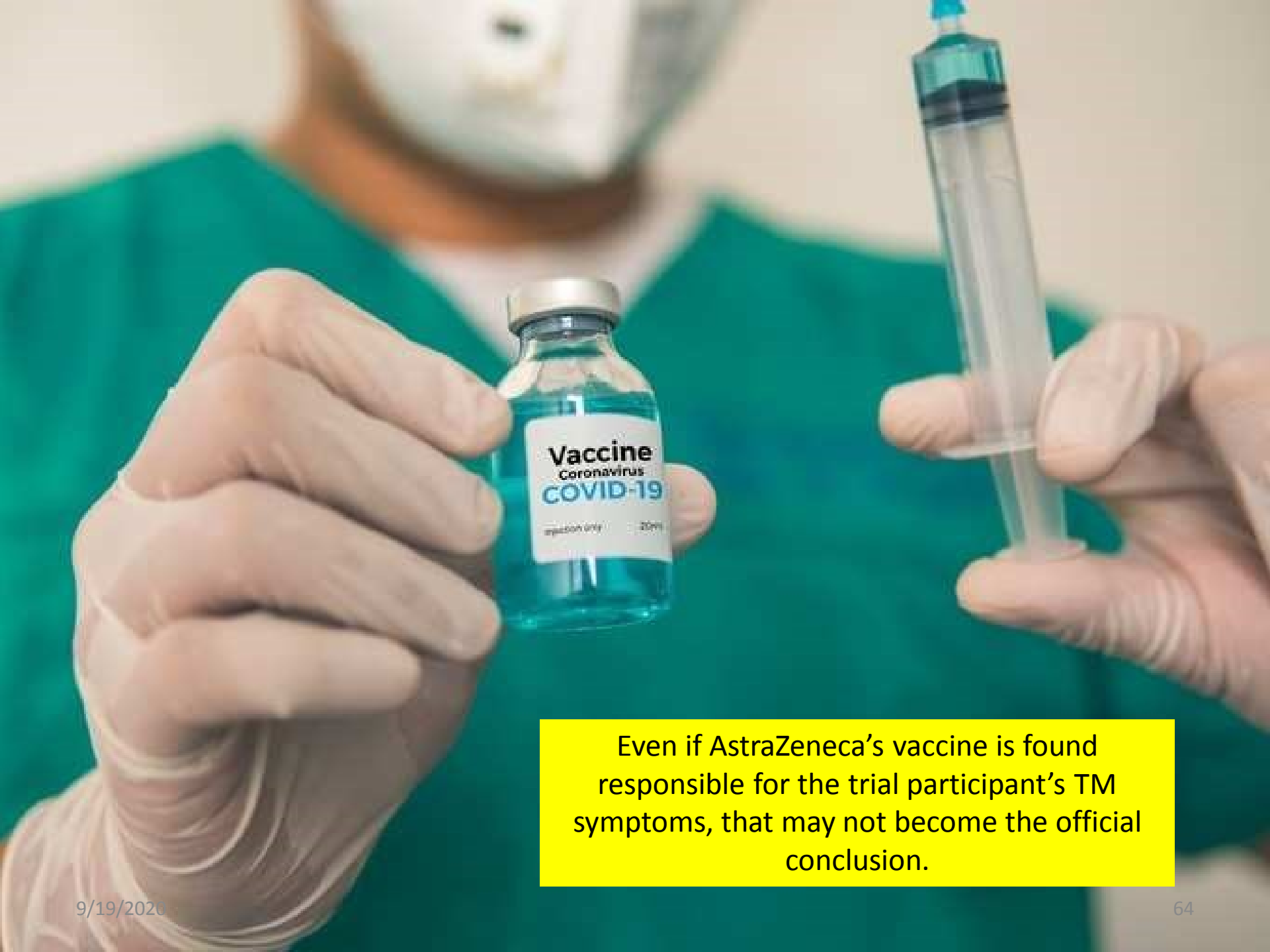
After the vaccine, doctors diagnosed Berrett with TM, and the boy became increasingly paralyzed as his spine became increasingly inflamed. Doctors said he'd eventually lose the ability to breathe and the family chose to intubate him.

After years of living with this disability, and needing someone to carry a breathing apparatus for him at all times, Berrett took his own life.

Even if AstraZeneca's vaccine is found responsible for the trial participant's TM symptoms, that may not become the official conclusion.



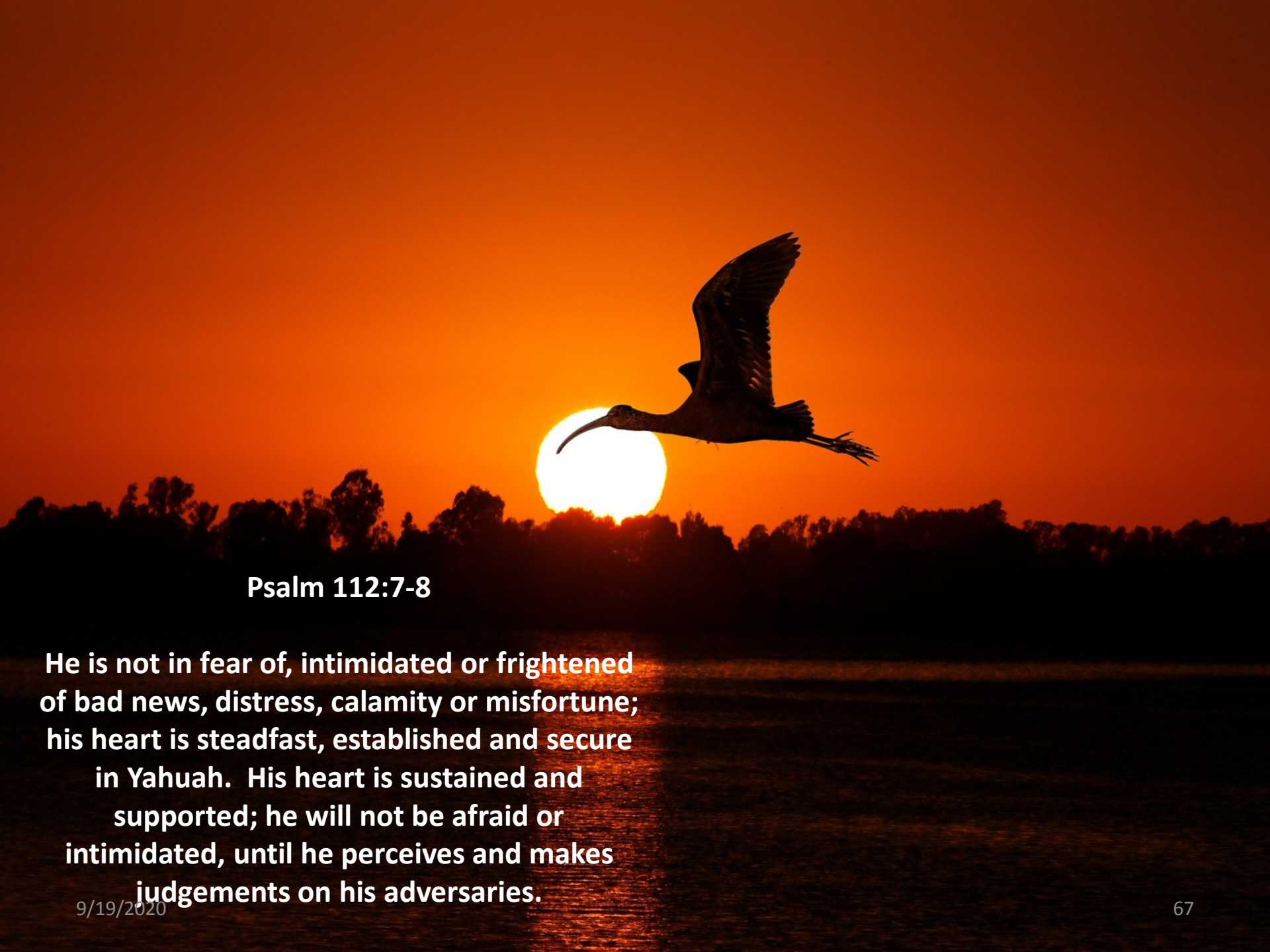


Transverse Myelitis After Vaccination




In July, another participant developed symptoms of TM, and the vaccine trial was paused. But an “independent panel” concluded the illness was unrelated to the vaccine, and the trial continued.
