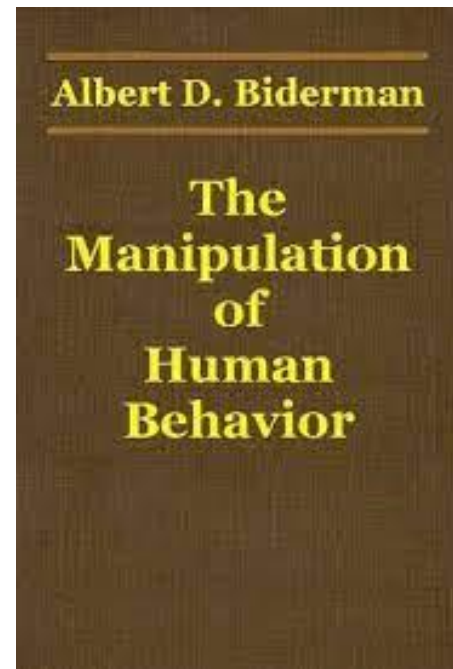


We have been framing our discussion around the Kubark Interrogation method and how it relates to us today.

Document a Day: Old Torture Made New

The torture techniques CIA and Defense Department interrogators used have a specific pedigree: they were developed and promoted by two psychologists who had worked for the military's Survival, Evasion, Resistance, Escape (SERE) programs, where U.S. soldiers are subjected to torture techniques perfected by such countries as China, North Korea, and the Soviet Union.



In this **January 15, 2003 memo**, two SERE trainers report on their **trip to instruct Guantánamo interrogators on “the theory and application of the physical pressures utilized during our training evolutions.”** Their instruction began, they report, with **“an in-depth class on Biderman's Principles,”** and the memo reproduces this **chart of “Coercive Management Techniques”** entitled **“Biderman's Chart of Coercion.”**

Biderman is Albert D. Biderman, whose **September 1957 paper “Communist Attempts to Elicit False Confessions From Air Force Prisoners of War”** contains the original chart in a more legible form. Biderman showed how Chinese and Korean interrogators used techniques including sleep deprivation, darkness or bright light, insults, threats, and exposure far more than physical force to break prisoners.

What communist country would have the most to gain and in the best position to create an environment as we see above?

Ask yourself-Do any of these internet controls play an intricate role in what we are going through now? Be aware, close attention to the to the east. Remember, been perfecting their own people.

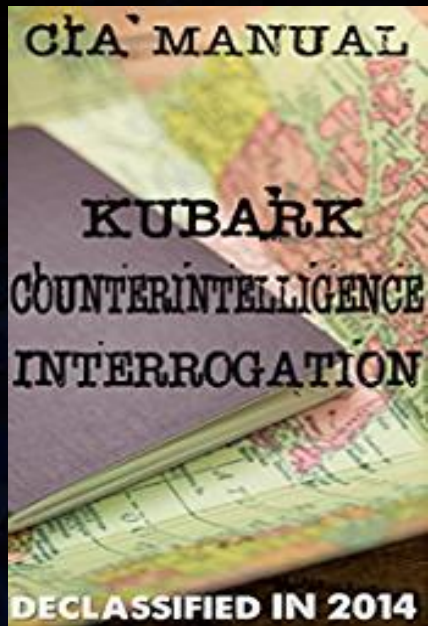

Adding to the Coercion tactics we have outlined, Kuback also included **detention**. We can see where that has been very beneficial to the Evil one's plan and the demoralization of the human spirit- If you allow it.

D. Detention

If, through the cooperation of a liaison service or by unilateral means, arrangements have been made for the confinement of a resistant source, the circumstances of detention are arranged to enhance within the subject his feelings of being cut off from the known and the reassuring, and of being plunged into the strange. Usually his own clothes are immediately taken away, because familiar clothing reinforces identity and thus the capacity for resistance. (Prisons give close hair cuts and issue prison garb for the same reason.) If the interrogatee is especially proud or neat, it may be useful to give him an outfit that is one or two sizes too large and to fail to provide a belt, so that he must hold his pants up.

This lines up perfectly with what they have done to the elderly during the terrorization of humanity. Cut off from family, put in a strange atmosphere with people in strange garb and put on respirators that would be a partial cause of death.

Is Extended Isolation Killing Older Adults in Long-Term Care?

Five months of COVID-19 lockdowns have created a mental health crisis

This has been elder abuse pure, simple and undeniable.

"Look, I'm sure she would have declined somewhat, but I know in my heart the **isolation** accelerated it," Evans says. "She would have made it to well over 100 but that's not going to happen now. ... **She's collateral damage of this COVID-19 seclusion**, passing away because of a broken heart."

In February, Lorri Evans' mom was walking the equivalent of four blocks, twice a day, around her memory care facility in Santa Cruz, California. "She used a walker for support," Evans says, "but her legs worked fairly well for someone who is 99."

"Just a year ago, she was dancing at my daughter's wedding," Evans says of her mom, Helen. "But now, she's fallen into an abyss."

When the coronavirus pandemic hit the U.S., sending long-term care facilities into lockdown, Helen was confined to the second floor of her complex — where her room was located — for months. Her outdoor walks ceased, and so did her mobility. She became bedbound. Her mind, already battling dementia, deteriorated, too.

Data on the mental health effects of the long lockdown at America's nursing homes and other long-term care facilities **is scant**. But experts, resident advocates, and those with loved ones on the inside say that lockdown is fueling a mental health crisis that's amplifying the devastating impacts of the pandemic on the long-term care industry, where **more than 70,000 long-term residents and staff have already died from COVID, accounting for 4 in 10 pandemic deaths. They say that feelings of loneliness, abandonment, despair and fear among residents — and their toll on physical and neurological health — are only pushing the pandemic's death toll higher.**

'I feel like I'm in prison'



Even before the pandemic, social isolation were considered serious health risks for older Americans. A body of evidence shows that these factors (social isolation) significantly increase a person's risk of mortality from all causes, potentially rivaling the risks of smoking, obesity and high blood pressure. Social isolation and loneliness are also associated with higher rates of clinically significant depression, anxiety and suicidal ideation.

But there is more than mental health at stake. Isolation and loneliness are associated with a 50 percent increased risk of developing dementia, a 32 percent increased risk of stroke, and a nearly fourfold increased risk of death among heart failure patients, according to separate studies. With 43 percent of adults age 60-plus in the U.S. reporting feeling lonely, the rates of social isolation and loneliness were already at the level of “a public health crisis,” according to Perissinotto, a coauthor of the report.

We have now put our elderly in a zoo atmosphere. To be gazed at from afar. Children too young to understand miss out on the bonding with prior generations that Yahuah and Torah say is critical for society. If they are allowed out of their cages one has to see that either the children or the elderly are thought of as diseased, when neither is the case. Wrapping themselves in plastic to hug their grandkids, or children hugging through plastic curtains is absurd to avoid getting the flu.



This video is sad on two levels. It reminds us of what we have done to the elderly and how much we are truly missing out on the connection to animals in general that we look at in confinement. Either we torture and kill them in lab experiments (I don't remember reading where Yahuah condoned or thought it was necessary in Torah). If we just kept up our Yah given immune systems with His herbs and food and follow His instructions all of this could be avoided. But it's Science don't you know?! We are beyond Yahuah's wisdom running after pharmakeia - witchcraft to our eternal demise. But I digress.

Nursing homes were prodded **into lockdown in mid-March**. COVID's spread prompted the federal Centers for Medicare and Medicaid Services (CMS) to issue guidance **urging a ban on visitors and nonessential personnel from the nation's 15,400 nursing homes**. **Internal group activities, including communal dining, were canceled, too.**

Many other long-term care facilities, such as assisted living facilities and memory care units, **followed suit**. None wanted to be the next Life Care Center of Kirkland, Washington, **which lost 37 people to COVID-19** via an early outbreak of the virus that began in late February. Still, dozens of similar outbreaks followed in facilities across the country: In April, new COVID-19 cases and deaths in long-term care facilities peaked across the nation. Although cases decreased in May and June, they increased in July and August, according to an analysis by the Kaiser Family Foundation. Similarly, deaths in long-term care facilities decreased from May to July, but have increased in August, the analysis shows.

Judith Gimbel also worries that the **isolation is killing her mom**. "I don't think she's deteriorating I know she is," she says of 95-year-old Ida, who lives in an assisted living facility in Gloucester County, New Jersey. **"She's dying a slow death in there."**

Before the pandemic hit, Ida participated in every activity the facility offered, says Gimbel: "She went down for morning exercise; she ate all three meals in the cafeteria; if they had crafts, she did craft; if they had music, she did music — anything." Without daily stimulation, Gimbel thinks her dementia has progressed. **"She sometimes doesn't recognize me, and that was never the case before,"** she says. **"Her brain has turned to mush."**



For Ida, meanwhile, the outdoor visits have made her frustrated and more depressed, her daughter Judith Gimbel says, because there's no physical contact. "She's 6 feet away from the table; she can't hear me," Gimbel says. "I can't pass her my phone to show her pictures of her great-grandson. I can't share the food I bring with her. I think it's worse than no visits at all."

The lack of touch is affecting many residents, says Gibson, particularly those who are suffering from dementia, like Ida. "We know that tactile sensation is one of the senses that remains intact, even throughout more severe levels of dementia," she says, "so taking that away can be harmful."

The point is that man's sense of identity depends upon a continuity in his surroundings, habits, appearance, actions, relations with others, etc. Detention permits the interrogator to cut through these links and throw the interogatee back upon his own unaided internal resources.

Little is gained if confinement merely replaces one routine with another. Prisoners who lead monotonously unvaried lives ". . . cease to care about their utterances, dress, and cleanliness. They become dulled, apathetic, and depressed." (7) And apathy can be a very effective defense against interrogation.

Control of the source's environment permits the interrogator to determine his diet, sleep pattern, and other fundamentals.

Manipulating these into irregularities, so that the subject becomes disorientated, is very likely to create feelings of fear and helplessness. Hinkle points out, "People who enter prison with attitudes of foreboding, apprehension, and helplessness generally do less well than those who enter with assurance and a conviction that they can deal with anything that they may encounter

Some people who are afraid of losing sleep, or who do not wish to lose sleep, soon succumb to sleep loss" (7)

In short, the prisoner should not be provided a routine to which he can adapt and from which he can draw some comfort-- or at least a sense of his own identity. Everyone has read of prisoners who were reluctant to leave their cells after prolonged incarceration. Little is known about the duration of confinement calculated to make a subject shift from anxiety, coupled with a desire for sensory stimuli and human companionship, to a passive, apathetic acceptance of isolation and an ultimate pleasure in this negative state. Undoubtedly the rate of change is determined almost entirely by the psychological characteristics of the individual. In any event, it is advisable to keep the subject upset by constant disruptions of patterns.

For this reason, it is useful to determine whether the interrogatee has been jailed before, how often, under what circumstances, for how long, and whether he was subjected to earlier interrogation. Familiarity with confinement and even with isolation reduces the effect.

Sending **COVID-positive patients into nursing homes** for 46 days helped kill thousands of elderly, including my husband's parents. But if you watched the news last spring, you probably would never have known.

He was riding high on his popularity: winning an Emmy award, creating and selling creepy posters of a conquered "COVID mountain" and signing a \$5.1 million book deal. All the while, he covered up how his decisions led to seniors dying — by the thousands.

A timeline of Cuomo's handling of COVID-19 in nursing homes

April 3: Cuomo signs the state budget, which included sweeping new immunity protections for nursing homes, a provision buried in the massive spending bills that most legislators were not aware of until after the fact.

More than 9,000 recovering coronavirus patients in New York state were released from hospitals into nursing homes early in the pandemic under a controversial directive that was scrapped amid criticism it accelerated outbreaks, according to new records obtained by The Associated Press.

The new number of 9,056 recovering patients sent to hundreds of nursing homes is more than 40 percent higher than what the state health department previously released. And it raises new questions as to whether a March 25 directive from Gov. Andrew Cuomo's administration helped spread sickness and death among residents, a charge the state disputes.

April 9: The operator of one nursing home in Brooklyn asked the administration if it could transfer residents with confirmed or suspected COVID-19 cases to the Javits Center, which had been set up as a federally-run coronavirus field hospital, or the USS Comfort, which had docked in Manhattan for the same reason. Both emergency facilities remained mostly empty the entire time they were open. The state denied the request.

April 20: Cuomo indicates that he is not aware of his own health department's directive about admitting residents who test positive for the coronavirus. Health Commissioner Howard Zucker reiterates that nursing homes should accept those residents and that "the necessary precautions will be taken" to protect the residents.

April 23: Cuomo says that nursing homes "don't have the right to object" to the state directive, adding that if they can't properly isolate COVID-19-positive residents, they must transfer those residents to another facility or ask the state Department of Health for assistance. The directive does not reference a nursing home's ability to contact the state or transfer residents to another facility if they cannot isolate them. Zucker says he is not aware of the state having received any such requests.

May 5: The state updates how it counts COVID-19 deaths in nursing homes to include presumed cases in addition to confirmed cases, increasing the total at the time by 1,700.

May 10: Under intense pressure, Cuomo rescinds the nursing home directive with an executive order and replaces it with a policy that states that nursing homes cannot accept residents without a negative COVID-19 test.

Feb. 10: The Cuomo administration meets with Democratic lawmakers behind closed doors, who later release the letter the administration gave them that provided answers to the questions legislators sent back in August. The letter raised the total COVID-19 death toll in nursing homes and other adult-care facilities to 15,049 through Feb 9.

Audit: Whitmer admin undercounted COVID nursing home deaths by 42%

(The Center Square) – A new **audit** found Gov. Gretchen Whitmer's administration undercounted COVID-19 nursing home deaths by 42%, or 2,386.

At issue is how many nursing deaths occurred in Michigan and whether Whitmer's COVID-19 policies exacerbated nursing home deaths by housing infected patients with those most vulnerable to die from COVID-19. COVID-19 disproportionately kills the elderly and those with pre-existing health conditions. In Michigan, **84%** of the state's total COVID-19 victims were people aged 60 and older.

The Auditor General's report found the total number of COVID-19 deaths at long-term care facilities at 8,061, compared to the state's previous self-reported tally of 5,675.

Nearly half of the disputed 2,386 deaths stem from federal reporting requirements mandating large long-term care facilities such as skilled nursing facilities, adult foster homes, and homes for the aged must report COVID-19 deaths. Smaller facilities – typically with fewer than 13 beds – were not required to report COVID-19 deaths.

"New York kept count and lied about it. Michigan started looking into it, found a number they didn't like, and they stopped counting," LeDuff said. "Which is worse?"

The heartbreaking story of [Veronica Wolski](#), a well-known Chicago Freedom advocate, was widely publicized. Once hospitalized in ironically named Resurrection Hospital, Veronica was given Remdesivir, which she had repeatedly refused, denied proper basic medical care that could have been lifesaving, and was not allowed access to her family, priest, or health care power of attorney. Veronica was blocked from leaving the hospital when she and her attorneys demanded release. Her health care power of attorney was removed by hospital security. Veronica died alone as a medical prisoner in a Catholic hospital, denied even a priest at the end of her life.

Unconscionable hospital violations of human rights, including even violations of the Geneva Conventions established following World War II to prevent abuses of prisoners, are occurring daily across the U.S.

- Patients are coerced to take rapidly approved drugs like Remdesivir, in spite of known risks of kidney and liver failure, and to be placed on ventilators, both of which bring in incentive payments and create huge profits for hospitals.

- Patients are denied adequate fluids and nutrition, as well as vitamins, inhaled and intravenous corticosteroids, antibiotics, antivirals, and adequate doses of "blood-thinners" (anticoagulants).
- Patients suffer inhumane isolation with use of chemical and physical restraints, in violation of existing guidelines for patient protection.

- Hospitals are using law enforcement to deny access to hospital grounds for family and advocates.

Patients and their advocates have been denied information on benefits of early treatments and denied access to such treatment. Autopsies have confirmed many patients died because of inadequate doses of standard anticoagulation, even after family members went to court to demand therapeutic doses to help save lives.

*Just finished a 10-night stretch in the ICU. Patient bashing and blatant meanness have taken on a whole new level within our health care colleagues. How can we NOT spiral downwards towards despair when this behavior is allowed and is being normalized?? ... I feel I've been thrown into a "Mean Girls" sequel. **Making fun of patients and families for not being V'd is the cool thing now.** ... I don't mind taking care of COVID patients. But this hateful vibe that has permeated my world is what's going to end my career if it doesn't [stop].*

CMS implemented “value-based” payment programs that track data such as how many workers at a healthcare facility receive a COVID-19 vaccine. Now we see why many hospitals implemented COVID-19 vaccine mandates. **They are paid more.**

There are deaths from the government-directed COVID treatments. For **remdesivir, studies show that 71–75 percent of patients suffer an adverse effect, and the drug often had to be stopped after five to ten days because of these effects, such as kidney and liver damage, and death. Remdesivir trials during the 2018 West African Ebola outbreak had to be discontinued because death rate exceeded 50%. Yet, in 2020, Anthony Fauci directed that remdesivir was to be the drug hospitals use to treat COVID-19, even when the COVID clinical trials of remdesivir showed similar adverse effects.**

In ventilated patients, the death toll is staggering. A National Library of Medicine January 2021 report of 69 studies involving more than 57,000 patients concluded that fatality rates were 45 percent in COVID-19 patients receiving invasive mechanical ventilation, increasing to 84 percent in older patients. Renz announced at a Truth for Health Foundation Press Conference that CMS data showed that in Texas hospitals, 84.9% percent of all patients died after more than 96 hours on a ventilator.

Then there are deaths from restrictions on effective treatments for hospitalized patients. Renz and a team of data analysts have estimated that more than 800,000 deaths in America's hospitals, in COVID-19 and other patients, have been caused by approaches restricting fluids, nutrition, antibiotics, effective antivirals, anti-inflammatories, and therapeutic doses of anti-coagulants.

Our formerly trusted medical community of hospitals and hospital-employed medical staff have effectively become “bounty hunters” for your life. Patients need to now take unprecedented steps to avoid going into the hospital for COVID-19.

Definition of psychopath

1. A grandiose sense of self-importance. Feeling superior to others and that one deserves special treatment.
2. Preoccupation with fantasies of unlimited success, power, brilliance, beauty, or ideal love.
3. Belief that he or she is “special” and unique and can only be understood by or should associate with, other special or high-status people or institutions
4. Requires excessive admiration. Often monopolize conversations. Feels slighted, mistreated, depleted, and enraged when ignored.
5. Has a sense of entitlement
6. Is interpersonally exploitative – takes advantage of others. Relationships are based on surface attributes and not the unique qualities of others. People are only valued only to the extent they are viewed as beneficial.
7. Lacks empathy. Severely limited or totally lacking ability to care about the emotional needs or experiences of others, even loved ones.
8. Envy others or believes others are envious of him or her
9. Shows arrogant, haughty behaviors and attitudes
10. Sense of self is highly superficial, extremely rigid, and often fragile. Self-stability depends on maintaining the view that one is exceptional. Grandiose sense of self is easily threatened. retreat from or deny realities that challenge grandiosity .
11. Interactions are superficial
12. Intimacy is avoided
13. Difficulty with attachment and dependency
14. Relies on feedback from the environment
15. Relationships only exist to shore up positive self-image
16. Narcissistic personality disorder is also a significant risk factor for suicide and suicidal attempts.
