A request for information from the surgeon general’s office **demand**ed that tech platforms **send data and analysis on the prevalence of Covid-19 misinformation on their sites, starting with common examples of vaccine misinformation documented by the Centers for Disease Control and Prevention.**

The notice asks the companies to submit **“exactly how many users saw or may have been exposed to instances of Covid-19 misinformation,”** as well as aggregate **data on demographics that may have been disproportionately exposed to or affected by the misinformation.**

The surgeon general, Dr. Vivek Murthy, **also demand**ed information from the platforms **about the major sources of Covid-19 misinformation, including those that engaged in the sale of unproven Covid-19 products, services and treatments.**

“Technology companies now have the opportunity to be open and transparent with the American people about the misinformation on their platforms,” Dr. Murthy said in an emailed statement. He added: **“This is about protecting the nation’s health.”**

Companies have until May 2 to submit the data. Denying requests for information does not carry a penalty, but the notice is the first formal request from the Biden administration of the tech companies to submit Covid-19 misinformation data, according to the surgeon general's office.

The request for information is part of President Biden's **Covid National Preparedness Plan**, which the White House detailed on Wednesday and which is a road map for a new stage of the pandemic where Covid-19 causes "minimal disruption," according to the White House. Mr. Biden first revealed details of the plan during his State of the Union address Tuesday night.

In addition to **demanding** misinformation data from the tech platforms, the surgeon general **called on health care providers and the public to submit information about how Covid-19 misinformation has negatively influenced patients and communities.**

"We're asking anyone with relevant insights — **from original research and data sets to personal stories that speak to the role of misinformation in public health — to share them with us,**" Dr. Murthy said.

We thought they only would listen to "peer reviewed studies" and "antidotal information or personal information or "original research" was not considered when discussing the harms of the jabberjab?! DUCKDUCKGO BOWS TO AUTHORITARIANS, BEGINS CENSORING SEARCH ENGINE RESULTS TO 'FIGHT DISINFORMATION'

Arguably the world's most popular private search engine, DuckDuckGo, has long been a haven for those who do not want to participate in Google's censorship, manipulation, and tracking. In 2008, Gabriel Weinberg stated this mission with an emphasis on protecting searchers' privacy and avoiding the filter bubble of personalized search results that comes with all things Google.

Since its inception, the pro-privacy and anti-tracking business model has propelled the company from just a couple hundred thousand searches a month to over 100,000,000 searches every day. Their growth has been nearly exponential. But that all may be changing now. **This week, Weinberg, took everything his organization had been working on for years, and flushed it down the toilet with a single tweet.**

Like so many others I am sickened by Russia's invasion of Ukraine and the gigantic humanitarian crisis it continues to create. #StandWithUkraine At DuckDuckGo, we've been rolling out search updates that down-rank sites associated with Russian disinformation.

Moreover, **who gets to decide what exactly constitutes “disinformation”**? In his thread, in which he engaged with several users, Weinberg **said nothing of transparency. Nor did he elaborate on what is and what isn’t disinformation or who would be telling DuckDuckGo what to censor.**

If anything, the last two years, and especially the last three weeks, have shown us that **today’s disinformation is the next days reality and vice versa. So many stories have been called disinformation only to be proven true months later while at the same time, overt disinformation has been presented as fact only to be proven false down the road.**

Chair of Advisory Committee on Immunizations floats racially-based depopulation plan

op Center for Disease Control official was caught on tape in 2016 saying that society should "get rid of of all the whites in the United States" to reduce the number of people who refuse vaccines.

Dr. Carol Baker made the alarming remarks during the "Achieving Childhood Vaccine Success in the U.S." panel discussion sponsored by the National Meningitis Association in New York City on May 9, 2016.

"So I have the solution. Every study published in the last five years, when you look at vaccine refusers," Baker told the panel. We'll just get rid of all the whites in the United States...Guess who wants to get vaccinated the most? Immigrants."

Notably, Baker was appointed Chair of the CDC's Advisory Committee on Immunization by Obama's Health and Human Services Secretary Kathleen Sebelius in 2009.

The Houston doctor was also honored with the Sabin Vaccine Institute's 2019 Albert B. Sabin Gold Medal at a Washington D.C. ceremony sponsored "in part by the Bill & Melinda Gates Foundation and Pfizer."

Is it really that surprising a Bill Gates-connected CDC official openly suggested depopulating whites who don't cooperate with their mandatory vaccine agenda?

Where does the word *fascism* come from? ^

The word *fascism* comes from the Latin *fasces*, which denotes a bundle of wooden rods that typically included a protruding axe blade. In ancient Rome, lictors (attendants to magistrates) would hold the *fasces* as a symbol of the penal power of their magistrate. The first European fascist, Benito Mussolini, adopted this symbol both to recall the greatness of the Roman Empire and to reinforce his authority as the eventual dictator of Italy. Fascist regimes like his required their citizens to be as unified as the tightly bound *fasces*.

Fasces as symbols of power and authority were also present throughout the United States and republican France in the 18th and 19th centuries. Similar to Mussolini's government, the U.S. and France aimed to align themselves with the legacy of Rome. However, the *fasces* came to be almost exclusively associated with fascism by the middle of the 20th century.

Although fascism is a notoriously difficult ideology to define, many 20th-century fascist movements shared several characteristics. First, these movements sourced their political strength from populations experiencing economic woes, real or imagined. Fascists tended to capitalize on these economic anxieties by shifting the blame away from government or market forces. Jews, immigrants, leftists, and other groups became useful scapegoats. Redirecting popular anger toward these people would, in theory, rid a country of its ailments.

To unify a country, fascist movements propagated extreme nationalism that often went hand in hand with militarism and racial purity. The prosperity of a nation depended on a unified polity that put the group's welfare above the individual's. A strong, vigilant military was considered necessary to defend these group interests. And for some fascists "the group" was defined not by territorial boundaries but by racial identity. Nazism constituted the most insidious form of racial-purist fascist nationalism.

Economic Fascism-Planned Capitalism Lives On Wednesday, June 1, 1994

When people hear the word “fascism” they naturally think of its ugly racism and anti-Semitism as practiced by the totalitarian regimes of Mussolini and Hitler. But there was also an economic policy component of fascism, known in Europe during the 1920s and ‘30s as “corporatism,” that was an essential ingredient of economic totalitarianism as practiced by Mussolini and Hitler.

So-called corporatism was adopted in Italy and Germany during the 1930s and was held up as a “model” by quite a few intellectuals and policy makers in the United States and Europe. A version of economic fascism was in fact adopted in the United States in the 1930s and survives to this day. In the United States these policies were not called “fascism” but “planned capitalism.” The word fascism may no longer be politically acceptable, but its synonym “industrial policy” is as popular as ever.

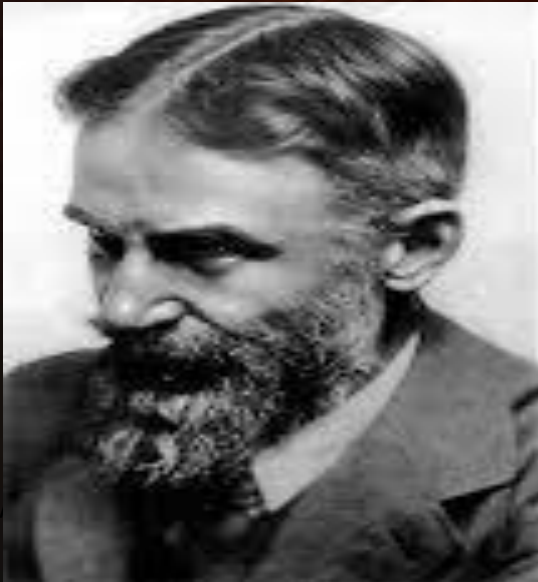
Few Americans are aware of or can recall how so many Americans and Europeans viewed economic fascism as the wave of the future during the 1930s. **The American Ambassador to Italy, Richard Washburn Child**, was so impressed with “**corporatism**” that he wrote in the preface to Mussolini’s 1928 autobiography that “**it may be shrewdly forecast that no man will exhibit dimensions of permanent greatness equal to Mussolini. . . . The Duce is now the greatest figure of this sphere and time.**”[1]



Winston Churchill wrote in 1927 that “If I had been an Italian I am sure I would have been entirely with you” and “don the Fascist black shirt.”[2] As late as 1940, Churchill was still describing Mussolini as “a great man.”

Certain British intellectuals were perhaps the most smitten of anyone by fascism. **George Bernard Shaw** announced in 1927 that his fellow “**socialists should be delighted to find at last a socialist [Mussolini] who speaks and thinks as responsible rulers do.**”[4] He helped form the **British Union of Fascists** whose “**Outline of the Corporate State,**” according to the organization’s founder, **Sir Oswald Mosley**, was “**on the Italian Model.**” While visiting England, the American author **Ezra Pound** declared that Mussolini was “continuing the task of **Thomas Jefferson.**”[5]

Thus, it is important to recognize that, **as an economic system, fascism was widely accepted in the 1920s and '30s.** The evil deeds of individual fascists were later condemned, **but the practice of economic fascism never was.** To this day, the historically uninformed continue to repeat the hoary slogan that, despite all his faults, Mussolini at least “made the trains run on time,” insinuating that his interventionist industrial policies were a success.

The Italian “Corporatist” System

- ❖ The state comes before the individual.

This stands in stark contrast to the classical liberal idea that individuals have natural rights that pre-exist government; that government derives its “just powers” only through the consent of the governed; and that the principal function of government is to protect the lives, liberties, and properties of its citizens, not to aggrandize the state.

October 7, 2021 Dr. Fauci: "I think what people have to appreciate that indeed you do have personal liberties for yourself. You should be in control of that, but you are a member of society. And as a member of society reaping all the benefits of being a member of society, you have a responsibility to society. And I think each of us, particularly in the context of a pandemic that's killing millions of people, you have got to look at it and say, there comes a time when you do have to give up what you consider your individual right. Of making your own decision for the greater good of society. There's no doubt that that's the case."

Aug 5, 2021 Dr. Fauci: “The alpha variant, the level of virus in a vaccinated person was extremely low in the vaccinated people compared to the unvaccinated people – not so with delta. So, we know now that vaccinated people who get breakthrough infections can spread the virus to other people.”

Mussolini viewed these liberal ideas (in the European sense of the word “liberal”) as the antithesis of fascism: “The Fascist conception of life,” Mussolini wrote, “stresses the importance of the State and accepts the individual only in so far as his interests coincide with the State. It is opposed to classical liberalism [which] denied the State in the name of the individual; Fascism reasserts the rights of the State as expressing the real essence of the individual.”[6]


Mussolini thought it was unnatural for a government to protect individual rights: “The maxim that society exists only for the well-being and freedom of the individuals composing it does not seem to be in conformity with nature’s plans.”[7] “If classical liberalism spells individualism,” Mussolini continued, “Fascism spells government.”



The essence of fascism, therefore, is that government should be the master, not the servant, of the people. Think about this. Does anyone in America really believe that this is not what we have now (1994)? Are Internal Revenue Service agents really our “servants”? Is compulsory “national service” for young people, which now exists in numerous states and is part of a federally funded program, not a classic example of coercing individuals to serve the state? Isn't the whole idea behind the massive regulation and regimentation of American industry and society the notion that individuals should be forced to behave in ways defined by a small governmental elite? When the nation's premier health-care reformer recently declared that heart bypass surgery on a 92-year-old man was “a waste of resources,” wasn't that the epitome of the fascist ideal—that the state, not individuals, should decide whose life is worthwhile, and whose is a “waste”?

The U.S. Constitution was written by individuals who believed in the classical liberal philosophy of individual rights and sought to protect those rights from governmental encroachment. But since the fascist/collectivist philosophy has been so influential, policy reforms over the past half century have all but abolished many of these rights by simply ignoring many of the provisions in the Constitution that were designed to protect them. As legal scholar Richard Epstein has observed: “[T]he eminent domain . . . and parallel clauses in the Constitution render . . . suspect many of the heralded reforms and institutions of the twentieth century: zoning, rent control, workers’ compensation laws, transfer payments, progressive taxation.”[8] **It is important to note that most of these reforms were initially adopted during the ‘30s, when the fascist/collectivist philosophy was in its heyday.**

❖ **Planned industrial “harmony.”**

Another keystone of Italian corporatism was the idea that the government’s interventions in the economy should not be conducted on an ad hoc basis, but should be “coordinated” by some kind of central planning board. Government intervention in Italy was “too diverse, varied, contrasting. There has been disorganic . . . intervention, case by case, as the need arises,” Mussolini complained in 1935.[9] **Fascism would correct this by directing the economy toward “certain fixed objectives” and would “introduce order in the economic field.”[10] Corporatist planning, according to Mussolini adviser Fausto Pitigliani, would give government intervention in the Italian economy a certain “unity of aim,” as defined by the government planners.[11]**

These exact sentiments were expressed by Robert Reich (currently the U.S. Secretary of Labor) and Ira Magaziner (currently (1994) the federal government's health care reform "Czar") in their book *Minding America's Business*. [12] In order to counteract the "untidy marketplace," an interventionist industrial policy "must strive to integrate the full range of targeted government policies—procurement, research and development, trade, antitrust, tax credits, and subsidies—into a coherent strategy"

[13]

Current industrial policy interventions, Reich and Magaziner bemoaned, are "the product of fragmented and uncoordinated decisions made by [many different] executive agencies, the Congress, and independent regulatory agencies There is no integrated strategy to use these programs to improve the . . . U.S. economy." [14]

In his 1989 book, *The Silent War*, Magaziner reiterated this theme by advocating a coordinating group like the national Security Council to take a strategic national industrial view." [15] The White House has in fact established a "National Economic Security Council." Every other advocate of an interventionist "industrial policy" has made a similar "unity of aim" argument, as first described by Pitigliani more than half a century ago.

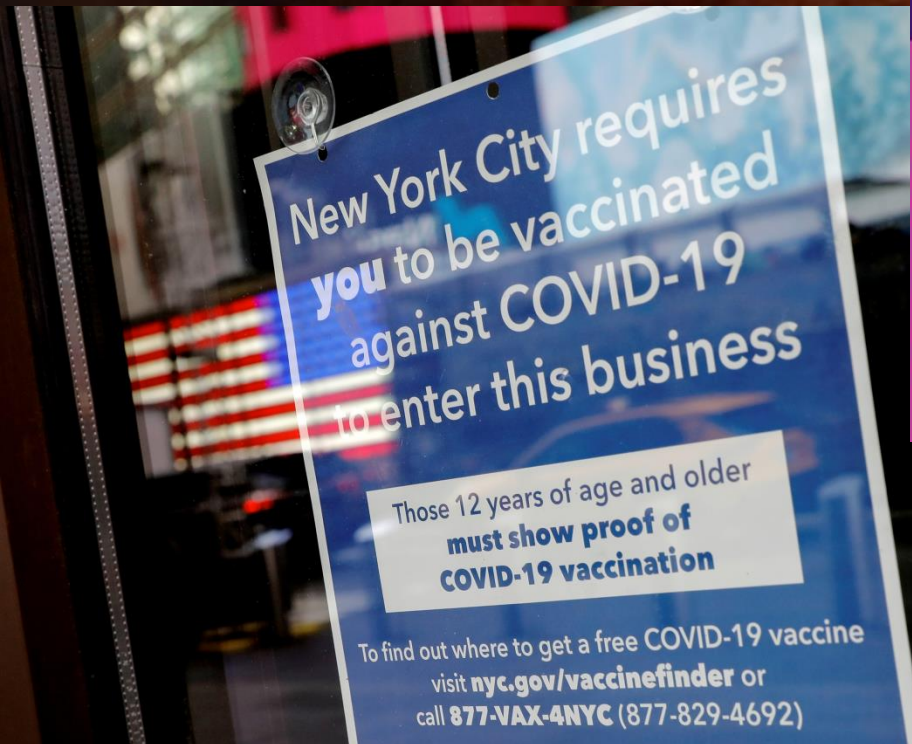
Government-business partnerships.

A third defining characteristic of economic fascism is that private property and business ownership are permitted, but are in reality controlled by government through a business-government “partnership.” As Ayn Rand often noted, however, in such a partnership government is always the senior or dominating “partner.”

In Mussolini’s Italy, businesses were grouped by the government into legally recognized “syndicates” such as the “National Fascist Confederation of Commerce,” the “National Fascist Confederation of Credit and Insurance,” and so on. All of these “fascist confederations” were “coordinated” by a network of government planning agencies called “corporations,” one for each industry. One large “National Council of Corporations” served as a national overseer of the individual “corporations” and had the power to “issue regulations of a compulsory character.”[16]

The purpose of this byzantine regulatory arrangement was so that the government could “secure collaboration . . . between the various categories of producers in each particular trade or branch of productive activity.”[17] Government-orchestrated “collaboration” was necessary because “the principle of private initiative” could only be useful “in the service of the national interest” as defined by government bureaucrats.[18]

This idea of **government-mandated and -dominated “collaboration”** is also at the heart of all interventionist industrial policy schemes. A successful industrial policy, write Reich and Magaziner, would **“require careful coordination between public and private sectors.”**[19] **“Government and the private sector must work in tandem.”**[20] **“Economic success now depends to a high degree on coordination, collaboration, and careful strategic choice,”** guided by government.[21]

Mercantilism and protectionism. Whenever politicians start talking about “collaboration” with business, it is time to hold on to your wallet. Despite the fascist rhetoric about “national collaboration” and working for the national, rather than private, interests, the truth is that mercantilist and Protectionist practices riddled the system. Italian social critic Gaetano Salvemini wrote in 1936 that under corporatism, “it is the state, i.e., the taxpayer, who has become responsible to private enterprise. In Fascist Italy the state pays for the blunders of private enterprise.”[25] As long as business was good, Salvemini wrote, “profit remained to private initiative.”[26] But when the depression came, “the government added the loss to the taxpayer’s burden. Profit is private and individual. Loss is public and social.”[27]



The Italian corporative state, The Economist editorialized on July 27, 1935, “only amounts to the establishment of a new and costly bureaucracy from which those industrialists who can spend the necessary amount, can obtain almost anything they want, and put into practice the worst kind of monopolistic practices at the expense of the little fellow who is squeezed out in the process.” Corporatism, in other words, was a massive system of corporate welfare. “Three-quarters of the Italian economic system,” Mussolini boasted in 1934, “had been subsidized by government.”[28]

If this sounds familiar, it is because it is exactly the result of agricultural subsidies, the Export-Import bank, guaranteed loans to “preferred” business borrowers, protectionism, the Chrysler bailout, monopoly franchising, and myriad other forms of corporate welfare paid for directly or indirectly by the American taxpayer.

Another result of the close “collaboration” between business and government in Italy was “a continual interchange of personnel between the . . . civil service and private business.”[29] Because of this “revolving door” between business and government, Mussolini had “created a state within the state to serve private interests which are not always in harmony with the general interests of the nation.”[30]

Between 1998 and 2004 more than 2200 high-ranking government officials became lobbyists. This included more than half the senior officials of the Clinton administration who became corporate lobbyists when they left government office.

Politicians who do favors for particular corporations or business interests can also look forward to highly paid corporate executive positions, board memberships, or lucrative consultancies after they retire from political life.

Even if such job offers are not explicitly promised, it is in the interests of those looking forward to a post-government career in business not to displease the business community whilst in office and this means they tend to take a business viewpoint whilst still in government.

The whole idea behind collectivism in general and fascism in particular is to make citizens subservient to the state and to place power over resource allocation in the hands of **a small elite**. As stated eloquently by the American fascist economist Lawrence Dennis, fascism “**does not accept** the liberal dogmas as to the sovereignty of the consumer or trader in the free market

Least of all does it consider that market freedom, and the opportunity to make competitive profits, are rights of the individual.” Such decisions should be made by a “dominant class” he labeled “**the elite**.”[32]

Conclusions

Virtually all of the specific economic policies advocated by the Italian and German fascists of the 1930s have also been adopted in the United States in some form, and continue to be adopted to this day. Sixty years ago, those who adopted these interventionist policies in Italy and Germany did so because they wanted to destroy economic liberty, free enterprise, and individualism. Only if these institutions were abolished could they hope to achieve the kind of totalitarian state they had in mind.

Many American politicians who have advocated more or less total government control over economic activity have been more devious in their approach. They have advocated and adopted many of the same policies, but they have always recognized that direct attacks on private property, free enterprise, self-government, and individual freedom are not politically palatable to the majority of the American electorate.

Thus, they have enacted a great many tax, regulatory, and income-transfer policies that achieve the ends of economic fascism, but which are sugar-coated with deceptive rhetoric about their alleged desire only to “save” capitalism.

American politicians have long taken their cue in this regard from **Franklin D. Roosevelt**, who sold his **National Recovery Administration (which was eventually ruled unconstitutional)** on the grounds that “government restrictions henceforth must be accepted not to hamper individualism but to protect it.”[40] In a classic example of Orwellian doublespeak, Roosevelt thus argued that individualism must be destroyed in order to protect it.



Now that socialism has collapsed and survives nowhere but in Cuba, China, Vietnam, and on American university campuses, the biggest threat to economic liberty and individual freedom lies in the new economic fascism. While the former Communist countries are trying to privatize as many industries as possible as fast as they can, they are still plagued by governmental controls, leaving them with essentially fascist economies: private property and private enterprise are permitted, but are heavily controlled and regulated by government.

As most of the rest of the world struggles to privatize industry and encourage free enterprise, we in the United States are seriously debating whether or not we should adopt 1930s-era economic fascism as the organizational principle of our entire health care system, which comprises 14 percent of GNP. We are also contemplating business-government “partnerships” in the automobile, airlines, and communications industries, among others, and are adopting government-managed trade policies, also in the spirit of the European corporatist schemes of the 1930s.

The state and its academic apologists are so skilled at generating propaganda in support of such schemes that Americans are mostly unaware of the dire threat they pose for the future of freedom. The road to serfdom is littered with road signs pointing toward “the information superhighway,” “health security,” “national service,” “managed trade,” and “industrial policy.”

In many cases, the private and public sectors, acting either separately or together, meet people's needs. But there are gaps, spaces where some people don't get what they need to live healthy, productive lives.

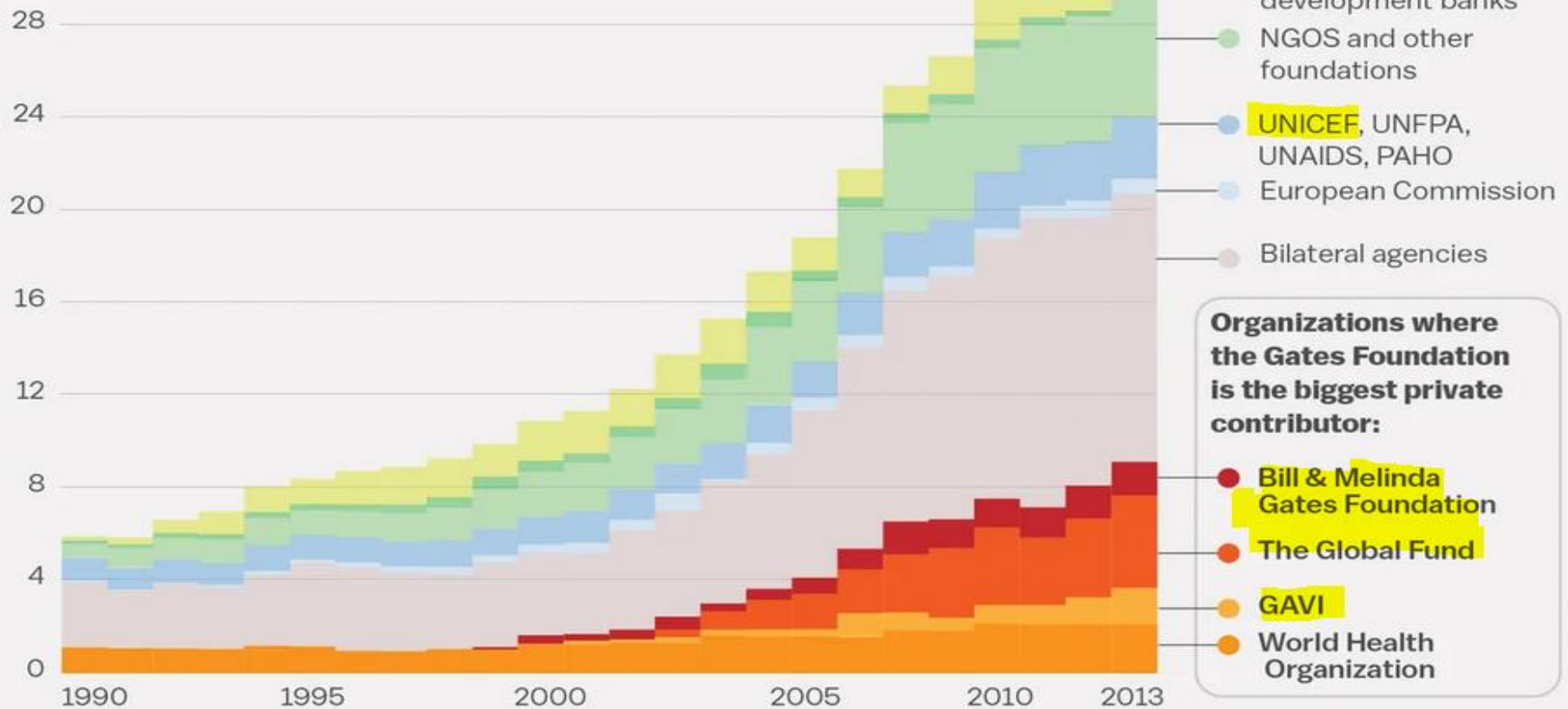

10. Sense of self is highly superficial, extremely rigid, and often fragile. Self-stability depends on maintaining the view that one is exceptional. Grandiose sense of self is easily threatened. retreat from or deny realities that challenge grandiosity .
11. Interactions are superficial
12. Intimacy is avoided
13. Difficulty with attachment and dependency
14. Relies on feedback from the environment
15. Relationships only exist to shore up positive self-image
16. Narcissistic personality disorder is also a significant risk factor for suicide and suicidal attempts.

VIII. THE NON-COERCIVE COUNTERINTELLIGENCE INTERROGATION

A. General Remarks

The term non-coercive is used above to denote methods of interrogation that are not based upon the coercion of an unwilling subject through the employment of superior force originating outside himself. However, the non-coercive interrogation is not conducted without pressure. On the contrary, the goal is to generate maximum pressure, or at least as much as is needed to induce compliance. The difference is that the pressure is generated inside the interrogatee. His resistance is sapped, his urge to yield is fortified, until in the end he defeats himself.

Manipulating the subject psychologically until he becomes compliant, without applying external methods of forcing him to submit, sounds harder than it is. The initial advantage lies with the interrogator. From the outset, he knows a great deal more about the source than the source knows about him. And he can create and amplify an effect of omniscience in a number of ways. For example, he can show the interrogatee a thick file bearing his own name. Even if the file contains little or nothing but blank paper, the air of familiarity with which the interrogator refers to the subject's background can convince some sources that all is known and that resistance is futile.

If the interrogatee is under detention, the interrogator can also manipulate his environment. Merely by cutting off all other human contacts, "the interrogator monopolizes the social environment of the source." (3) He exercises the powers of an all-powerful parent, determining when the source will be sent to bed, when and what he will eat, whether he will be rewarded for good behavior or punished for being bad. The interrogator can and does make the

subject's world not only unlike the world to which he had been accustomed but also strange in itself - a world in which familiar patterns of time, space, and sensory perception are overthrown. He can shift the environment abruptly. For example, a source who refuses to talk at all can be placed in unpleasant solitary confinement for a time. Then a friendly soul treats him to an unexpected walk in the woods. Experiencing relief and exhilaration, the subject will usually find it impossible not to respond to innocuous comments on the weather and the flowers. These are expanded to include reminiscences, and soon a precedent of verbal exchange has been established. Both the Germans and the Chinese have used this trick effectively.

The interrogator also chooses the emotional key or keys in which the interrogation or any part of it will be played.

Because of these and other advantages, "...skilled and determined interrogators are almost invariably successful in eliciting some information from their sources.... For prisoner-of-war interrogation, the figures generally given as the proportion of sources who abandon the 'name, rank, number only' rule, or other injunctions of silence, are between 95 and 100 percent...."(3)

A principal goal during the opening phase is to confirm the personality assessment obtained through screening and to allow the interrogator to gain a deeper understanding of the source as an individual. Unless time is crucial, the interrogator should not become impatient if the interrogee wanders from the purposes of the interrogation and reverts to personal concerns. Significant facts not produced during screening may be revealed. The screening report itself is brought to life, the type becomes an individual, as the subject talks. And sometimes seemingly rambling monologues about personal matters are preludes to significant admissions. Some people cannot bring themselves to provide information that puts them in an unfavorable light until, through a lengthy prefatory rationalization, they feel that they have set the stage, that the interrogator will now understand why they acted as they did. If face-saving is necessary to the interrogee, it will be a waste of time to try to force him to cut the preliminaries short and get down to cases. In his view, he is dealing with the important topic, the why. He will be offended and may become wholly uncooperative if faced with insistent demands for the naked what.

2. The Reconnaissance

If the interrogatee is cooperative at the outset or if rapport is established during the opening phase and the source becomes cooperative, the reconnaissance stage is needless; the interrogator proceeds directly to detailed questioning. But if the interrogatee is withholding, a period of exploration is necessary. Assumptions have normally been made already as to what he is withholding: that he is a fabricator, or an RIS agent, or something else he deems it important to conceal. Or the assumption may be that he had knowledge of such activities carried out by someone else. At any rate, the purpose of the reconnaissance is to provide a quick testing of the assumption and, more importantly, to probe the causes, extent, and intensity of resistance.

During the opening phase the interrogator will have charted the probable areas of resistance by noting those topics which caused emotional or physical reactions, speech blocks, or other indicators. He now begins to probe these areas. Every experienced interrogator has noted that if an interrogatee

At the same time it is necessary to make every effort to keep the subject from learning through the interrogation process precisely where our informational gaps lie. This principle is especially important if the interrogatee is following his normal life, going home each evening and appearing only once or twice a week for questioning, or if his bona fides remains in doubt. Under almost all circumstances, however, a clear revelation of our interests and knowledge should be avoided. It is usually a poor practice to hand to even the most cooperative interrogatee an orderly list of questions and ask him to write the answers. (This stricture does not apply to the writing of autobiographies or on informational matters not a subject of controversy with the source.) Some time is normally spent on matters of little or no intelligence interest for purposes of concealment. The interrogator can abet the process by making occasional notes -- or pretending to do so -- on items that seem important to the interrogatee but are not of intelligence value. From this point of view an interrogation can be deemed successful if a source who is actually a hostile agent can report to the opposition only the general fields of our interest but cannot pinpoint specifics without including misleading information.

It is important to determine whether the subject's knowledge of any topic was acquired at first hand, learned indirectly, or represents merely an assumption. If the information was obtained indirectly, the identities of sub-sources and related information about the channel are needed. If statements rest on assumptions, the facts upon which the conclusions are based are necessary to evaluation.

C. Techniques of Non-Coercive Interrogation of Resistant Sources

If source resistance is encountered during screening or during the opening or reconnaissance phases of the interrogation, non-coercive methods of sapping opposition and strengthening the tendency to yield and to cooperate may be applied. Although these methods appear here in an approximate order of increasing pressure, it should not be inferred that each is to be tried until the key fits the lock. On the contrary, a large part of the skill and the success of the experienced interrogator lies in his ability to match method to source. The use of unsuccessful techniques will of itself increase the interrogatee's will and ability to resist.

The effectiveness of most of the non-coercive techniques depends upon their unsettling effect. The interrogation situation is in itself disturbing to most people encountering it for the first time. The aim is to enhance this effect, to disrupt radically the familiar emotional and psychological associations of the subject. When this aim is achieved, resistance is seriously impaired. There is an interval -- which may be extremely brief -- of suspended animation, a kind of psychological shock or paralysis. It is caused by a traumatic or sub-traumatic experience which explodes, as it were, the world that is familiar to the subject as well as his image of himself within that world. Experienced interrogators recognize this effect when it appears and know that at this moment the source is far more open to suggestion, far likelier to comply, than he was just before he experienced the shock.

Another effect frequently produced by non-coercive (as well as coercive) methods is the evocation within the interrogatee of feelings of guilt. Most persons have areas of guilt in their emotional topographies, and an interrogator can often chart these areas just by noting refusals to follow certain lines of questioning. Whether the sense of guilt has real or imaginary causes does not affect the result of intensification of guilt feelings. Making a person feel more and more guilty normally increases both his anxiety and his urge to cooperate as a means of escape.

2. Nobody Loves You

An interrogatee who is withholding items of no grave consequence to himself may sometimes be persuaded to talk by the simple tactic of pointing out that to date all of the information about his case has come from persons other than himself. The interrogator wants to be fair. He recognizes that some of the denouncers may have been biased or malicious. In any case, there is bound to be some slanting of the facts unless the interrogatee redresses the balance. The source owes it to himself to be sure that the interrogator hears both sides of the story.

3. The All-Seeing Eye (or Confession is Good for the Soul)

The interrogator who already knows part of the story explains to the source that the purpose of the questioning is not to gain information; the interrogator knows everything already. His real purpose is to test the sincerity (reliability, honor, etc.) of the source. The interrogator then asks a few questions to which he knows the answers. If the subject lies, he is informed firmly and dispassionately that he has lied. By skilled manipulation of the known, the questioner can convince a naive subject that all his secrets are out and that further resistance would be not only pointless but dangerous. If this technique does not work very quickly, it must be dropped before the interrogatee learns the true limits of the questioner's knowledge.

4. The Informer

Detention makes a number of tricks possible. One of these, planting an informant as the source's cellmate, is so well-known, especially in Communist countries, that its usefulness is impaired if not destroyed. Less well known is the trick of planting two informants in the cell. One of them, A, tries now and then to pry a little information from the source; B remains quiet. At the proper time, and during A's absence, B warns the source not to tell A anything because B suspects him of being an informant planted by the authorities.

Suspicion against a single cellmate may sometimes be broken down if he shows the source a hidden microphone that he has "found" and suggests that they talk only in whispers at the other end of the room.

5. News from Home

Allowing an interrogatee to receive carefully selected letters from home can contribute to effects desired by the interrogator. Allowing the source to write letters, especially if he can be led to believe that they will be smuggled out without the knowledge of the authorities, may produce information which is difficult to extract by direct questioning.

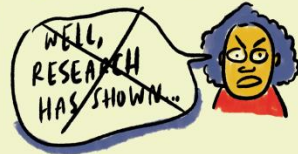

Regression

There are a number of non-coercive techniques for inducing regression. All depend upon the interrogator's control of the environment and, as always, a proper matching of method to source. Some interrogatees can be repressed by persistent manipulation of time, by retarding and advancing clocks and serving meals at odd times -- ten minutes or ten hours after the last food was given. Day and night are jumbled. Interrogation sessions are similarly unpatterned the subject may be brought back for more questioning just a few minutes after being dismissed for the night. Half-hearted efforts to cooperate can be ignored, and conversely he can be rewarded for non-cooperation. (For example, a successfully resisting source may become distraught if given some reward for the "valuable contribution" that he has made.) The Alice in Wonderland technique can reinforce the effect. Two or more interrogators, questioning as a team and in relays (and thoroughly jumbling the timing of both methods) can ask questions which make it impossible for the interrogatee to give sensible, significant answers. A subject who is cut off from the world he knows seeks to recreate it, in some measure, in the new and strange environment. He may try to keep track of time, to live in the familiar past, to cling to old concepts of loyalty, to establish -- with one or more interrogators -- interpersonal relations resembling those that he has had earlier with other people, and to build other bridges back to the known. Thwarting his attempts to do so is likely to drive him deeper and deeper into himself, until he is no longer able to control his responses in adult fashion.

The placebo technique is also used to induce regression. The interrogatee is given a placebo (a harmless sugar pill). Later he is told that he has imbibed a drug, a truth serum, which will make him want to talk and which will also prevent his lying. The subject's desire to find an excuse for the compliance that represents his sole avenue of escape from his distressing predicament may make him want to believe that he has been drugged and that no one could blame him for telling his story now. Gottschelk observes, "Individuals under increased stress are more likely to respond to placebos." (7)

In other words, a psychologically immature source, or one who has been regressed, could adopt an implication or suggestion that he has been drugged, hypnotized, or otherwise rendered incapable of resistance, even if he recognizes at some level that the suggestion is untrue, because of his strong desire to escape the stress of the situation by capitulating. These techniques provide the source with the rationalization that he needs.

Whether regression occurs spontaneously under detention or interrogation, and whether it is induced by a coercive or non-coercive technique, it should not be allowed to continue past the point necessary to obtain compliance. Severe techniques of regression are best employed in the presence of a psychiatrist, to insure full reversal later. As soon as he can, the interrogator presents the subject with the way out, the face-saving reason for escaping from his painful dilemma by yielding. Now the interrogator becomes fatherly. Whether the excuse is that others have already confessed ("all the other boys are doing it"), that the interrogatee has a chance to redeem himself ("you're really a good boy at heart"), or that he can't help himself ("they made you do it"), the effective rationalization, the one the source will jump at, is likely to be elementary. It is an adult's version of the excuses of childhood.
