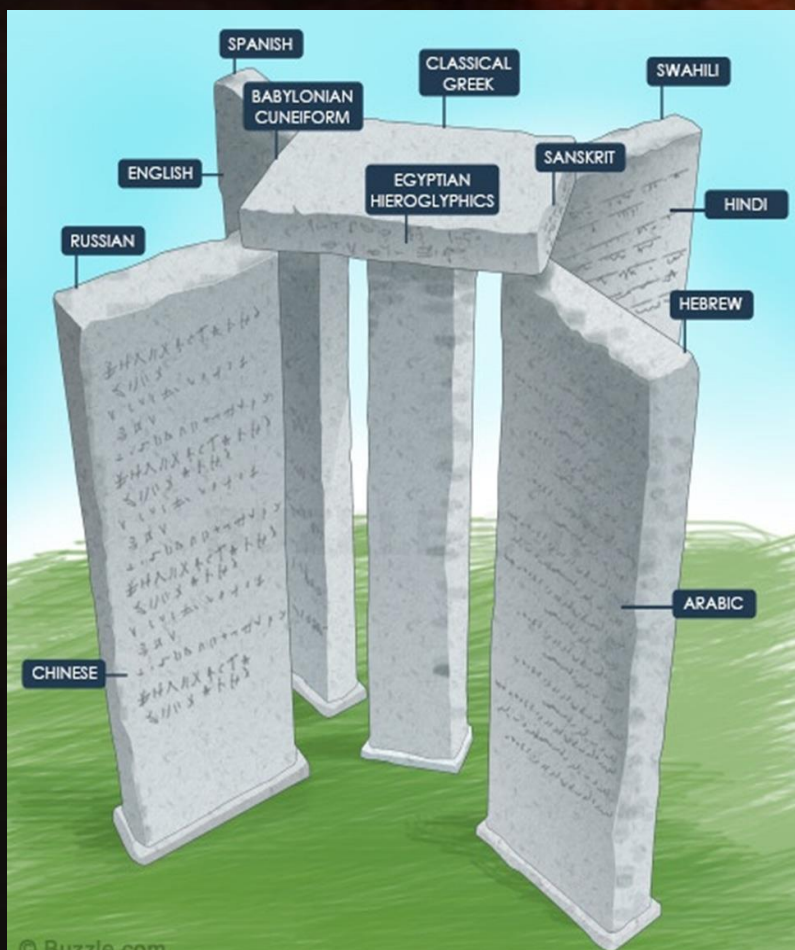
"Let These be Guidestones to an Age of Reason."



A message consisting of a set of ten guidelines or principles is engraved on the Georgia Guidestones in eight different languages, one language on each face of the four large upright stones. English, Spanish, Swahili, Hindi, Hebrew, Arabic, Chinese, and Russian.

- 1 . Maintain humanity under 500,000,000 in perpetual balance with nature.
2. Guide reproduction wisely — improving fitness and diversity.
3. Unite humanity with a living new language.
4. Rule passion — faith — tradition — and all things with tempered reason.
5. Protect people and nations with fair laws and just courts.
6. Let all nations rule internally resolving external disputes in a world court.
7. Avoid petty laws and useless officials.
8. Balance personal rights with social duties.
9. Truth — beauty — love — seeking harmony with the infinite.
10. Be not a cancer on the earth — Leave room for nature — Leave room for nature.

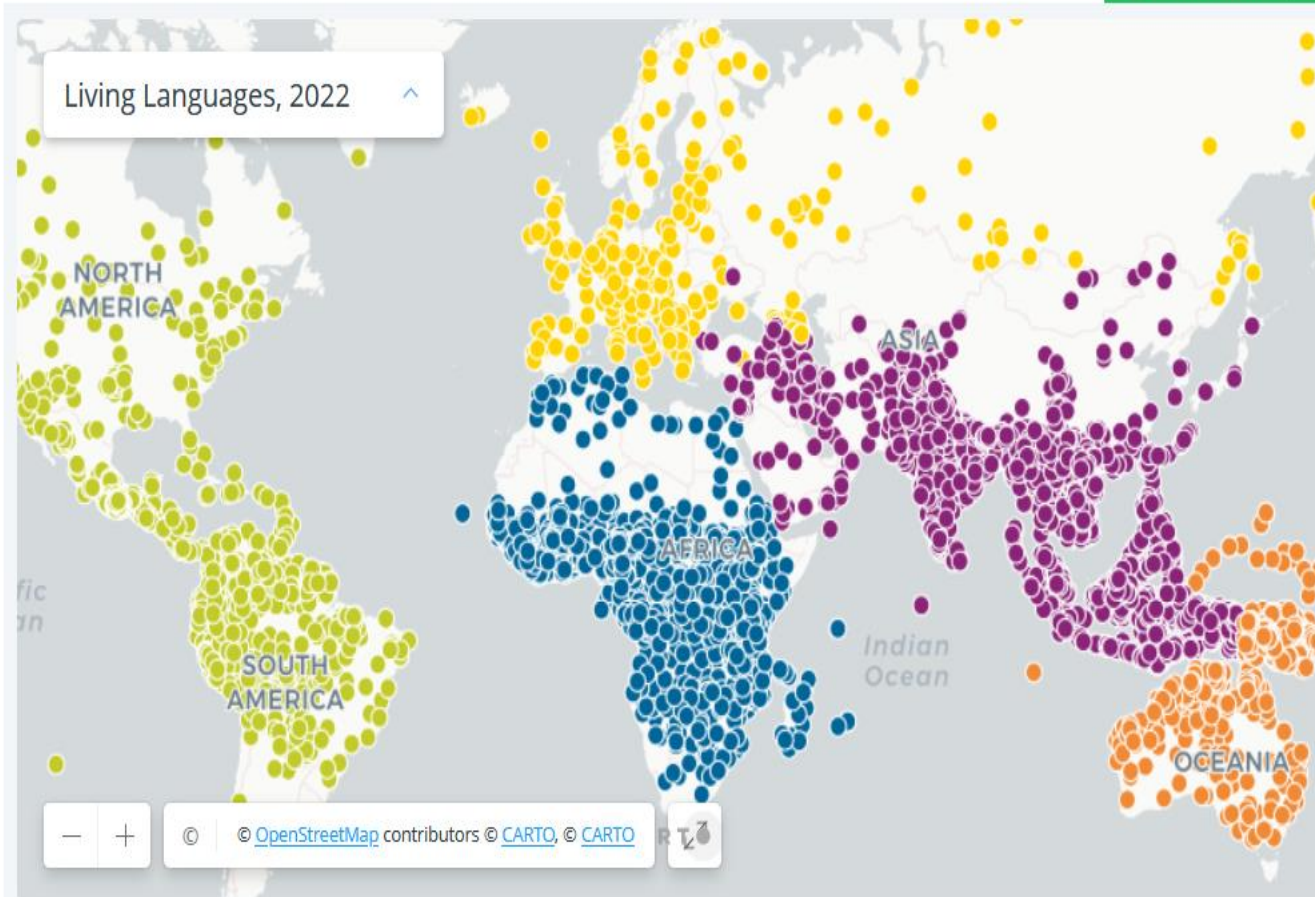

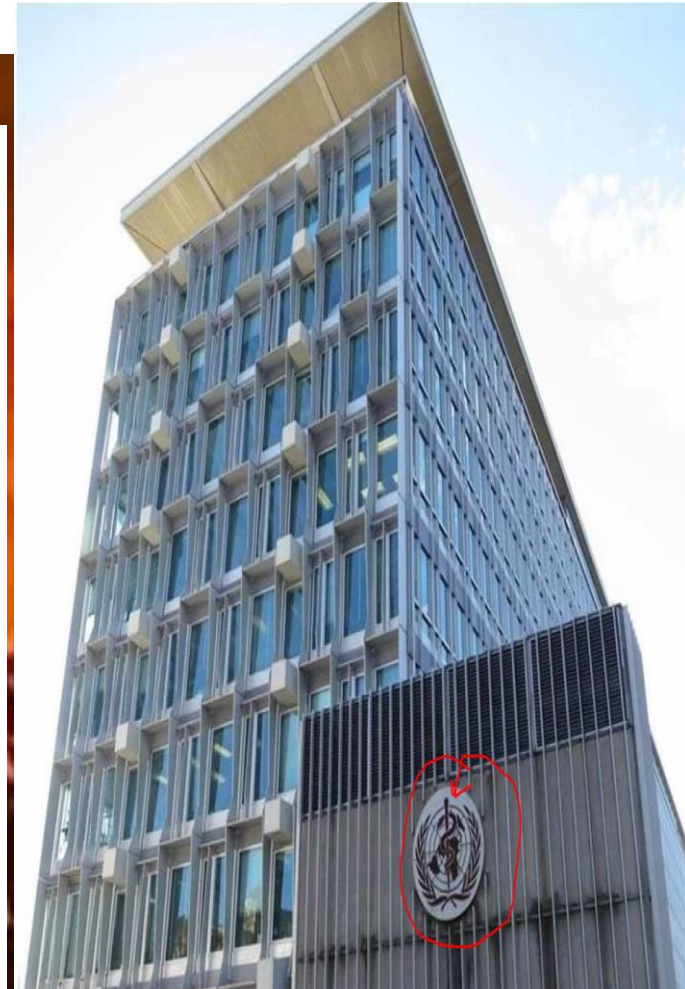
World Health Assembly agrees to launch process to develop historic global accord on pandemic prevention, preparedness and response

The Health Assembly met in a Special Session, the second-ever since WHO's founding in 1948, and adopted a sole decision titled: "The World Together." The decision by the Assembly establishes an intergovernmental negotiating body (INB) to draft and negotiate a WHO convention, agreement, or other international instrument on pandemic prevention, preparedness and response, with a view to adoption under Article 19 of the WHO Constitution, or other provisions of the Constitution as may be deemed appropriate by the INB.

Article 19 of the WHO Constitution provides the World Health Assembly with the authority to adopt conventions or agreements on any matter within WHO's competence. The sole instrument established under Article 19 to date is the WHO Framework Convention on Tobacco Control, which has made a significant and rapid contribution to protecting people from tobacco since its entry into force in 2005.

Under the decision adopted today, the INB will hold its first meeting by 1 March 2022 (to agree on ways of working and timelines) and its second by 1 August 2022 (to discuss progress on a working draft). It will also hold public hearings to inform its deliberations; deliver a progress report to the 76th World Health Assembly in 2023; and submit its outcome for consideration by the 77th World Health Assembly in 2024.

Through the decision, the World Health Assembly also requested the WHO Director-General to convene the INB meetings and support its work, including by facilitating the participation of other United Nations system bodies, non-state actors, and other relevant stakeholders in the process to the extent decided by the INB.

Treaty Threatens National Sovereignty

As noted by The Pulse, “there are a number of things in the treaty that the people of the world need to consider before going down this path.” In the featured video, The Pulse’s Joe Martino interviews Shabnam Palesa Mohamed, a member of the steering committee of the World Council for Health, who points out that the treaty gives the WHO:

“... an inordinate amount of power to make decisions in sovereign countries as to how people live and how they deal with pandemics, from lockdowns to mandates over treatment.”

In short, it would create a one-size-fits-all approach to disease, without regard for all the varying situations found in individual countries, and this is something we already know

doesn’t work. The treaty is a direct threat to a nation’s sovereignty to make decisions for itself and its citizens, and would erode democracy everywhere.

At the same time, it would cost each member country millions of dollars to participate in this process. As explained by Mohamed, the treaty will need to go through a voting process at the World Health Assembly in 2023. They need a majority for it to pass and, if passed, all member countries will be bound by it.

The Treaty Is 'Invalid and Unlawful'

Another concern raised by Mohamed is that many countries don't even know about this treaty as of yet, and it's possible that the WHO might try to push for earlier implementation than 2024 – all without public participation or input. "It is undemocratic, it is unconstitutional and therefore it makes the treaty invalid and unlawful," she says.

She also highlights the WHO's history of corruption and many health policy failures, which are "intrinsically linked to conflicts of interest." In an open letter on the WHO's pandemic treaty, the World Council for Health writes, in part:³

"The proposed WHO agreement is unnecessary, and is a threat to sovereignty and inalienable rights. It increases the WHO's suffocating power to declare unjustified pandemics, impose dehumanizing lockdowns, and enforce expensive, unsafe, and ineffective treatments against the will of the people.

The WCH [World Council for Health] believes that the people have a right to participate in any agreement that affects their lives, livelihoods, and well-being.

However, the WHO has not engaged in a process of public participation, which is evidence that its priority is capturing more power for itself and its corporate accomplices, than serving the interests of the people. Without an unbiased democratic process, any agreement by the WHO, acting via the United Nations, will be unlawful, illegitimate, and invalid.

Historically, the WHO leadership has failed the people. Among many examples, it approved the injurious H1N1 (swine flu) vaccine for a controversially declared pandemic.

Equally, the WHO failed during the COVID-19 chapter as it encouraged lockdowns, suppressed early preventive treatments, and recommended product interventions that have proven to be neither safe nor effective.

The WHO cannot be allowed to control the world's health agenda, nor enforce biosurveillance. While it receives funding from public sources belonging to the people, it is caught in a perpetual conflict of interest because it also receives substantial funding from private interests that use their contributions to influence and profit from WHO decisions and mandates.

For example, the Gates Foundation and the Gates-funded GAVI vaccine promotion alliance, contribute over \$1 billion a year."

Another concern is the fact that when people are harmed by the WHO's health policies, there's no accountability because the WHO has diplomatic immunity. According to Mohamed, "the WHO should not be making ANY decisions about world health in the future."

The Ultimate Power Grab

As noted by Martino, while the treaty claims to be focused on pandemic planning and responses, there's serious concern that it could be expanded to cover other areas of health as well. Mohamed agrees, saying that it could potentially be expanded, using the WHO's constitution as the basis for that expansion. Article 2 of the WHO's constitution states:

"In order to achieve its objective, the functions of the Organization shall be: a) to act as the directing and coordinating authority on international health work ... k) to propose conventions, agreements and regulations, and make recommendations with respect to international health matters ...

s) to establish and revise as necessary international nomenclatures of diseases, of causes of death and of public health practices ... v) generally to take all necessary action to attain the objective of the Organization."

Its power is already very significant, and the goal to turn the WHO into a global health dictatorship is virtually written into its constitution. Also, remember that the WHO removed the specificity of mass casualties from the definition of a pandemic, so now a pandemic can be just about any disease that occurs in multiple countries. Even obesity could theoretically qualify. So, the WHO could claim power over health care systems in any number of ways, given the chance.

Treaty Would Grant WHO Power to Mandate Vaccine Passports

While most of the world is more than ready to move on, the WHO seems unwilling to let go. A WHO official recently told the Ottawa Citizen that the COVID pandemic is still “far from over.”⁴

The reason for this reluctance to declare the pandemic over is likely because the WHO hopes to gain the power to mandate vaccine passports and COVID jabs worldwide. It's already working on the creation of a global vaccine passport/digital identity program. As reported by WEBLYF:⁵

“Under the guise of a ‘trust network,’ another initiative called Vaccination Credential Initiative (VCI) is also gaining momentum.

Partnering with big tech companies, big corporations, and big universities, VCI describes itself as ‘a voluntary coalition of public and private organizations committed to empowering individuals with access to verifiable clinical information including a trustworthy and verifiable copy of their vaccination records in digital or paper form using open, interoperable standards.’

Treaty Would Create Global Censorship of Health Information

The treaty would also give the WHO the power to censor health information worldwide. On the European Council's web page discussing the pandemic treaty, under the headline "Restoring Trust in the International Health System," it states:¹⁰

"The agreement ... will set the foundation for better communication and information to citizens. Misinformation threatens public trust and risks

undermining public health responses. To redeem citizen trust, concrete measures should be foreseen to improve the flow of reliable and accurate information as well as to tackle misinformation globally."

In other words, under this treaty, we can expect even greater censorship than what we've experienced so far. Tech companies have already proven where their allegiance lies, and it's not with the public.

Google, Facebook, Twitter, Instagram and others have deplatformed just about everyone who posts health information that runs counter to what the WHO is saying, real-world data and verifiable facts be damned. Financial platforms have also banned people for the same reason. Now imagine there being a binding international law that makes all that censorship mandatory.

Their Playbook Was Revealed in 2019

Officially, the Bill & Melinda Gates Foundation is the second largest funder of the WHO, second only to the U.S. government,¹¹ but the combined contributions from the Gates Foundation and GAVI made Gates the unofficial top sponsor of the WHO as of 2018.¹²

Gates has also been funding pandemic exercises, including Event 201,¹³ held October 18, 2019, which gained notoriety for its extraordinary accurate “predictions” of the COVID pandemic mere months before it was declared. Other co-sponsors included the World Economic Forum and Johns Hopkins Bloomberg School of Public Health.

However, earlier that year, February 14, 2019, Gates also funded the Nuclear Threat Initiative’s (NTI) pandemic exercise for senior global leaders on international response to deliberate biological events, which took place in Munich, Germany.^{14,15}

NTI was founded to assess and reduce threats associated with the proliferation of nuclear weapons,¹⁶ but they’ve since expanded to include biological threats.¹⁷ Gates has also given grants to the NTI for vaccine development in relation to biological threats.¹⁸

While Event 201 featured a fictional coronavirus outbreak, the NTI exercise involved response to “deliberate, high consequence biological events.” In other words, a deliberate release of a genetically engineered bioweapon – in this case a pneumonic plague – for which there is no available treatment. This exercise scenario was the first of its kind. The video above features a summary of the four-phase exercise.

Curiously, in mid-November 2019, The Guardian, The New York Times,¹⁹ The Washington Post²⁰ and others reported that two people in China had in fact been diagnosed with pneumonic plague.²¹

In addition to the Bill & Melinda Gates Foundation, the NTI event was sponsored by the Wellcome Trust, the “philanthropic arm” of GlaxoSmithKline and an investor in Vaccitech, which owns the patents to AstraZeneca’s COVID jab.²² Both Gates and Wellcome are part of the technocratic globalist network that is pushing The Great Reset forward.

Another sponsor was Georgetown University,²³ which also curated the World Economic Forum’s library of COVID-19 treatments (primarily focused on antivirals and COVID gene transfer injections).²⁴

Curation was done by three Georgetown University professors and Rebecca Katz, director of the Georgetown Center for Global Health Science and Security.²⁵ Katz is also listed as an author on the NTI paper,²⁶ “A Spreading Plague: Lessons and Recommendations for Responding to a Deliberate Biological Event,” published June 2019, in which they review the conclusions reached from that February 2019 exercise.

'A Spreading Plague'

Together, these two pandemic exercises – both of which were sponsored by Gates – form a playbook for how to set up a biological attack and then hide the truth from the world so that you can not only profit from it in the short term but also centralize power, permanently transfer wealth and change the social and financial order to your own liking in the process.

Not surprisingly, a number of Event 201 participants also partook in the NTI's exercise,²⁷ and hold positions within technocratic institutions like Wellcome, the WHO and the World Economic Forum.

Event 201, in particular, focused not on finding remedies and saving lives, but how to control "misinformation." A vast majority of that exercise centered around the creation of effective propaganda and censorship. Similarly, "A Spreading Plague" also includes the recommendation to enlist private companies as "assets" to carry out the globalists bidding:²⁸

"In 2019 and 2020, international organizations, including the WHO, UNODA [United Nations Office for Disarmament Affairs], and the World Economic Forum, should convene private sector companies to identify gaps and concrete next steps to strengthen the capability of companies to provide assets to assist with international response for deliberate biological attacks and other high-consequence biological events."

In the NTI scenario – in which a fictional country called Carta is found to have engineered and released a biological weapon into the neighboring country of Vestia – we also see curious parallels to current-day accusations by Russia, which claims biological weapons research was being conducted in the Ukraine, necessitating defensive action.

All in all, the NTI tabletop exercise only adds to the evidence pile that suggests the COVID pandemic was premeditated and preplanned for financial and geopolitical purposes. It was a power grab.

The pandemic treaty with the WHO is precisely what the World Economic Forum and its allies now need, as it will put the technocratic cabal firmly in charge of the biosecurity of the whole world, and empower them to implement the rest of The Great Reset agenda.

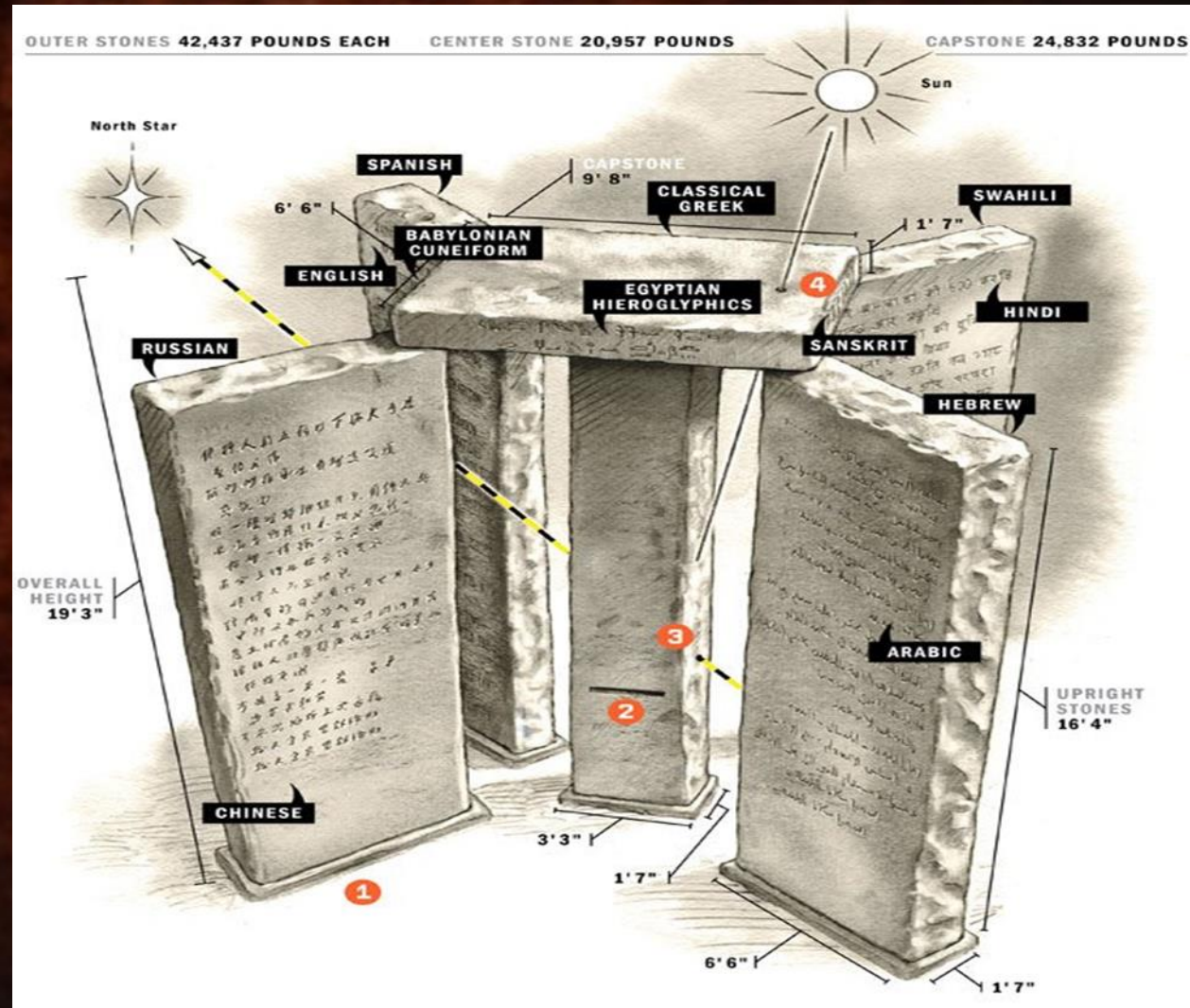

Before we can delve into the mystery of the Guidestone's origins, let us first understand exactly what the Guidestones are. Erected in 1980, under aforementioned mysterious conditions, by the Elberton Granite Finishing Company, the Guidestones are located at the highest point in Elberton County and are technically owned by the County itself.

With foundations included, the monument stands almost twenty feet tall, and is made up of four slabs surrounding one in the center, with a capstone placed on top of them. Another tablet lays set in the ground to the direct west of the main structure.

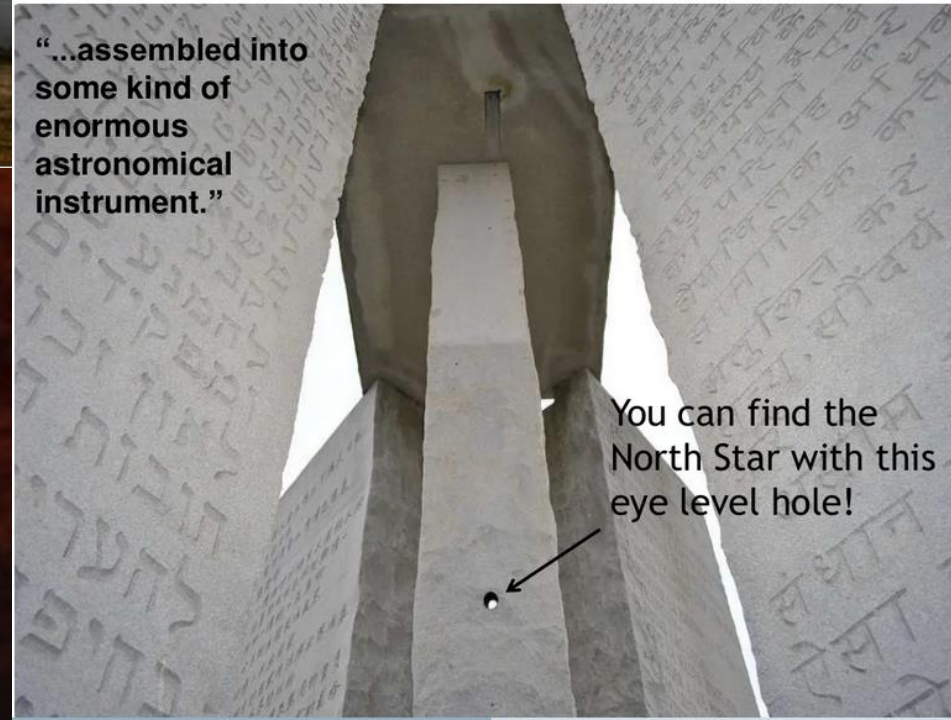
The size and structure, and in fact almost everything about the guide stones seems to have some significance, but what's written on them is the most important thing.

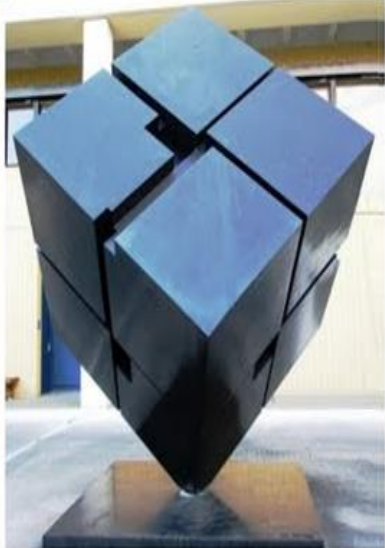

Each face of the vertical stones contains a list of what appear to be guidelines for society, written in one of eight languages (English, Spanish, Swahili, Hindi, Hebrew, Arabic, Chinese, and Russian) with a smaller message, “**Let these be guidestones to an Age of Reason**” written on the sides of the capstone in four ancient languages (Babylonian, Classical Greek, Sanskrit, and Egyptian Hieroglyphs). The guidelines inscribed on the main stones are:

THE TOP 2 IS DEPOPULATION AND CONTROL OVER THE REMAINING

1. Maintain humanity under 500,000,000 in perpetual balance with nature.
2. Guide reproduction wisely — improving fitness and diversity.
3. Unite humanity with a living new language. **DIGITAL?**
4. Rule passion — faith — tradition — and all things with tempered reason.
5. Protect people and nations with fair laws and just courts.
6. Let all nations rule internally resolving external disputes in a world court.
7. Avoid petty laws and useless officials.
8. Balance personal rights with social duties. **SOCIALISM FOR THE GOOD OF THE COLLECTIVE**
9. Prize truth — beauty — love — seeking harmony with the infinite.
10. Be not a cancer on the Earth — Leave room for nature — Leave room for nature.

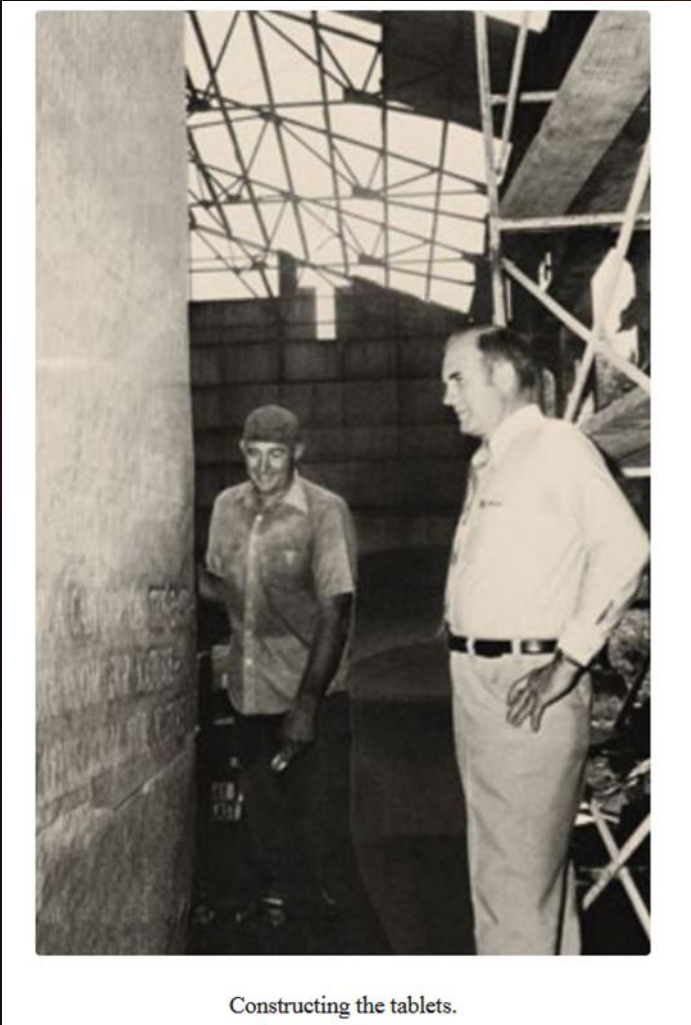
1. Channel through stone indicates celestial pole. 2. Horizontal slot indicates annual travel of sun. 3. Sunbeam through capstone marks noontime throughout the year. Another inscription indicates plans for a time capsule that has not yet been planted. The ground layed tablet also includes the source of the guidestones greatest mysteries : Two inscriptions, one reading “Sponsors: **A small group of Americans who seek the Age of Reason.**”, and another reading “Author: R.C. Christian (a pseudonym)” [sic].

The tablet that sits on the ground to the west contains information such as the date the structure was erected (March 22, 1980), it's dimensions and weight, once again the message of, “Let these be guidestones to an Age of Reason”, and a list of “Astronomic Features” –SEE ABOVE



The mystery of the Georgia Guidestones begins in the offices of Elberton Granite Finishing, where on a summer day in 1979, a well dressed older gentleman, who no one in Elberton had ever laid eyes on before, walked in and had an interesting project for company president Joe Fendley: a large astronomically aligned structure consisting of stones larger than any that had been quarried in the county before, and cut to very exact specifications.

The mystery man called himself R.C. Christian, and claimed that he represented a “small group of loyal Americans.” Of course, Fendley was taken aback by the huge undertaking that had just crossed his desk, so he asked the question that is still being asked to this day: What’s the purpose of the structure? Christian’s answer, although not exact, shed some of the only light on the mystery that we have to this day.



He said the structure would serve as a compass, a calendar, and a clock, that it would be engraved with a set of guides in eight of the world's major languages, and most tellingly, that it would have to be capable of withstanding any major catastrophic event, so that what remained of society after such an event, would be able to use those guides to rebuild a society better than the one that they had survived.

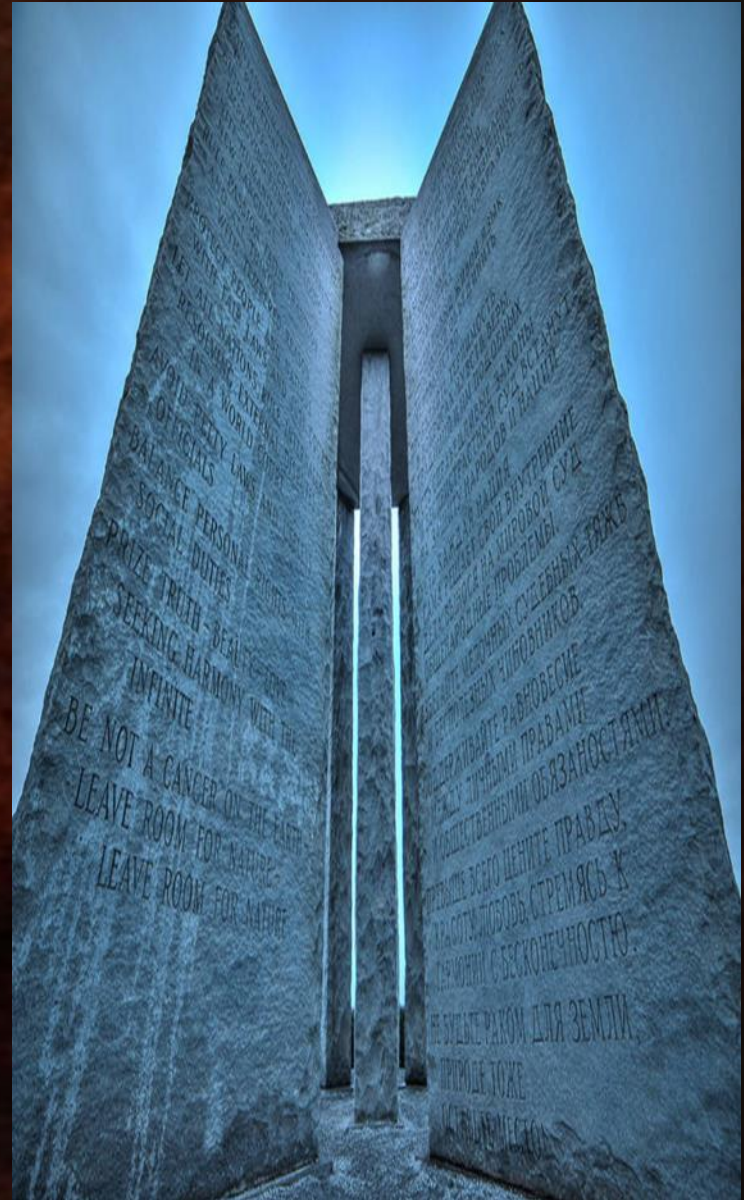
Thinking that Christian was nothing more than a nutcase with a well practiced schtick, Fendley attempted to deflect him by explaining that he couldn't take on such a project without a guarantee that it would be funded.

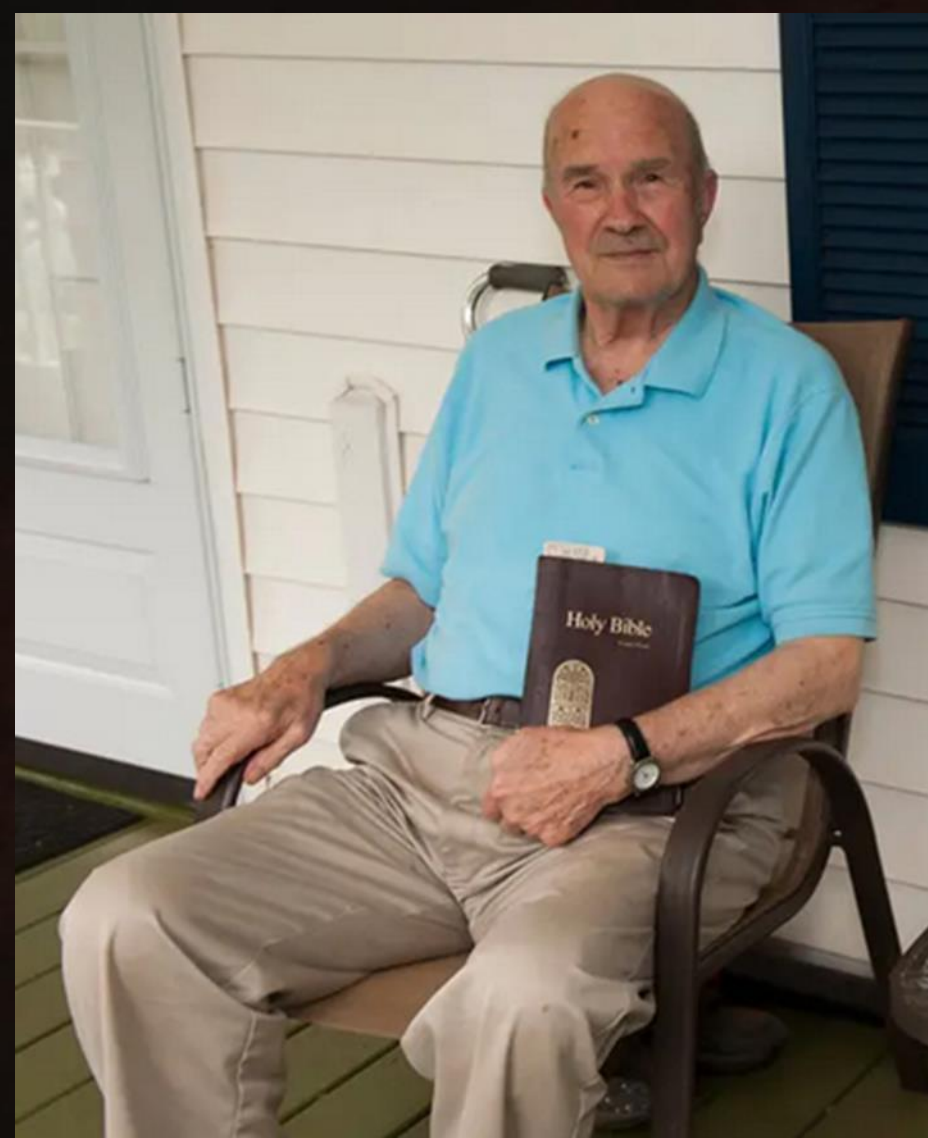
In response, Christian requested that he be sent to the most trustworthy banker that Fendley knew. Fendley sent him to local Bank President, Wyatt Martin, a man who would come to know R.C. Christian better than anyone else on record.

Just like Fendley before him, Martin thought at first that Christian was a crazy person, but his fancy suit and well spoken demeanor soon began to sway his opinion of his new client, and he was intrigued and even further drawn in when Christian admitted that his name was merely a pseudonym.

Soon after their first meeting, the two would agree that Martin would be privy to Christian's real name and info for legal purposes, but that he would sign an agreement to never share what he knew, and that he would serve as an intermediary for Christian in all matters concerning the Guidestone's construction from then on.

Shortly after, as money for the Guidestones started coming in from banks all over the country (Christian did this to insure that his identity couldn't be traced) Martin and Fendley helped Christian secure the land for his project, and with that, the construction and eventual existence of the Guidestones was set in stone (no pun intended.)

Fendley saw Christian just one more time,⁴⁶ as he came by the office to drop off specifications and a model for the project, leaving without even shaking the granite man’s hand; only saying, “You’ll never see me again” as he walked out. He wasn’t lying; Fendley, and for that matter nobody in Elberton, would ever see R.C. Christian again, except for **Wyatt Martin**.

The story doesn’t end with the Guidestone’s going up (which they did in March of 1980), or with Christian eventually signing over the land that housed the stones to the county (he suspected, rightfully since they still stand to this day, that civic pride would insure the stones stay up).

It seems that one of the most mysterious things about these apparent guidelines for humanity’s rebirth **is who exactly R.C. Christian is.**

The main clues we have as to his identity are a stone sculpture of suspect origin and the memories of an old friend; who this evidence points to will surprise you.

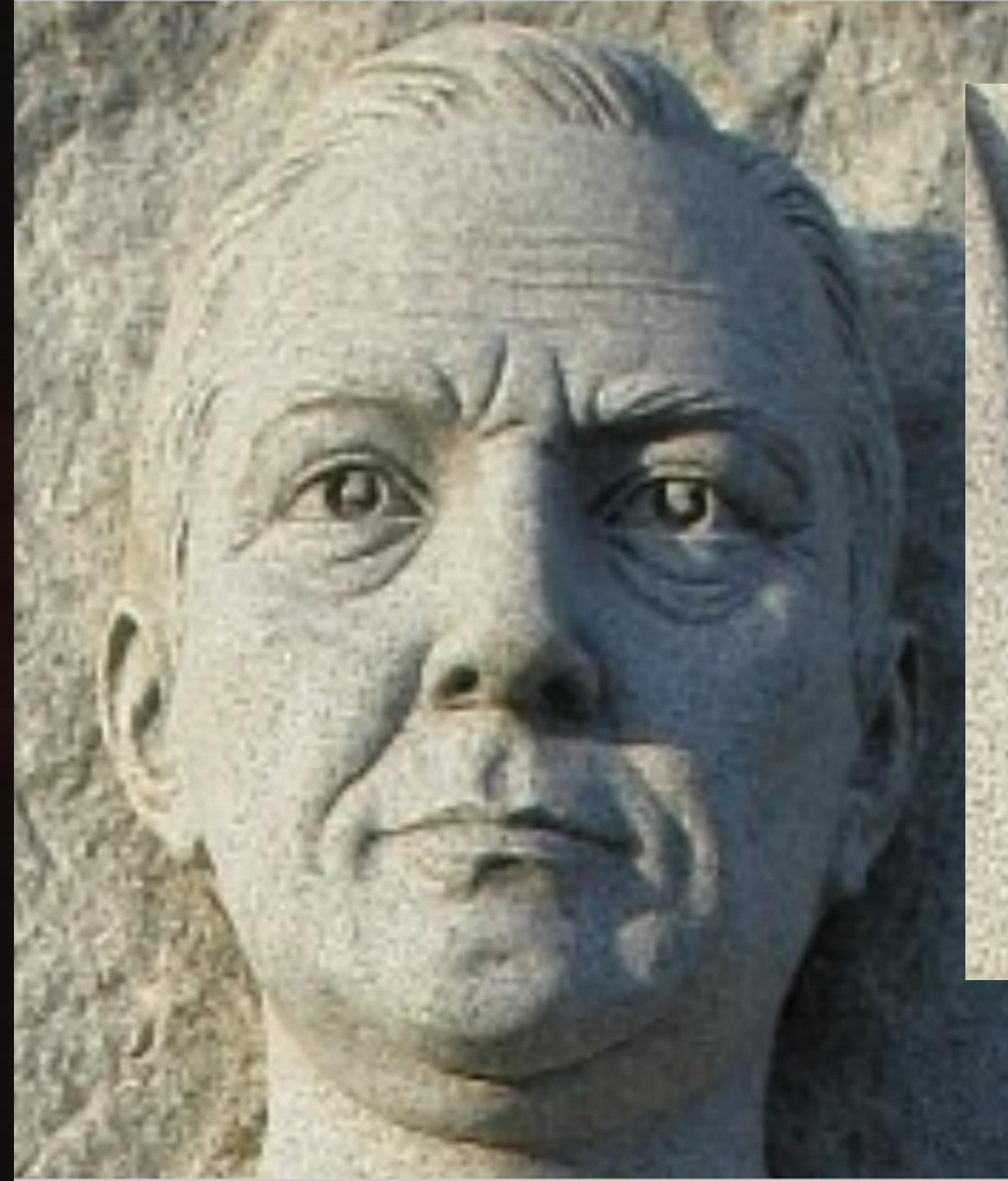
It is entirely possible that the face of R.C. Christian stares down at the residents of Elberton County, Georgia every day. Alongside the Elberton Country Civic Center sits a granite bust supposedly depicting former President Franklin D. Roosevelt.

However, the bust was destroyed in 1995 and upon reconstruction took on a form that looks nothing like FDR. Many think that the new bust whose subject wears a suit and tie adorned with strange symbols is the work of R.C. Christian and may in fact be a depiction of the man himself or one of his associates.

In December 1793, he was arrested and was taken to Luxembourg Prison in Paris. While in prison, he continued to work on *The Age of Reason* (1793–1794). James Monroe, a future President of the United States, used his diplomatic connections to get Paine released in November 1794. Paine became notorious because of his pamphlets. *The Age of Reason*, in which he advocated deism, promoted reason and free thought and argued against institutionalized religion in general and Christian doctrine in particular. He published the pamphlet *Agrarian Justice* (1797), discussing the origins of property and introduced the concept of a guaranteed minimum income through a one-time inheritance tax on landowners. In 1802, he returned to the U.S. When he died on June 8, 1809 only six people attended his funeral as he had been ostracized for his ridicule of Christianity.^[8]

When a columnist writes, readers write back, but reason often is lacking

Usually the mail from readers refers to my work in such endearing terms as "worst jumble of garbage that I have ever seen in print." Or, "If you know so much about everything, why aren't you God?"

Occasionally, a stray compliment wends its way through the Postal Service. More rarely, a reader tattoos a cogent argument on my skull while feigning agreement with something I wrote.

An Iowa physician, Herbert H. Kersten of Fort Dodge, reacted to my attack on those who attribute base sentiments to anyone who wants to solve America's problems first. He lulled me into dropping my guard. He said I correctly suggested it is not wrong to be patriotic.

Then, wham! He threw in the incendiary names of Patrick Buchanan and David Duke, contending they are among the few public figures who speak for

American interests "in this new era of internationalism." Duke, he said as my skin crawled, "voices many beliefs held by reasonable Americans. It is unfortunate that more acceptable public figures are not pushing similar views."

The rest of Dr. Kersten's letter supported protection of American workers, criticized job quotas and outlined why he thinks there should be strict limits on immigration — because our environment, work force and education system can't absorb more people. He urged America to help other nations to help themselves, but not to shoulder the world's burdens.

Although his argument was marred by a shouting tone conveyed by endless exclamation points and underlined words, overall Dr. Kersten made a tenable case. It wasn't mean-spirited, although he came uncomfortably close at times, but I can't buy his basic statements.

Duke is cleverly tiptoeing into main-

stream thinking to attract supporters there, while reserving his unacceptable real thoughts for the bigoted fringe. Those who give Duke a place among reasonable Americans uncover their own embarrassing gullibility.

Buchanan could have argued his usual positions within the boundaries, if barely, of mainstream thinking. Instead, he showed a heavier hand than Duke, dis-

paraging ethnic and racial groups.

Buchanan is deliberately marching outside the realm of America's tolerant tradition, widely but of course not universally held, toward those who are different from the majority. New Hampshire Republicans who vote for him next week will act, I hope, out of protest against President Bush, and not because they actually agree with Buchanan.

Unlike Dr. Kersten, most of those who aim letters my way don't bother with reasoning. In response to my unflattering portrayal of Judge Mary Lupo of the William Kennedy Smith trial, a reader from Lubbock, Texas, presented this bouquet to me: "To another idiot who is mad because he isn't a Kennedy or Elvis Presley or John Wayne."

A Pompano Beach reader, though, called me "sir," said the trial was a farce and is convinced Smith was guilty of rape. I think he was, too, although the

prosecution failed to prove it, partly because of the skillful performance of defense attorney Roy Black. His reputation is crumbling fast, as reports surface of his crude remarks made subsequently about witnesses and the prosecutor.

My column suggesting Arabs are human hit a nerve. A Boca Raton reader listed examples of terrorism by various Arab extremists over the years. He did not point out examples of torture of Palestinian prisoners by the Israeli secret police. An Arab-American from High Point, N.C., said he and others like him seek "an accurate description of who we are and what our roots really represent."

A reader in Proctor, Minn., took two full pages to argue about the exact day this century will end. The year 2000, not 1999, will be the last year of the 20th Century, he insisted. That's too bad, because the way it's going, I want to get this century behind me ASAP.

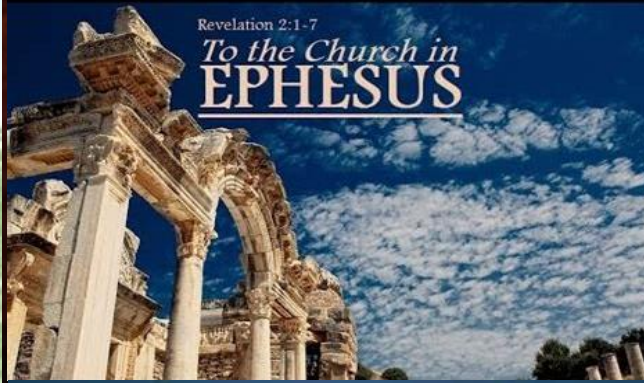
The alliance between Nazi Germany and Imperial Japan was both cause and effect of the worldwide political and economic crisis of the 1930s, as the far-right governments of the two nations felt increasingly emboldened to defy and destabilize the international system. The deepening of the Great Depression, heretofore the most severe downturn in the history of capitalism, facilitated Hitler's rise to power in Germany and the ascent of ultra-nationalists in Shōwa Japan.

Japanese imperialism and Nazism also each brandished ferocious ideologies of racial superiority. Such pretensions to mastery buttressed their plans for empire-building in East Asia and Eastern Europe. These racisms, one touting Japanese claims to lead the peoples of Asia against White, European dominance, the other resolutely pro-"Aryan," should have clashed and negated, one might think, any possibility of cooperation. Yet they did not.

VIII. THE NON-COERCIVE COUNTERINTELLIGENCE INTERROGATION

A. General Remarks

The term non-coercive is used above to denote methods of interrogation that are not based upon the coercion of an unwilling subject through the employment of superior force originating outside himself. However, the non-coercive interrogation is not conducted without pressure. On the contrary, the goal is to generate maximum pressure, or at least as much as is needed to induce compliance. The difference is that the pressure is generated inside the interrogatee. His resistance is sapped, his urge to yield is fortified, until in the end he defeats himself.

Manipulating the subject psychologically until he becomes compliant, without applying external methods of forcing him to submit, sounds harder than it is. The initial advantage lies with the interrogator. From the outset, he knows a great deal more about the source than the source knows about him. And he can create and amplify an effect of omniscience in a number of ways. For example, he can show the interrogatee a thick file bearing his own name. Even if the file contains little or nothing but blank paper, the air of familiarity with which the interrogator refers to the subject's background can convince some sources that all is known and that resistance is futile.

If the interrogatee is under detention, the interrogator can also manipulate his environment. Merely by cutting off all other human contacts, "the interrogator monopolizes the social environment of the source." (3) He exercises the powers of an all-powerful parent, determining when the source will be sent to bed, when and what he will eat, whether he will be rewarded for good behavior or punished for being bad. The interrogator can and does make the

subject's world not only unlike the world to which he had been accustomed but also strange in itself - a world in which familiar patterns of time, space, and sensory perception are overthrown. He can shift the environment abruptly. For example, a source who refuses to talk at all can be placed in unpleasant solitary confinement for a time. Then a friendly soul treats him to an unexpected walk in the woods. Experiencing relief and exhilaration, the subject will usually find it impossible not to respond to innocuous comments on the weather and the flowers. These are expanded to include reminiscences, and soon a precedent of verbal exchange has been established. Both the Germans and the Chinese have used this trick effectively.

The interrogator also chooses the emotional key or keys in which the interrogation or any part of it will be played.

Because of these and other advantages, "...skilled and determined interrogators are almost invariably successful in eliciting some information from their sources.... For prisoner-of-war interrogation, the figures generally given as the proportion of sources who abandon the 'name, rank, number only' rule, or other injunctions of silence, are between 95 and 100 percent...."(3)

A principal goal during the opening phase is to confirm the personality assessment obtained through screening and to allow the interrogator to gain a deeper understanding of the source as an individual. Unless time is crucial, the interrogator should not become impatient if the interrogee wanders from the purposes of the interrogation and reverts to personal concerns. Significant facts not produced during screening may be revealed. The screening report itself is brought to life, the type becomes an individual, as the subject talks. And sometimes seemingly rambling monologues about personal matters are preludes to significant admissions. Some people cannot bring themselves to provide information that puts them in an unfavorable light until, through a lengthy prefatory rationalization, they feel that they have set the stage, that the interrogator will now understand why they acted as they did. If face-saving is necessary to the interrogee, it will be a waste of time to try to force him to cut the preliminaries short and get down to cases. In his view, he is dealing with the important topic, the why. He will be offended and may become wholly uncooperative if faced with insistent demands for the naked what.

2. The Reconnaissance

If the interrogatee is cooperative at the outset or if rapport is established during the opening phase and the source becomes cooperative, the reconnaissance stage is needless; the interrogator proceeds directly to detailed questioning. But if the interrogatee is withholding, a period of exploration is necessary. Assumptions have normally been made already as to what he is withholding: that he is a fabricator, or an RIS agent, or something else he deems it important to conceal. Or the assumption may be that he had knowledge of such activities carried out by someone else. At any rate, the purpose of the reconnaissance is to provide a quick testing of the assumption and, more importantly, to probe the causes, extent, and intensity of resistance.

During the opening phase the interrogator will have charted the probable areas of resistance by noting those topics which caused emotional or physical reactions, speech blocks, or other indicators. He now begins to probe these areas. Every experienced interrogator has noted that if an interrogatee

At the same time it is necessary to make every effort to keep the subject from learning through the interrogation process precisely where our informational gaps lie. This principle is especially important if the interrogatee is following his normal life, going home each evening and appearing only once or twice a week for questioning, or if his bona fides remains in doubt. Under almost all circumstances, however, a clear revelation of our interests and knowledge should be avoided. It is usually a poor practice to hand to even the most cooperative interrogatee an orderly list of questions and ask him to write the answers. (This stricture does not apply to the writing of autobiographies or on informational matters not a subject of controversy with the source.) Some time is normally spent on matters of little or no intelligence interest for purposes of concealment. The interrogator can abet the process by making occasional notes -- or pretending to do so -- on items that seem important to the interrogatee but are not of intelligence value. From this point of view an interrogation can be deemed successful if a source who is actually a hostile agent can report to the opposition only the general fields of our interest but cannot pinpoint specifics without including misleading information.

It is important to determine whether the subject's knowledge of any topic was acquired at first hand, learned indirectly, or represents merely an assumption. If the information was obtained indirectly, the identities of sub-sources and related information about the channel are needed. If statements rest on assumptions, the facts upon which the conclusions are based are necessary to evaluation.

C. Techniques of Non-Coercive Interrogation of Resistant Sources

If source resistance is encountered during screening or during the opening or reconnaissance phases of the interrogation, non-coercive methods of sapping opposition and strengthening the tendency to yield and to cooperate may be applied. Although these methods appear here in an approximate order of increasing pressure, it should not be inferred that each is to be tried until the key fits the lock. On the contrary, a large part of the skill and the success of the experienced interrogator lies in his ability to match method to source. The use of unsuccessful techniques will of itself increase the interrogatee's will and ability to resist.

The effectiveness of most of the non-coercive techniques depends upon their unsettling effect. The interrogation situation is in itself disturbing to most people encountering it for the first time. The aim is to enhance this effect, to disrupt radically the familiar emotional and psychological associations of the subject. When this aim is achieved, resistance is seriously impaired. There is an interval -- which may be extremely brief -- of suspended animation, a kind of psychological shock or paralysis. It is caused by a traumatic or sub-traumatic experience which explodes, as it were, the world that is familiar to the subject as well as his image of himself within that world. Experienced interrogators recognize this effect when it appears and know that at this moment the source is far more open to suggestion, far likelier to comply, than he was just before he experienced the shock.

Another effect frequently produced by non-coercive (as well as coercive) methods is the evocation within the interrogatee of feelings of guilt. Most persons have areas of guilt in their emotional topographies, and an interrogator can often chart these areas just by noting refusals to follow certain lines of questioning. Whether the sense of guilt has real or imaginary causes does not affect the result of intensification of guilt feelings. Making a person feel more and more guilty normally increases both his anxiety and his urge to cooperate as a means of escape.

2. Nobody Loves You

An interrogatee who is withholding items of no grave consequence to himself may sometimes be persuaded to talk by the simple tactic of pointing out that to date all of the information about his case has come from persons other than himself. The interrogator wants to be fair. He recognizes that some of the denouncers may have been biased or malicious. In any case, there is bound to be some slanting of the facts unless the interrogatee redresses the balance. The source owes it to himself to be sure that the interrogator hears both sides of the story.

3. The All-Seeing Eye (or Confession is Good for the Soul)

The interrogator who already knows part of the story explains to the source that the purpose of the questioning is not to gain information; the interrogator knows everything already. His real purpose is to test the sincerity (reliability, honor, etc.) of the source. The interrogator then asks a few questions to which he knows the answers. If the subject lies, he is informed firmly and dispassionately that he has lied. By skilled manipulation of the known, the questioner can convince a naive subject that all his secrets are out and that further resistance would be not only pointless but dangerous. If this technique does not work very quickly, it must be dropped before the interrogatee learns the true limits of the questioner's knowledge.

4. The Informer

Detention makes a number of tricks possible. One of these, planting an informant as the source's cellmate, is so well-known, especially in Communist countries, that its usefulness is impaired if not destroyed. Less well known is the trick of planting two informants in the cell. One of them, A, tries now and then to pry a little information from the source; B remains quiet. At the proper time, and during A's absence, B warns the source not to tell A anything because B suspects him of being an informant planted by the authorities.

Suspicion against a single cellmate may sometimes be broken down if he shows the source a hidden microphone that he has "found" and suggests that they talk only in whispers at the other end of the room.

5. News from Home

Allowing an interrogatee to receive carefully selected letters from home can contribute to effects desired by the interrogator. Allowing the source to write letters, especially if he can be led to believe that they will be smuggled out without the knowledge of the authorities, may produce information which is difficult to extract by direct questioning.

Regression

There are a number of non-coercive techniques for inducing regression. All depend upon the interrogator's control of the environment and, as always, a proper matching of method to source. Some interrogatees can be repressed by persistent manipulation of time, by retarding and advancing clocks and serving meals at odd times -- ten minutes or ten hours after the last food was given. Day and night are jumbled. Interrogation sessions are similarly unpatterned the subject may be brought back for more questioning just a few minutes after being dismissed for the night. Half-hearted efforts to cooperate can be ignored, and conversely he can be rewarded for non-cooperation. (For example, a successfully resisting source may become distraught if given some reward for the "valuable contribution" that he has made.) The Alice in Wonderland technique can reinforce the effect. Two or more interrogators, questioning as a team and in relays (and thoroughly jumbling the timing of both methods) can ask questions which make it impossible for the interrogatee to give sensible, significant answers. A subject who is cut off from the world he knows seeks to recreate it, in some measure, in the new and strange environment. He may try to keep track of time, to live in the familiar past, to cling to old concepts of loyalty, to establish -- with one or more interrogators -- interpersonal relations resembling those that he has had earlier with other people, and to build other bridges back to the known. Thwarting his attempts to do so is likely to drive him deeper and deeper into himself, until he is no longer able to control his responses in adult fashion.

The placebo technique is also used to induce regression. The interrogatee is given a placebo (a harmless sugar pill). Later he is told that he has imbibed a drug, a truth serum, which will make him want to talk and which will also prevent his lying. The subject's desire to find an excuse for the compliance that represents his sole avenue of escape from his distressing predicament may make him want to believe that he has been drugged and that no one could blame him for telling his story now. Gottschelk observes, "Individuals under increased stress are more likely to respond to placebos." (7)

In other words, a psychologically immature source, or one who has been regressed, could adopt an implication or suggestion that he has been drugged, hypnotized, or otherwise rendered incapable of resistance, even if he recognizes at some level that the suggestion is untrue, because of his strong desire to escape the stress of the situation by capitulating. These techniques provide the source with the rationalization that he needs.

Whether regression occurs spontaneously under detention or interrogation, and whether it is induced by a coercive or non-coercive technique, it should not be allowed to continue past the point necessary to obtain compliance. Severe techniques of regression are best employed in the presence of a psychiatrist, to insure full reversal later. As soon as he can, the interrogator presents the subject with the way out, the face-saving reason for escaping from his painful dilemma by yielding. Now the interrogator becomes fatherly. Whether the excuse is that others have already confessed ("all the other boys are doing it"), that the interrogatee has a chance to redeem himself ("you're really a good boy at heart"), or that he can't help himself ("they made you do it"), the effective rationalization, the one the source will jump at, is likely to be elementary. It is an adult's version of the excuses of childhood.
