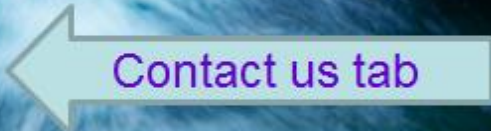
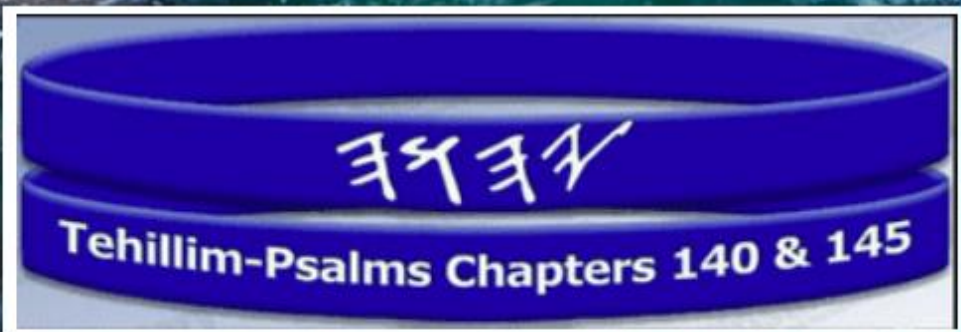

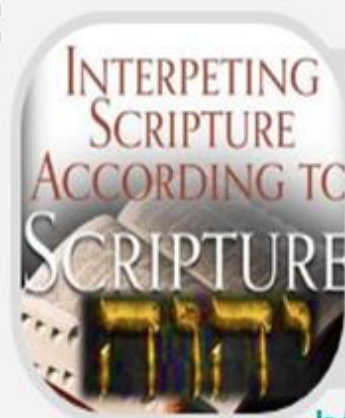

Moshe- approximately 1440 BC

- ❖ A Hebrew who grew up in great wealth and raised in the Egyptian Palace.
- ❖ Escaped may assignation attempts
- ❖ Was a tall man
- ❖ A leader of armies
- ❖ A man with a temper and a physical speech impediment
- ❖ A man who lived in both worlds. An insider with connections.
- ❖ A man who was not a separatist. Offered the opportunity of freedom to anyone who wanted to come with him.
- ❖ A man whose family members were given great status in the community
- ❖ Was pitted against a highly organized, oppressive and massive ruling system
- ❖ A man who was routinely criticized for his decisions by other leaders of his own people and the mixed multitude as he led the people according to Yahuah's instructions.
- ❖ Ended the slavery of his people.
- ❖ Restored a unity to the 12 tribes of Yah'shara'al.

Gideon- 1252-1152BC

- ❖ He was a military leader, judge and prophet whose calling and victory over the Midianites
- ❖ Yah'shara'al was oppressed by Midian for seven years until he defeated Midian's armies.
- ❖ He was confused and questioned why Yahuah had abandoned his people, but later trusted Yahuah and obeyed.
- ❖ The Midianites, a nomadic and huge group of people who depleted Yah'shara'al's supplies.
- ❖ He brings 32,000 men as an army to take on the enormous Midianite army.
- ❖ He makes Gideon send home anyone who is afraid.
- ❖ After another test leaving just 300 men, Gideon knows he has to rely on Yahuah to provide a miracle.
- ❖ Yahuah has an even odder plan in place. They won't even have to invade or attack to wipe out the Midianites. He has them create as much noise as possible by blaring trumpets and smashing jars.
- ❖ Confused the men in the Midianite camp end up killing each other in the chaos.
- ❖ He has become symbolic of a military success of a small elite force against overwhelming numerical odds.
- ❖ He survived his glorious victories and Yah'shara'al had peace 40 years,
- ❖ He died at a great age and was mourned by a grateful nation.

- ❖ He marshaled military forces to fight the Ammonites, Edomites, Moabites, Amalekites and Philistines.
- ❖ Was very charismatic.
- ❖ His Family was put in high places
- ❖ He was put into power after progressive moral corruption of the Israelites and their leaders (Judges)
- ❖ This was a period of political and social upheaval
- ❖ Yah'shara'al was looking for a saviour who could end the strife that had marred their nation's landscape for generations.
- ❖ He united the scattered tribes, giving them greater strength. He reigned for 42 years.
- ❖ He was courageous in battle.
- ❖ He was a generous king. Early in his reign he was admired and respected by the people.
- ❖ Made lots of mistakes - Had a very large ego
- ❖ Had a thirst for revenge
- ❖ Was successful in his mission for Yahuah at great cost to himself and family.

King Cyrus - 1st King of Yah'shara'al - 590-529 BC

- ❖ Came from Persian Royalty
- ❖ Many assassinations attempts including as a baby-His father ordered him killed after a dream.
- ❖ Was given away to a shepherd to raise
- ❖ He is known for his innovations in building projects; he further developed the technologies that he found in the conquered cultures and applied them in building the palaces of Pasargadae.
- ❖ A brilliant military strategist, he vanquished the king of the Medes, then integrated all the Iranian tribes, whose skill at fighting on horseback gave his army great mobility.
- ❖ His Family was put in high places
- ❖ United the Iranian people under one ruler for the first time.
- ❖ Became the first king of the Persian Empire and went on to establish one of the largest empires in the world.
- ❖ He reigned for 30 years.
- ❖ He was tolerant and magnanimous as well as brave and daring.
- ❖ He was a generous king. Early in his reign he was admired and respected by the people.
- ❖ He knew the name of Yahuah and the prophecy that was written about him by name 140 years before he was born.
- ❖ In the first year of his reign he was prompted by Yah to decree that the Temple in Jerusalem should be rebuilt and that such Jews as cared to might return to their land for this purpose.
- ❖ "I will raise up Cyrus in My righteousness: I will make all his ways straight. He will rebuild my city and set my exiles free, but not for a price or reward, says Yahuah Almighty." Isaiah 45:13

Yahuah Has Patterns When He Chooses Leaders



King Cyrus -1st King of Yah'shara'al - 590-529 BC

- ❖ He treated the people he conquered equally by letting them practice their religion and let them speak their own language. The Jews did not rebel against him and praised him as the "chosen one".
- ❖ He freed the slaves and established racial equality.
- ❖ The **Cyrus Cylinder** is the first recognition that if you're going to run a society with different languages/beliefs, you cannot impose **by force** one system." This system proved so successful that his dynasty lasted for 200 years.
- ❖ He was held in high esteem, not only by his own people, the Persians, but by the Greeks and others
- ❖ He was not only a great conqueror and administrator; he held a place in the minds of the Persian people similar to that of Romulus and Remus in Rome or Moses for Yah'shara'al.
- ❖ Isaiah 45:1 Yahuah anointed Cyrus for this task, even referring to him as a messiah (lit. 'anointed one') and he is the only non-Jewish figure in Scripture to be called this.
- ❖ He has played a crucial role in defining the national identity of modern Iran
- ❖ The forefathers of the United States of America sought inspiration from Cyrus the Great through works such as *Cyropaedia*. Thomas Jefferson, for example, owned two copies of *Cyropaedia*, one with parallel Greek and Latin translations on facing pages showing substantial Jefferson markings that signify the amount of influence the book has had on drafting the United States Declaration of Independence.
- ❖ Was successful in his mission for Yahuah at great cost to himself and family.

The Persian Empire entered a period of decline after a failed invasion of Greece by Xerxes I in 480 BC.

The costly defense of Persia's lands depleted the empire's funds, leading to heavier taxation among Persia's subjects. While the leader is successful in the mission, he may not always be successful in his relationship with Yahuah.

Taking A Deeper Look- Then and Now



Since the pattern of our back sliding is repeated over and over, the necessity for Yahuah to allow oppression of His people has been the pattern of the temporary remedy. As Yahusha brilliantly explained in his parable of the Wheat and the Tares, the two grow up together. You cannot just pull up the tares too soon or you will sacrifice some of the wheat nearby. When the time of harvest is near, the tares will out themselves. Of course Yahusha was talking about the end time, but the lesson in how to deal with this situation before then, is priceless. Yahuah established how justice was to be carried out. We do not have to wait till the end of time to see it played out.

The Parable of the Wheat & Weeds confirms that nothing surprises Yahuah. He does have a plan for this world and He is working to accomplish it. He “sees” what the evil one has done. However it is unfolding over time and that means there's some waiting to do. Something we find difficult. Yahusha is showing us the art of patience. TARES Look IDENTICAL To WHEAT



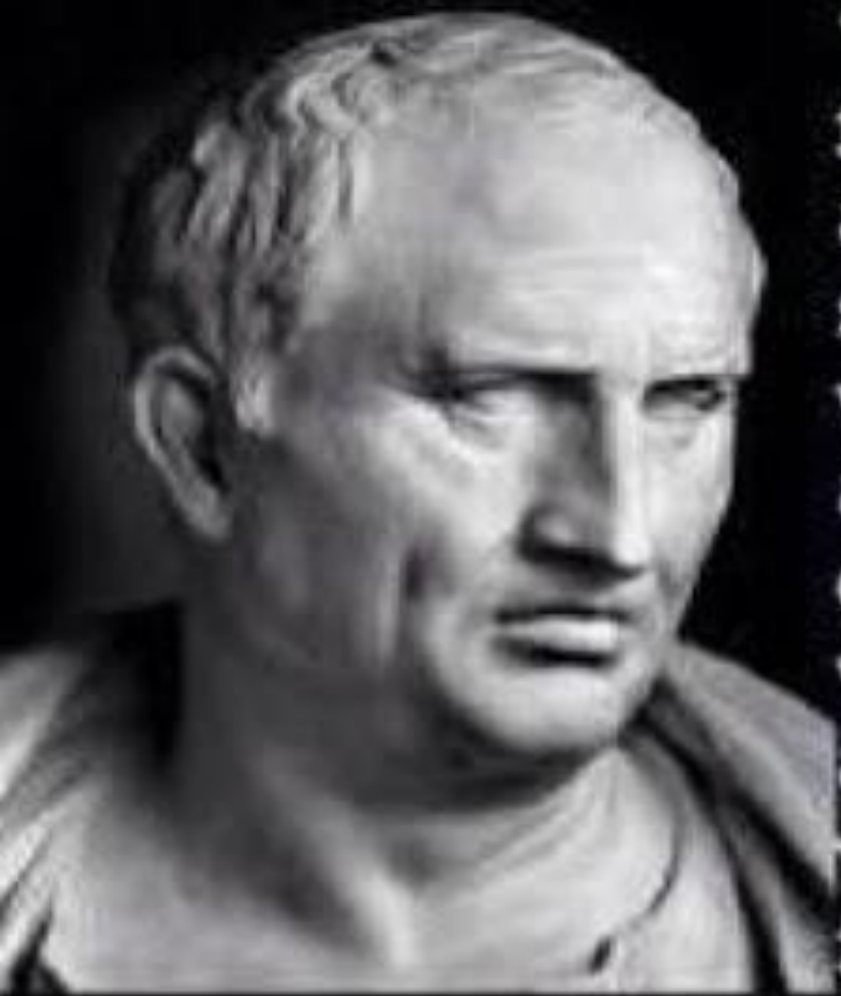
WHEAT: before it is fully ripe.

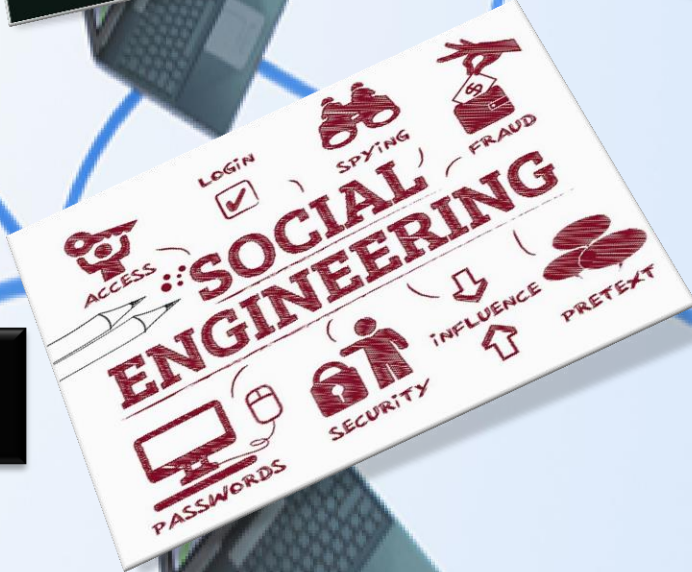

The book of Judges proves that.

June 27, 2005

A sharply divided Supreme Court on Monday **upheld the constitutionality of displaying the Ten Commandments on government land**, but drew the line on displays inside courthouses, saying they violated the doctrine of separation of church and state.

The rulings were the court's first major statement on the Ten Commandments since **1980**, when justices barred their display in public schools. But the high court's split verdict leaves somewhat unsettled the role of religion in American society, a question that has become a flashpoint in U.S. politics.

Dissenting in the Texas case, Justice John Paul Stevens argued the display was an improper government endorsement of religion. Stevens noted in large letters the monument proclaims 'I AM the LORD thy God.'

"The monument is not a work of art and does not refer to any event in the history of the state," Stevens wrote. **"The message transmitted by Texas' chosen display is quite plain: This state endorses the divine code of the Judeo-Christian God."**



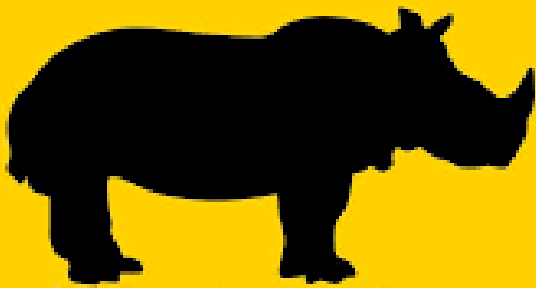

The Ten Commandments memorial at Bloomfield City Hall in Bloomfield, N.M. The U.S. Supreme Court on Monday sided with a lower court, the 10th US Circuit Court of Appeals, that ordered Bloomfield to remove the monument. A concrete block that displays the Ten Commandments sits alongside other monuments related to the Declaration of Independence, Gettysburg Address, and Bill of Rights.

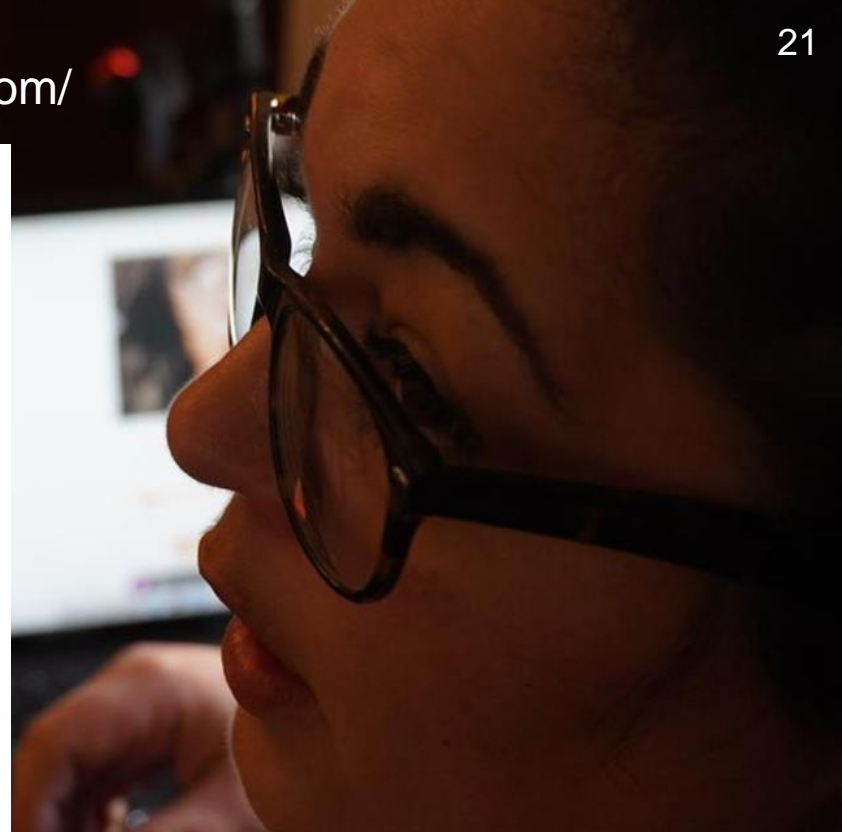

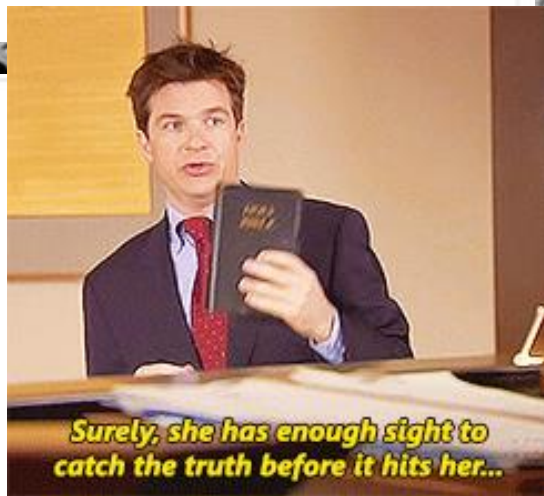

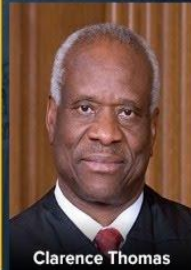

FUN FACT: Like the Associate Justices, the Chief Justice is appointed by the President and confirmed by the Senate. There is no requirement that the Chief Justice serve as an Associate Justice, but 5 of the 17 Chief Justices have served on the Court as Associate Justices prior to becoming Chief Justice. Justices are appointed for life **“during good behavior.”** **The only way to remove a Chief Justice is through the impeachment process,** which has happened once in all the years, and that was in 1805 to Associate Justice Samuel Chase.

We have already seen the tares in the Supreme Court. There will be more when their time of testing comes. How many are set firmly in the Constitution? Are they light weights- to be blown away by the winds of PC?

Keep watching. You will be surprised who folds. Thomas is Awesome, Alito is great but the rest are problematic.

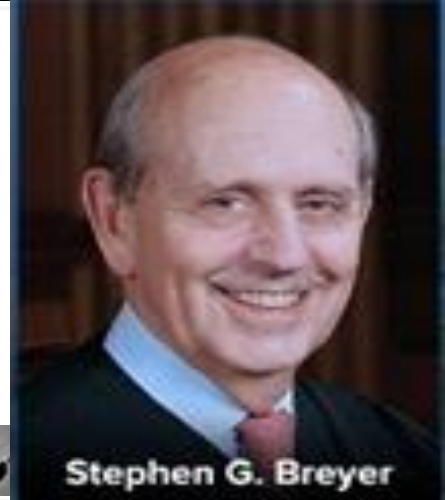

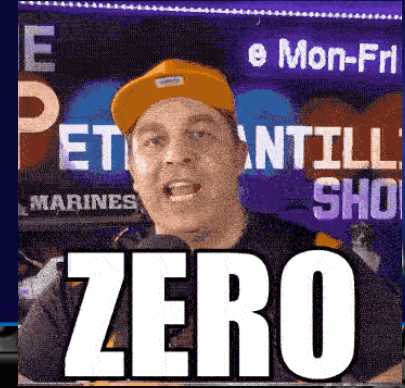
Gideon and Yahuah dealt with the tares who were sown in.

What is 4d chess? ^

The term 3D stands for third dimension, while **4D** includes “time” plus the three spatial dimensions. **5D chess** boldly claims to go even beyond that as it mixes **chess**, as we know it, with a multiverse time-travel function. And this is where my mind starts to go a bit crazy! Jul 31, 2020

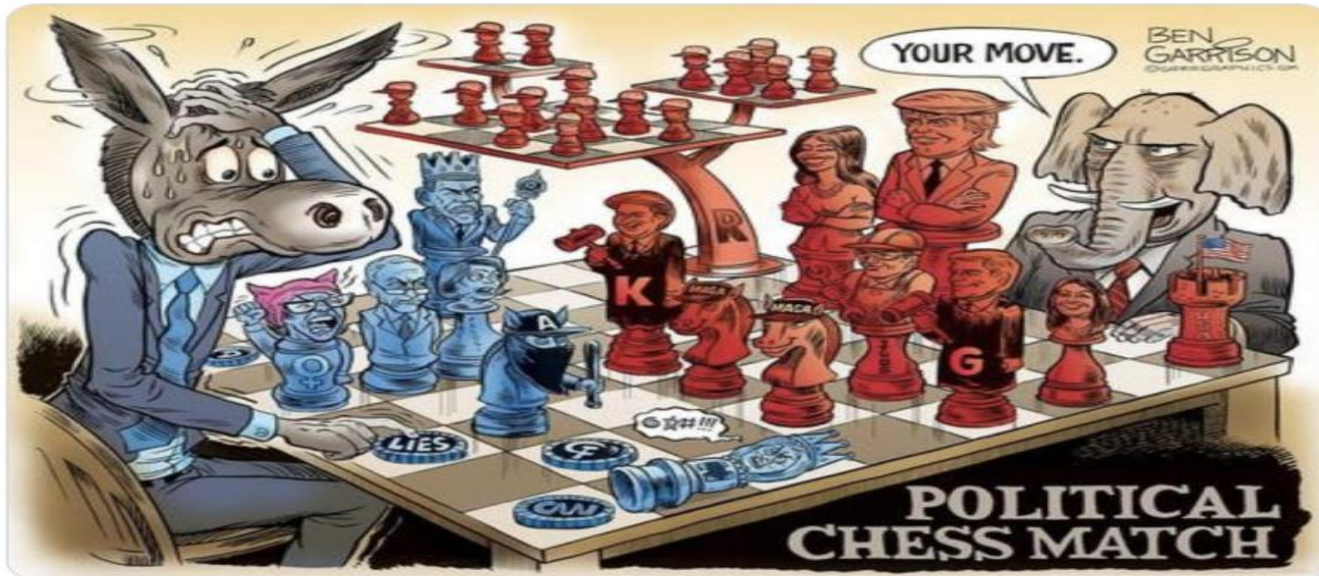
4D, meaning the 4 common dimensions, is an important idea in physics referring to three-dimensional space (3D), which adds the dimension of time to the other three dimensions of length, width, and depth.

The short of it is this: in higher dimensions, it gets rapidly harder to win, but rapidly easier to not lose. So adding dimensions turns symmetric games into asymmetric games: people who want to win get weaker. People who just want to keep playing get stronger. Ineffective players try to "win" in some finite sense. Effective ones try to goad opponents into going for the clear win, while making sure they simply stay in the game and don't lose. This should remind you of guerrilla warfare.

Asymmetric Game Regimes

Let's talk about war for a bit, though not all higher-dimensional games map to war.

Over the past century, war has gotten more asymmetric as it's gotten higher dimensional. World War I, with weak air power and primitive tanks was all about the highly symmetric condition of attrition warfare. World War 2, where air power reigned supreme and advanced tanks combined with motorized infantry to enable the Blitzkrieg model, was less symmetric. Vietnam, where complex political dimensions and the global Cold War backdrop entered the equation, was strongly asymmetric. And by the time we get to Iraq and Afghanistan, there is no meaningful definition of winning, but there is a definition of losing: getting into nation-building and failing. And today we are in the age of cyberwarfare, which is so highly asymmetric, a small team of state-sponsored hackers could use the NotPetya ransomware to bloodlessly bring huge multi-national corporations to their knees and cause billions of dollars of damage.

During this evolution, war went from stylized conflict with rules derived from honor codes, to a pattern of "total war" with no rules, to a blurring of lines between war and peace, to software eating war.

One interesting effect was that military objectives for typical pairs of adversaries diverged. As Henry Kissinger noted, "the conventional army loses if it does not win, the guerrilla wins if he does not lose". The asymmetry lies not just in the relative weakness of the guerrilla, but *in the fact that the conventional army is compelled by doctrine and tradition to try and "win."* The guerrilla is more powerful in being doctrinally enabled to fight for a less conventionally honorable outcome. There is, in a way, a higher-level symmetry here. The guerrilla army is weaker in terms of resources but stronger in terms of doctrinal freedom of action.


Chess models conventional warfare, where both sides share a win condition: checkmate. If you do not achieve checkmate, you either lose, or you end up in a "draw." But note that outside the formal rules of the game, a draw in chess is in a sense a loss for the party with lower endurance (for example, if you didn't recognize the inescapable draw condition and continued a futile, infinite, trivial end game until your frustrated opponent conceded just to get on with their life).

This kind of "draw" of course, is analogous to the long, terrible trench warfare stalemate of WW I.

So the popular theory of Trump playing 4d chess is both right and wrong. Yes he's playing 4d chess effectively. No, it is not by employing a naively "sophisticated" 4d strategy and thinking on more levels and further out than his adversaries. He's been doing it the theoretically sound way: by trying not to lose, like Data or the Vietcong. In higher dimensions, sophisticated naïveté eats naive sophistication for lunch.

In algorithmic terms, Trump adopted a low-complexity, highly randomized "algorithm" that had only a few key elements: pushing buttons, baiting and name-calling, distracting from negative attention by stoking new controversies, and simply adding more complexity/dimensionality to the game itself, by opening up new fronts constantly. As he himself noted once, "anything that makes things more complicated, I do." This is an excellent folk articulation of the principle that adding dimensions hurts the player going for the explicit win more.





Viewed in the light of 4d chess, the US political system is in fact set up for such asymmetry. In a formal sense, the 2016 election ended in a draw of sorts: Hillary won the popular vote while Trump won the electoral college vote. The system translated this outcome into a loss for the stronger side: the one capable of winning the popular vote. The US system is a 4d chess board compared to simpler political systems.

The electoral college system is not designed to allow less populous states to win; it is designed to ensure they stay in the game. The "game" here isn't the narrow electoral game, but the story of America itself. This broader game is set up to ensure political power, once gained, is not lost as easily as economic or cultural power.

Is this a good design? Depends on what you care about. Arguably, in something like a unicameral parliamentary system with true proportional representation, the Trump "base" would have been electorally wiped out and lost all political power over the last 30 years. The system worked as designed, acting as a check against a potential tyranny of the majority, and keeping the minority political interest alive in the game. For now.



Protecting against the tyranny of the majority is an important principle to follow in general, whatever the bugs of a specific design or your issues with a particular minority political ideology.



So how do you play to not lose at 4d chess?

Simplify your actions, increase your randomness, complicate the game for the adversary, and try to stay alive.

And perhaps the most paradoxical principle, to win you have to avoid *trying* to win.

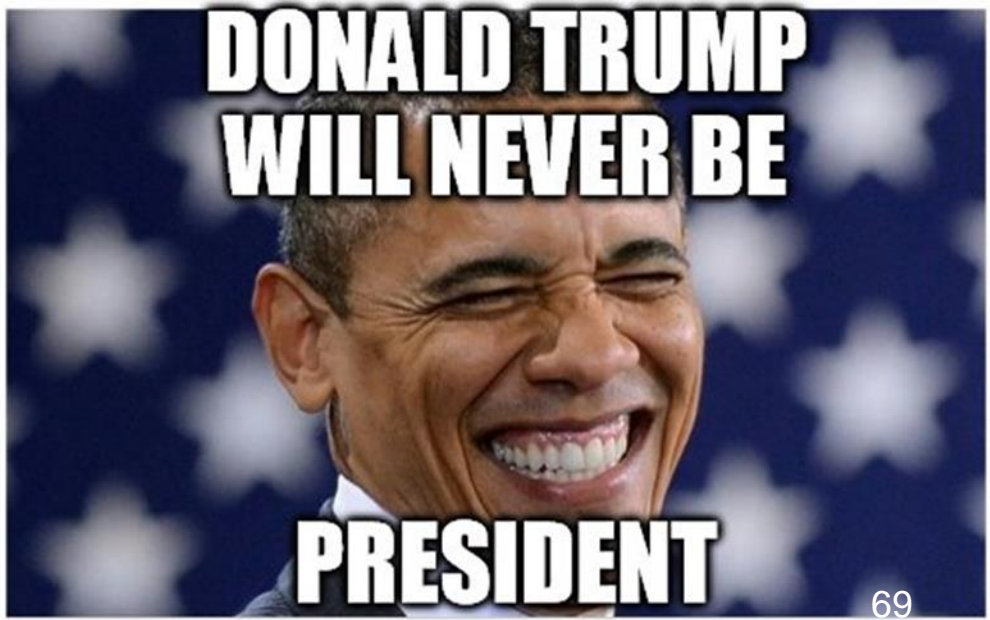

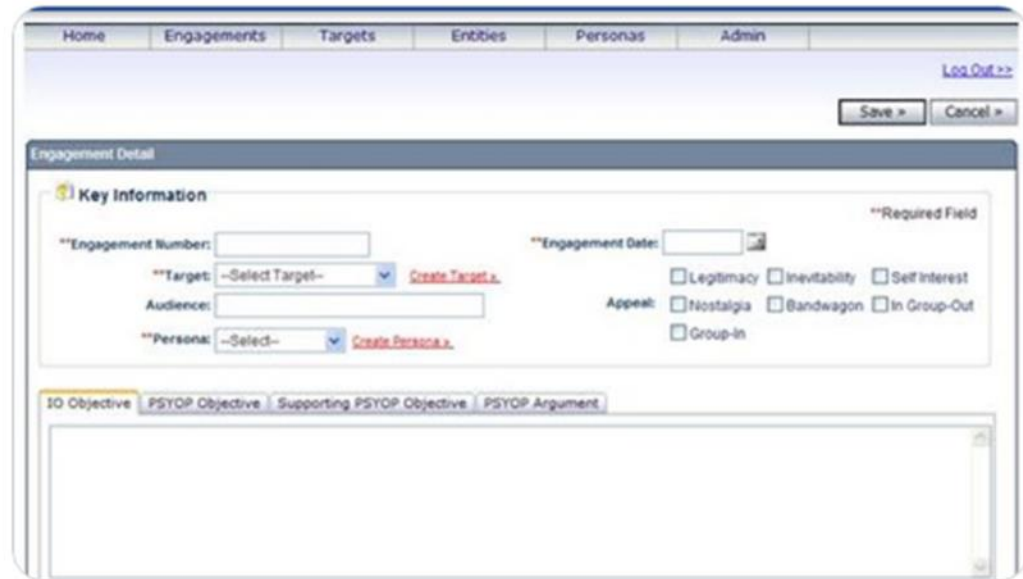

Time for New Look at 2008 Obama Passport Breach

The light of truth!



Among the unexpected findings of the Sheriff Arpaio cold case was this one:

Records of Immigration and Naturalization Service cards filled out by airplane passengers arriving on international flights originating outside the United States in the month of August 1961, examined at the National Archives in Washington, D.C. are missing records for the week of President Obama's birth, including the dates Aug. 1, 1961 through Aug. 7, 1961.

This revelation evoked memories of one of the great underreported stories of the 2008 campaign: the multiple breaches of the presidential candidates' passport records in March of that year. In one of its more egregiously dishonest moments, the *Washington Post* headlined the story on March 22, "Rice Apologizes For Breach of Passport Data; Employees Looked at Files On Obama, Clinton, McCain."

The "Rice" in question is Secretary of State Condoleezza Rice. The offended party in the *Post* story was Barack Obama. He told reporters that he expected "a full and thorough investigation," one that "should be done in conjunction with those congressional committees that have oversight function so it's not simply an internal matter."

It is not until the thirteenth paragraph of the *Post* story that the reader learns that of one of the three contract employees caught in the act worked for the Analysis Corporation, the CEO of which was John Brennan, a 25-year CIA veteran. The *Post* does report that Brennan donated \$2,300 to the Obama campaign but suggests no deeper tie. This information is offset by the revelation that the other two culpable contract employees worked for Stanley Inc., whose CEO Philip Nolan contributed \$1,000 to the Clinton campaign.

Stanley, however, had been handling passport work for 15 years and had just been awarded a five-year, \$570-million contract. The company had no reason to play favorites in the 2008 campaign. It promptly fired the two employees, neither of whom was likely working at the directive of Nolan or of the Clinton campaign.

Unlike Stanley Inc., a huge government contractor listed on the New York Stock Exchange, Analysis Corp. had fewer than 100 employees, and its one culpable employee escaped discipline. The *Post* article tells us only that "his or her employment status is under review."

Nor was Brennan a casual donor to the Obama campaign. To its credit, *CNN Politics* saw the real news angle in the passport scandal: "Chief of firm involved in breach is Obama adviser." As *CNN* reported, also on March 22, Brennan "advises the Illinois Democrat on foreign policy and intelligence issues." He had even briefed the media on behalf of the campaign early in the month.

"Obama Taps CIA Veteran As Adviser On Terror; Brennan Has Drawn Fire on Interrogations." The fact that an employee of Obama's new counterterrorism adviser had **breached Obama's passport files just months earlier** held no interest for the *Post's* allegedly nonpartisan editors.

What likely did have a connection was Obama's strategic jab at the two people who stood between him and the White House at an April 2008 fundraiser in San Francisco. "Foreign policy is the area where I am probably most confident that I know more and understand the world better than Senator Clinton or Senator McCain," said the overconfident candidate.

Obama took particular aim at Hillary Clinton. He countered her boast of having met leaders from 80 foreign countries with his real-world experience in several key outposts.

"I traveled to Pakistan when I was in college," said Obama in the way of illustration. "I knew what Sunni and Shia was [sic -- Obama has always had problems with noun-verb agreement] before I joined the Senate Foreign Relations Committee."

This declaration took ABC reporter Jake Tapper by surprise. He thought it odd that **he had not heard of this trip,** especially "given all the talk of **Pakistan** during this campaign." Indeed, Obama had introduced the general subject of Pakistan as early as **Aug. 1, 2007.** As Tapper observed at the time, Obama talked about U. S. Pakistan policy as a way of challenging Hillary's perceived strength on foreign affairs.

Had Tapper inquired further, he would have learned that Obama did not mention the Pakistan visit in either of his books, the 1995 *Dreams From My Father* or the 2006 *Audacity of Hope*.

Obama's most serious biographer, David Remnick, sheds little light on Obama's motives for going to Pakistan and none for staying quiet about it. In *The Bridge*, Remnick tells how Obama first visits his friends Hamid and Chandoo in Pakistan during Ramadan "and then to Indonesia to see his mother and Maya" -- a three-week trip in all. In 1981, Ramadan began on July 3 and ran for a lunar month. Remnick is likewise mum on whether the Ramadan timing was purposeful.

In *A Singular Woman*, Janny Scott's biography of Obama's mother, Ann Dunham, Scott has Obama circling the world in the opposite direction and in a different time frame.

Scott writes of summer 1981, "Barry spent July in Jakarta, then went to Pakistan to visit a friend from Occidental [College] on his way back to the United States."



As confirmation, Scott includes a letter **purportedly written in May 1981** to Dunham's employers at the Ford Foundation: "I would like to use my educational travel for dependent children to have my son, Barry, come out to visit us." I say "purportedly" because Scott provides no detail at all of Obama's 1981 Indonesian visit. She does, however, provide eyewitness testimony of a 1983 visit to Indonesia by Obama.

But it was not. At the time they were writing, each knew the trip was controversial. Although Scott gives no hint of the controversy, Remnick does. He quotes an old girlfriend of Chandoo, who accuses Fox News of twisting the Pakistan visit "into something awful." What made the trip controversial was not so much what Obama did once he got to Pakistan, but how he got there. In 1981, Pakistan was not an easy or likely destination for an American tourist.

The light of truth

This prompted some noise in the blogosphere that Obama could not have traveled to Pakistan as an American citizen. Quick to Obama's defense as always, FactCheck.org made the valid case that American citizens could travel to Pakistan in 1981 and thus dismissed the travel issue as "more 'Birther' nonsense."

The fact that Obama could have traveled to Pakistan on an American passport, however, does not mean that he did. Not surprisingly, FactCheck fails to mention the variable that prompted the controversy in the first place -- namely, Obama's curious silence about the trip until April 2008. Nor, of course, does FactCheck mention the event that took place just weeks before Obama's first mention of the Pakistan visit -- namely, the passport breach. True to form, the word "passport" does not even appear in Remnick's 2010 book.

It remains to be seen whether Sheriff Arpaio and his posse will get to the bottom of Passportgate, but their effort should be applauded. The mainstream's media's beef that Obama's background has been "thoroughly vetted" and that the various "conspiracy theories" about his origins have already been debunked is just junk disinformation on top of its earlier junk misinformation.
