This is big news—FOX News reporter Chad Pergram reported late Friday afternoon the DNI John Ratcliffe delivered his report.

At the same time as this news is breaking, the President's Executive Order on foreign interference in US elections comes due. **The Director of National Intelligence (DNI John Ratcliffe) is required to provide a report which is to cover an inventory of all known acts of foreign intervention into the 2020 election.** Based on what we know to date, this report should have a litany of observations and evidence.

# White House counsel's office warned Trump not to fire Chris Wray

Dec. 16, 2020, 4:00 AM CST

Attorneys have fretted that by firing the FBI director, Trump could be putting himself in jeopardy.

White House lawyers “strongly” advised Trump against firing another FBI director out of concern that doing so would risk creating the perception that a “loyalty test” was being imposed on a position that traditionally has maintained independence from the White House, according to the senior administration official.

The lawyers, led by White House counsel Pat Cipollone, specifically said that firing Wray could spark legal issues similar to those raised after Trump ousted James Comey as FBI director in 2017 in the midst of the Russia investigation, the officials said.

Their concern was that firing Wray could be seen as retaliation because the president has publicly pressured him to take specific actions on certain investigations – such as announcing a probe into President-elect Joe Biden’s son – and then expressed frustration that Wray has not followed his suggestions.



# Trump Finally Has His Lawyer

Pat Cipollone is making the president happy. But his job is bigger than the president.

PAT CIPOLLONE HAD BEEN working as White House counsel for just two months when his boss issued his first performance review. During a private ceremony in the Oval Office, Donald Trump was walking around the room, shaking hands, when he stopped and greeted Cipollone and his former law partner Tom Yannucci. Cipollone introduced his old friend and told the president that the two had once worked together. “So far, Pat’s doing a great job,” Trump said. “But we’ll know for sure after six years.”

That Trump would brashly predict his own victory in 2020 is no great surprise.

He is not the sort of lawyer who will refer to the president as “King Kong,” as his predecessor, Don McGahn, once did. Trump has long been tough on his lawyers, demanding loyalists and brawlers in the mold of Roy Cohn, his personal attorney from his time as a real-estate magnate and a former aide to red-baiting Senator Joseph McCarthy. Trump didn’t believe that McGahn would fight for him with the tenacity of a Cohn, and McGahn himself appeared to be more of a guardrail for Trump than a defender. “I don’t have a lawyer,” Trump complained to McGahn and other aides in the Oval Office two months into his tenure, according to a passage in Special Counsel Robert Mueller’s report.

“(C) A description of the mission, scope, and duration of use of members of the armed forces under this section.”.

(b) USE OF MILITIA AND ARMED FORCES TO ENFORCE FEDERAL AUTHORITY.—Section 252 of title 10, United States Code, is amended to read as follows:

**“§ 252. Use of militia and armed forces to enforce Federal authority**

“(a) AUTHORITY.—Whenever unlawful obstructions, combinations, or assemblages, or rebellion against the authority of the United States, make it impracticable to enforce the laws of the United States in any State by the ordinary course of judicial proceedings, the President may call into Federal service such of the militia of any State, and use such of the armed forces, as the President considers necessary to enforce those laws or to suppress the rebellion.

“(b) CERTIFICATION TO CONGRESS.—(1) The President may not invoke the authority under this section unless the President and the Secretary of Defense certify to Congress that the State concerned is unable or unwilling to suppress an unlawful obstruction, combination, or assemblage, or rebellion against the authority of the United States described in subsection (a).

“(2) A certification under paragraph (1) shall include the following:

“(A) A description of the circumstances necessitating the invocation of the authority under this section.

“(B) Demonstrable evidence that the State concerned is unable or unwilling to suppress such unlawful obstruction, combination, or assemblage, or rebellion against the authority of the United States, and a legal justification for resorting to the authority under this section to so suppress.

“(C) A description of the mission, scope, and duration of use of members of the armed forces under this section.”

**“§ 256. Consultation**

“The President, in every possible instance, shall consult with Congress before invoking the authority under section 251, 252, or 253 of this title.”.

(2) CLERICAL AMENDMENT.—The table of sections at the beginning of chapter 13 of title 10, United States Code, is amended by adding at the end the following new item:

“256. Consultation.”.

(e) RESTRICTION ON DIRECT PARTICIPATION BY MILITARY PERSONNEL.—

(1) IN GENERAL.—Such chapter is further amended by adding at the end the following new section:

**“§ 257. Restriction on direct participation by military personnel**

“(a) IN GENERAL.—No activity under this chapter shall permit direct participation by a member of the Army, Navy, Air Force, Marine Corps, or Space Force in a search, seizure, arrest, or other similar activity unless participation in such activity by such member is otherwise expressly authorized by law.

“(b) REGULATIONS.—The Secretary of Defense shall prescribe such regulations as may be necessary to ensure compliance with subsection (a).

“(c) RULE OF CONSTRUCTION.—Nothing in this section shall be construed to limit authority of law enforcement personnel of the armed forces on Federal military installations”.

(2) CLERICAL AMENDMENT.—The table of sections at the beginning of such chapter is further amended by adding at the end the following new item:

“257. Restriction on direct participation by military personnel.”.

SUBJECT: Attorney General's Authority to Use Classified Information in Connection with Review of Intelligence Activities Relating to the 2016 Presidential Campaigns

By the authority vested in me as President by the Constitution and the laws of the United States of America, I hereby direct the following:

Section 1. Authority of the Attorney General. The Attorney General is currently conducting a review of intelligence activities relating to the campaigns in the 2016 Presidential election and certain related matters. On May 13, 2019, the Attorney General directed John Durham to conduct that review, which subsequently developed into a criminal investigation. On October 19, 2020, the Attorney General appointed Mr. Durham to conduct that investigation pursuant to the powers and independence afforded by the Special Counsel regulations of the Department of Justice.

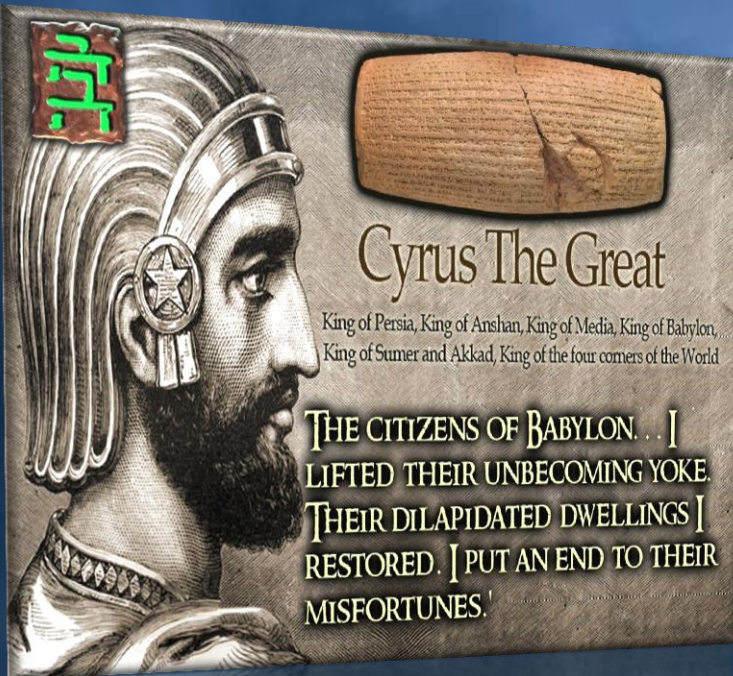
