# Halloween In America

Celebration of Halloween was extremely limited in colonial New England because of the rigid Protestant belief systems there. Halloween was much more common in Maryland and the southern colonies. As the beliefs and customs of different European ethnic groups as well as the American Indians meshed, a distinctly American version of Halloween began to emerge. The first celebrations included "play parties," public events held to celebrate the harvest, where neighbors would share stories of the dead, tell each other's fortunes, dance and sing. Colonial Halloween festivities also featured the telling of ghost stories and mischief-making of all kinds. **By the middle of the nineteenth century, annual autumn festivities were common, but Halloween was not yet celebrated everywhere in the country.**

In the second half of the nineteenth century, America was flooded with new immigrants. These new immigrants, especially the millions of Irish fleeing Ireland's potato famine of 1846, helped to popularize the celebration of Halloween nationally. Taking from Irish and English traditions, Americans began to dress up in costumes and go house to house asking for food or money, a practice that eventually became today's "trick-or-treat" tradition. **Young women believed that on Halloween they could divine the name or appearance of their future husband by doing tricks with yarn, apple parings or mirrors.**

In the late 1800s, there was a move in America to mold Halloween into a holiday more about community and neighborly get-togethers than about ghosts, pranks and witchcraft. At the turn of the century, Halloween parties for both children and adults became the most common way to celebrate the day. Parties focused on games, foods of the season and festive costumes. Parents were encouraged by newspapers and community leaders to take anything "frightening" or "grotesque" out of Halloween celebrations. Because of these efforts, Halloween lost most of its superstitious and religious overtones by the beginning of the twentieth century.

By the 1920s and 1930s, Halloween had become a secular, but community-centered holiday, with parades and town-wide parties as the featured entertainment. Despite the best efforts of many schools and communities, vandalism began to plague Halloween celebrations in many communities during this time. By the 1950s, town leaders had successfully limited vandalism and Halloween had evolved into a holiday directed mainly at the young. Due to the high numbers of young children during the fifties baby boom, parties moved from town civic centers into the classroom or home, where they could be more easily accommodated. Between 1920 and 1950, the centuries-old practice of trick-or-treating was also revived. Trick-or-treating was a relatively inexpensive way for an entire community to share the Halloween celebration. In theory, families could also prevent tricks being played on them by providing the neighborhood children with small treats. A new American tradition was born, and it has continued to grow.

The activity is popular in the United States, the United Kingdom, Ireland, Canada, and due to increased American cultural influence in recent years, imported through exposure to US television and other media, trick-or-treating has started to occur among children in many parts of Europe, and in the Saudi Aramco camps of Dhahran, Akaria compounds and Ras Tanura in Saudi Arabia. The most significant growth and resistance is in the United Kingdom, where the police have threatened to prosecute parents who allow their children to carry out the "trick" element. In continental Europe, where the commerce-driven importation of Halloween is seen with more skepticism, numerous destructive or illegal "tricks" and police warnings have further raised suspicion about this game and Halloween in general.

In Ohio, Iowa, and Massachusetts, the night designated for trick-or-treating is often referred to as Beggars Night.

**Trick-or-treating** spread from the western United States eastward, stalled by sugar rationing that began in April 1942 during World War II and did not end until June 1947.

Early national attention to trick-or-treating was given in October 1947 issues of the children's magazines Jack and Jill and Children's Activities, and by Halloween episodes of the network radio programs The Baby Snooks Show in 1946, The Jack Benny Show and The Adventures of Ozzie and Harriet in 1948. The custom had become firmly established in popular culture by 1952, when Walt Disney portrayed it in the cartoon Trick or Treat, Ozzie and Harriet were besieged by trick-or-treaters on an episode of their television show, and UNICEF first conducted a national campaign for children to raise funds for the charity while trick-or-treating. \*\* More on UNICEF 2013 later in this chapter.

Trick-or-treating on the prairie, although some popular histories of Halloween have characterized trick-or-treating as an adult invention to re-channel Halloween activities away from vandalism, nothing in the historical record supports this theory. To the contrary, adults, as reported in newspapers from the mid-1930s to the mid-1950s, typically saw it as a form of extortion, with reactions ranging from bemused indulgence to anger. Likewise, as portrayed on radio shows, children would have to explain what trick-or-treating was to puzzled adults, and not the other way around. Sometimes even the children protested: for Halloween 1948,

members of the Madison Square Boys Club in New York City carried a parade banner that read "American Boys Don't Beg."

So what is going on today? Halloween is now even more popular than pagan Easter, and rivals pagan Christmas- both of which still pretend to have religious overtones.

Satan has people in our modern era mimicking the witches and Druids of old. All of this is cursed of Yahuah. We live in a time when witchcraft is being revived. Movies are filled with witchcraft and numerous television programs such as "Charmed" are teaching witchcraft to millions. The Harry Potter books are likewise furthering the cause of Satan! These will be addressed in a later chapter. Halloween is no joke and is not harmless fun! This evil holiday has no part in the life of a child of Yahuah. The Roman Catholic Church borrowed Halloween from the witches, which shows how blind they are.

Halloween is just the beginning of the Pagan program that was adapted into early Christianity. Interesting that the adapting of Satanic formats to convey the message of Scripture to Pagans became the pattern, producing a wide variety of mixtures such as the various forms of Catholicism around the world. This too will be addressed in a later chapter. As we have seen Halloween roots go deep into heathenism, paganism, Satanism, and the occult; and the modern expression is *no better!*

Isn't the whole theme one of darkness, death, fear, threats, destruction and evil? There are witches, broomsticks, bats, owls, ghosts, skeletons, death, and monsters. We dress our children as demons, witches, ghouls, monsters and werewolves and send them out into the streets in the dark to reenact the Druids' practice of demanding food from people under the threat of tricks (or curses) if they don't comply.

We take not a turnip, but a pumpkin and carve demon faces in it and decorate with it. At Halloween there will be apple bobbing, divination, fortune telling, haunted houses, candles lit, and spirits called up. There will be séances and Ouija boards in

the name of fun and excitement. There will be sacrifices of dogs, cats, rats, chickens, goats and even humans, but we don't want to think about that!

Think of how Yahusha feels when He sees people cavorting around and dressing up their children to shatan, whom He wanted to save by His act at Passover, but instead seeing them being opened up to demonic forces and those little ones entrusted to in their parents care are terrified and being introduced to fear, torment, and confusion. **How this must grieve Yahuah!**

The bottom line is this: Halloween has been so deluded that many parents don't even realize all the symbolism there is in trick or treating, wearing of costumes, decorating with jack-o'-lanterns, and all the rest that goes with this evil holiday. October 31 is the night that Satanists and occultists the world around look forward to for giving the most honor to Satan and praying to him intensely for the fall of Yahuah's people and the destruction of families. It is the night of the *human* sacrifice to Satan. It is the biggest day in the life of a Satanist. It is *not* an innocent holiday!! We will get into further detail on this in a later chapter as well.

The Dictionary of the Occult and Paranormal,<sup>2</sup> states "Halloween was originally a pagan festival of darkness, fire, and death. All Hallows Eve was celebrated by the Celts of northern Europe... **Halloween was also an important date for the witches' calendar."**

According to witchcraft organizations, witches have eight major festivals throughout the year. Four are the solar festivals: one at both equinoxes, and one at both solstices. The other four occur almost midpoint between the Solar festivals; **the most famous of these are Samhain (Halloween to non-witches)** and Beltane (May day). Samhain, or Halloween, is the beginning of their new year, and is the time when they claim that they can most effectively communicate with the dead.

Irene Park, a former witch and authority on the history of Halloween says:

"Most of the original folklore of Halloween has been preserved in the modern traditions: the goblins, jack-o-lanterns, Halloween parties, begging for gifts, etc., which all had their origin in the ancient celebration of All Hallows Eve.

**It creates a "tongue-in-cheek" attitude that the forces of evil are not to be taken seriously — that devils, witches, and goblins are considered merely make-believe, plastic masks, with child-like impotence. It also tends to promote an acceptance and friendliness toward dark traditions and occult beliefs; that Satan is not really so bad, witches are really not evil, demons are not really dangerous.**

**Members of the occult and devotees to the true satanic traditions of Halloween are ecstatic by the widespread acceptance and participation in their sacred festival.** They view society's celebration of Halloween as an enormous public relations victory, and believe it's a time when their dark powers are greatly intensified, due to the unity of the masses which magnify and exalt the forces

of evil. With thousands focusing their energies upon traditions of Satan, they feel this strengthens his influence in the affairs of the world."

The Satanists and wiccans are laughing at people who think they are believers in 'god' and 'jesus' but worship satan exactly like they do on this one day a year! This fact along with Yahuah telling us not to should convince you right now this is dangerous and should not be considered appropriate- especially for small children!

Listed below are Scripture that discuss the very things that took place when Halloween first started and what still takes place at times. Many people have been exposed to Ouija boards, séances, and other forbidden practices during Halloween. Some may reply, "But we only do this in fun...we don't practice witchcraft." That which represents Satan and his domain cannot be handled or emulated "for fun". Such participation places you in enemy and forbidden territory and that is dangerous ground. Why would you want your child exposed to such practices?

Some may think that we are over emphasizing the influence of the demonic during Halloween with too much emphasis on witchcraft and the satanic. It is not as bad as we think. What about the presentation of violence, murder, blood, atmosphere of fear, and death that is seen during Halloween. Many more homes have ghoulish decorations. The violent and grotesque movies come out during Halloween and are the number one videos rented during Halloween. Halloween is preoccupied with death. More destructive acts are done during Halloween. The Scriptures makes it very clear that we are to not have anything to do with the deeds of darkness.

We find the people of Judah were doing similar things in Jeremiah chapter 2. They were claiming that they weren't polluted with Baal (the lord-shatan), but Yahweh said:

**Jeremiah 2:22 - For though thou wash thee with nitre, and take thee much soap, yet thine iniquity is marked before me, saith the Master YAHWEH. 23 - How canst thou say, I am not polluted, I have not gone after Baalim? see thy way in the valley, know what thou hast done: thou art a swift dromedary traversing her ways;**

**They claimed they weren't polluted, but apparently their actions showed otherwise. Therefore it is certainly wrong to mix paganism into worship. Paganism is actually Satanism.**

Why would anyone believe it is okay to incorporate Satanism into our worship?  
How terrible! The Egyptians observed many of these pagan practices, what did Yahuah command Israel?

Take a look at the decorations, movies, haunted houses, pranks of today compared to when you were a kid. The signs of violence, grotesque imagery, satanic evidence,

and evil pranks are much worse in our society today. The celebration of Halloween becomes more macabre each year. Why would a person who says they are "saved" or a child of Yahuah want their children to participate in the deeds of darkness?

## Recap of Customs

### Jack o lanterns or Jack in the Lantern

### Trick or Treating

They were blood thirsty murderers and even if you dress your child like a little puppy dog, saying "trick or treat" or doing it for them is an abomination and should not be taught to them that it is acceptable. In later years James Napier says, in his book, Holidays of Legend, Irish farmers went house to house begging for food for their ancient gods. Then each would peel his (or her) apple, trying to get the peel off in one piece (which gave the peeling particular power, and gained special favor with the spirits). ## Bonfires

Bonfires originally came from the nights of human and animal sacrifices where they would throw the remains of the bodies into the fire. The next morning all that was left were the ashes and bones. Thus the name of these fires was called "bone-fires". The orange flames lit up the black night. Isn't that just heartwarming!! People are now getting together in the desert by the thousands to burn a modern wicker man in big pagan celebrations. Is this really what you want your teenager to think is ok? We have opened the door to it as infants and they can be led away so easily. That is why Yah warns us!

## **Black Cats**

# A Seductive Bridge Between Two Worlds

In honor of the Halloween season, the last week of October has been declared "Earth Religions Awareness Week" in Asheville, NC. The mayor's proclamation explains that Earth-centered beliefs, are "among the oldest spiritual systems on the planet" and that pagan practitioners "have given us practical knowledge of herbal remedies, midwifery and alternative forms of healing."<sup>1</sup>

That may sound good to all who have embraced the new [global spirituality](#) touted in schools, movies, and the wildly popular [Harry Potter books](#). But some of the local pastors were understandably alarmed. Concerned that such a government endorsement could speed the spread of witchcraft, they led a group of 25 Christians to City Hall. "We just wanted to counter that by making a positive statement that we believe Jesus is Lord," said Pastor Ken Lewis of the West Asheville Baptist Church.

Mayor Leni Sitnick apologized, but refused to rescind the special designation for the week of October 25. "I don't tell anyone how to believe, but I support everyone's right to freedom of religion," she said. "Being aware of different religions, of all religions ... should not be feared." Of course, a government proclamation is far different than public awareness. But never mind. These days, facts and logic seem to slip away from ideological conflicts.

**PAGANISM IS IN.** This irrational twist in the changing view of "the separation between church and state" demonstrates the new public attitudes toward occult thrills and earth-centered values. Since a multicultural perspective is fast becoming a graduation requirement in school districts across the country, educators look for creative ways to immerse students in various [earth-centered rituals](#) and experiences. So it's not surprising that a Wiccan priestess was allowed to present "a program designed to dispel witchcraft myths" at an Asheville elementary school -- something she has done every October for the past four years. After all, earth-centered religions fit right into the envisioned global spirituality needed to "re-connect with the earth" as Al Gore and other leaders have proposed.

The new public attitudes toward earth-centered celebrations fueled an interesting conflict in our California school district a few years ago. A simple request that Halloween festivities be held after school rather than during class time to free some Christian children from a duty to participate exploded into a major community feud. Most parents were angry. They simply couldn't understand why some children would choose to avoid the traditional in-school celebration of a "harmless holiday." Why worry about the small minority who felt offended by its ancient link to a "dead religion?"

To resolve the conflict, a large public meeting was held. Only a few minority voices were heard. **A former Wiccan priest explained that the old Celtic witchcraft that gave birth to Halloween is anything**

but "dead." **Flourishing in today's pagan revival, it has become an official religion with tax-exempt status.**<sup>2</sup> A few Christian parents shared their concerns about programs that compelled children to celebrate occult themes. They knew well that pagan symbols and occult amusement were desensitizing children to a fast-spreading subculture obsessed with death, spells and black magic -- not just at Halloween but all year long.<sup>3</sup>



The majority booed, jeered, and refused to listen. "These are religious objections to secular events," declared Phil Faillaice, the president of the board. Everyone seemed to have forgotten that a different minority had, only nine months earlier, banned Christmas songs as offensive to their beliefs. But times have changed. By the end of the evening, the pro-Halloween group had won its case, and the media spread the "good" news from coast to coast.

**Teletubbies** "It's hard to give up a good party," added Daniel Melia, UC Berkeley professor of Celtic languages. "Satan is a Christian notion. This is a pre-Christian celebration."

He was wrong about Satan. The Old Testament mentions Satan fourteen times, and that doesn't include all his other names. From beginning to end, the Bible shows how Lucifer has always been stirring rebellion against God and hatred for His people -- even as he masquerades as an "angel of light." But then as now, the good news outshines the bad: the evil one could never cause more trouble than God would allow.<sup>5</sup>

**THE ROOTS OF HALLOWEEN.** Few understand the spirit behind Halloween better than Valerie Duffy, a former witch. (You can read her amazing testimony in [A Twist of Faith](#)). "The feast of Samhain (sah-ween) is an unholy Sabbath observed by occultists worldwide," she explains. Freed from the demonic forces that once controlled her life, she now lives in an "upstate New York" community that often publicizes Wiccan coven meetings and "full moon" celebrations. Each October, she fights -- and wins<sup>6</sup> -- a spiritual battle against oppressive forces that intensify their attacks near the Wiccan holiday.

Valerie knows all too well why Neopagans love Halloween. The old Celtic "sabbat" is their main feast -- a window of time when the walls between the physical and spiritual worlds supposedly become thin enough to allow easy crossovers. This was the time to catch up with one's ancestors and other spirits from the underworld.<sup>7</sup> But don't think the Vigil of Samhain was just a fun holiday. The "Lord of the Dead", Samhain himself, is no deity to laugh at. Valerie explains why:

*"On October 31, black-cloaked Druids bearing torches would go door to door to select humans for their New Year's sacrifice to the Lord of the Dead. In return for the child or infant, they would leave a hollowed turnip with candle light shining through the carved face -- **a satanic counterfeit for the biblical Passover.**"*

*"In the reveling that took place on that night to Samhain, the demons supposedly loosed for the night would pass over the homes "marked" by the carved lantern. Those families had provided the required gift or sacrifice. Other homes could be hit -- sometimes with sudden death.*

*"The children selected for sacrifice were tossed into a bonfire. The Druids called it a bone-fire since only the bones were left. From the agonizing screams of the dying, the divining priests would foretell the future of the village."<sup>8</sup>*

Does the last statement sound familiar? Remember how the shaman or medicine man in Disney's Pocahontas read the future in the smoke from his ritual fire. When you look behind today's idealized

images of the world's pagan religions, you find some awesome similarities. Small wonder since Satan, the mastermind behind the Druid rituals, has been repeating the same basic strategies throughout history.

Those who are captivated by occult thrills and symbols become blind to the dangers they have embraced. Images that once drew shudders, now produce laughter. I stopped by a large bookstore one day and discovered a huge new display inside. Startled, I stared at a child-sized open casket filled with vampire books. The wooden casket was leaning against a large imitation stone altar. On it stood an embellished cross with candles on each side. In the center, displayed like a Bible, lay a large book. Sickened by the mockery of Christianity, I checked the cover and found *Memnoch the Devil*, the latest top-selling vampire book by Anne Rice. On the gray cathedral-like wall above the altar hung a cross. I hurried out of the store.

**THE PARADIGM SHIFT.** This decade's culture clash may be more evident in October, but Halloween's celebration of occultism is only a symptom of a spiritual battle that rages all year. Most of us were grieved by this past year's school and church massacres -- horrendous symptoms of a rudderless society. Yet, murderous eruptions of violence have been increasing year by year at a pace that parallels the accelerating shift from Biblical truth to an irrational emphasis on self-esteem. For instance, some years ago, three teenage boys shamelessly stabbed, strangled, and beat a 55-year-old man crippled by multiple sclerosis -- then feasted on the spaghetti in his refrigerator. He "didn't have a chance," concluded the *Newsweek* story. "The boys who allegedly attacked him. . . were ruthless."<sup>9</sup>

Girls are fast catching up with boys. In New Orleans, a 13-year old schoolgirl pulled out a knife and plunged it into a classmate's back. "You name the crime, we have it; you think about the worst scenarios and we have them here,"<sup>10</sup> said Edward Cue, an official with California's "hard core" Youth Authority school in Ventura.

The lack of remorse baffles law officers. Why are both children and adults losing the old sensitivity to the horrors of evil? Why can't they tell right from wrong? The *New York Times* cover story that declared "evil is back," raised the same questions: "What does it mean? Violence? Mindless wickedness? Malignant wickedness?"<sup>11</sup>

The answer is: all the above. People love evil. Children gleefully watch televised death scenes that might have shocked hardened spectators in the old Roman coliseum. The lure of cruelty, violence, and occult horrors sell some of the most popular children's books as well as supermarket tabloids. By its mere exposure and availability, evil has been reinvented. Now it feels good, not bad -- exciting, not repulsive.

### **And Satan grins.**

Fictionalized evil -- the kind children enjoy in [books](#) and [movies](#) -- separates people from the reality of human suffering, which is just what the evil one intended. Many become spectators rather than participants in real community life. Eventually, both real and imagined violence becomes significant only as entertainment.

Some years ago, a car hit an elderly couple in a busy shopping complex. A crowd was already gathering at the scene when I happened to come by. It didn't take long to see the streams of blood from both their heads, yet no one had bound their wounds or covered their shivering bodies. I cried out for blankets or jackets, scarves -- anything to stop the bleeding and slow the shock. Nobody responded -- neither men nor women. When I tried to stop the bleeding from the woman's broken skull with a tissue from my purse, the spectators just stared with blank faces. I called to the owner of the car for a blanket or clothing. He didn't move. When I ran to his car and grabbed some dry cleaned clothes from his back seat, he protested. I suppose he didn't want blood on his clean clothes. Eventually an ambulance came and took the victims away.

The Bible mentions people who act like animals. "What's wrong with that?" some might argue. "Animals are nicer than people."



Those who study animals see the harsh nature behind the soft fur, brown eyes, and flattering media images. An anthropologist had been studying a group of monkeys for some time when a party of chimpanzees invaded the territory. "The results were devastating," he wrote. "During the hour-long hunt, seven [monkeys] were killed; three were torn apart in front of me. Nearly four hours later, the hunters were still eating. . . while I sat staring in disbelief at the remains of many of my study subjects."[12](#)

Were these animals evil?

No. Evil is unique to humanity. We alone are given a moral choice and God's Word to help us resist temptation. Animals are expected to follow their natural instincts, **but humans are held accountable to God's standard. Ignorance of that standard doesn't cancel the consequences for not heeding it.** "They are without excuse," the Bible tells us.

That standard is the Torah. The writer is very close to the complete truth, but because someone scraped off Yah's name 7,000 times she does not see all the deception. How fortunate we are!

## Why Is UNICEF Accusing Health Journalists of Lying?

A recently published report<sup>1</sup> by the United Nations Children's Fund (UNICEF) reveals that the organization is tracking "the rise of online pro-vaccine safety sentiments in Central and Eastern Europe," and has identified the most influential pro-vaccine safety influencers" on the web.

UNICEF included me on the list, along with other independent health websites like GreenMedInfo.com, Mothering.com and NaturalNews.com, just to name a few. In their opening reference, they use a quote by Mark Twain that reads:

"A lie can travel halfway around the world while the truth is putting on its shoes."

Clearly, UNICEF is inferring that I and other vaccine-safety advocates are lying about the situation and therefore should be ignored. This would be hilarious if it wasn't so serious.

Here we have an international organization supposedly dedicated to children's health and wellbeing, and instead of addressing the ample scientific evidence showing the potential harm

of vaccines, they're entering into ever-deepening partnerships with vaccine company giants like Merck<sup>2</sup> and GlaxoSmithKline<sup>3</sup> (GSK).

They spend precious time and resources on public relations schemes to convince you to ignore any science that raises questions about the wisdom of “carpet-bombing” infants’ and young children’s immune systems with potentially harmful vaccines.

### UNICEF’s Bedfellows

This is especially disturbing because Merck has been involved in numerous criminal scandals and class-action lawsuits in recent years, including fraudulently marketing its deadly drug Vioxx; lying about the true efficacy of its mumps vaccine.

Additionally, they engaged in scientific fraud (a charge brought by its own scientists); and hiding critical side effects associated with its osteoporosis drug Fosamax, just to name a few of the most publicized.

Even more shocking, in 2009, it was revealed that Merck actually had a hit list of doctors to be “neutralized” or discredited for voicing critical opinions about the pain killer Vioxx—a drug that indeed ended up killing more than 60,000 people before it was pulled from the market.

Two years later, in 2011, the company ended up pleading guilty to a criminal charge over the fraudulent marketing and sales of this deadly drug.<sup>4</sup> But sure, let’s listen to UNICEF and trust the guys who go so far as to threaten the lives of those who question the safety of a very factually dangerous drug. Then there’s GSK, whose leadership among corporate criminals is illustrious indeed.

Not only was GSK found guilty in the largest health fraud settlement in US history just last year, for which they were fined \$3 billion. A couple of months ago, Chinese authorities accused the company of bribery and illegal marketing schemes. Chinese police claim to possess evidence showing that bribery has been a “core part” of GSK China's business model since 2007.

Doctors and government officials are said to have received perks such as travel, cash, and sexual favors that when combined, amounted to nearly \$5 billion, according to some reports. The company allegedly used travel agencies as middlemen to carry out these illegal acts. Four Chinese GSK executives have so far been detained on charges of cash and sexual bribery.

GSK also spent more than 10 years covering up information that proved they knew about the serious health dangers of their blockbuster diabetes drug Avandia, as it would adversely affect sales. While carousing with the true liars and criminals, UNICEF deems it fitting to paint me and other health journalists as the liars; the ones leading you astray.

Little does UNICEF realize that by publicizing a list of monitored “vaccine influencers”—the health reporters who stick pegs in the wheels of their crafty PR schemes by publishing all those studies the vaccine industry would rather see buried—they’ve basically given you a Who’s Who of real vaccine information.

Maybe we should thank them rather than rail against their poor judgment? As stated by Sayer Ji of Greenmedinfo.com, who was also targeted in the report:

“[W]hile the document purports to be analytical and descriptive, it has proscriptive and defamatory undertones, and only thinly conceals an agenda to discredit opposing views and voices. UNICEF's derogatory stance.

This is all the more surprising considering that websites such as GreenMedinfo.com aggregate, disseminate and provide open access to peer-reviewed research on vaccine adverse effects and safety concerns extracted directly from the US National Library of Medicine, much of which comes from high-impact journals.”

GMO-Labeling Supporters Now Accused of Supporting Eco-Terrorism. What’s Next?

Another recent article, published in Forbes Magazine,<sup>6</sup> really ups the ante of the attack on health journalists and their readers with the headline: “ Domestic Eco-Terrorism Has Deep Pockets. And Many Enablers.” The article, written by Jay Byrne and Henry I. Miller, reads in part:

“In recent years, [eco]terrorists have attempted to gain sympathy and “justification” for their actions by means of disinformation campaigns that relentlessly smear the safety and utility of genetic engineering applied to agriculture... “Frankenfood” headlines may sell newspapers and organic food, but this kind of “black marketing” — enhancing the perceived value of your products by disparaging those of your competitors – can also encourage serious criminal acts.

...There exists in this country a vast, well-established, highly professional, protest industry fueled by special interest groups seeking to line their own pockets... Anti-genetic engineering campaigns are openly funded and promoted by mainstream organic food marketers like Gary Hirshberg, the chairman of Stonyfield Organic, and alternative health and food-supplement hucksters Joe Mercola and Mike Adams — all cynical fear-profiteers who benefit from

increased consumer mistrust in their competitors' products... The ultimate objective, of course, is to sell more overpriced, overrated organic food...

One result of the widely disseminated disinformation effort is an environment that provides encouragement to extremists who commit criminal acts. It comes from the Facebook and Twitter followers of the genetic engineering conspiracy theorists, organic marketers and “right to know” labeling activists... Against the backdrop of this fear-mongering, hate-speech and support for acts of terror toward legal, highly regulated, safe and societally valuable R&D, we should condemn not only the perpetrators themselves but also their corporate and media enablers.”

Why Am I on Biotech's Hit List?

Alright, now that we've been labeled as “enablers of domestic eco-terrorism” as well—again by simply reporting on research that is published in peer-reviewed journals and interviewing educated researchers and professionals in the field—let's take a look at who's behind the name calling. The first author of this hit-piece is Jay Byrne, whose author's bio identifies him as president of v-Fluence Interactive Public Relations, Inc. Why does Mr. Byrne fail to mention in his bio that he was a former Monsanto executive?

Jay Byrne actually headed up corporate communications for Monsanto Company from 1997 to 2001. And this piece is nothing if not a corporate communication; clearly, there are persistent ties there. How nice for Monsanto to be able to call up their old communications director and have him pen a totally impartial article warning you of your eco-terrorism ties and contributions, should you decide to support a GMO labeling campaign. Back in 2001, Jay Byrne also made the following statement, which is more than a little telling:

“Imagine the internet as a weapon, sitting on a table. Either you use it or your opponent does, but somebody's going to get killed.”

Byrne's company v-Fluence Interactive Public Relations<sup>7</sup> is also a thinly veiled arm of big Biotech. According to Byrne, “traditionally produced foods and agricultural practices are under attack... Leveraging such issues as pesticides, GMOs, hormones, antibiotics, Mad Cow disease, CAFOs and trade concerns linked to risk factors (human health, environmental risks and consumer choices/controls).” If that's not a statement taken right out of Big Biotech's playbook, I don't know what is. He's certainly not speaking with any concern for your health and wellbeing.

Perhaps Jay would like to address the recent contamination of alfalfa and wheat exports. While it was just recently approved for commercial use, it was already found in contaminated and rejected exports sending yet another shock to countries who require labeling or reject

genetically engineered crops. Monsanto is single-handedly destroying farmer's export markets by genetically polluting and contaminating our entire agriculture.

The following slide is from his 2013 conference presentation<sup>8</sup> on Food and Agricultural Advocacy, which carries the following description (you can view the slideshow in its entirety here):

“These five stakeholders represent a core group of commercial players who act in advocacy roles seeking to influence public attitudes, commercial and governmental policies negatively impacting agriculture and food biotechnology. These influencers directly or via their organizations have been principal drivers via direct activities, funding or complementary marketing behind North American anti-GMO advocacy campaigns in 2011.

While the scope of this report focused on NGOs it is important to note that absent commercial partners – specifically those in the organic, natural products and alternative health sectors – who provide funding and other leverage for anti-GMO advocacy there would be little effective or sustained advocacy in this space.”



Remember Henry Miller?

Coincidentally, if the name Henry I. Miller—the second author of that hit piece—rings a bell, it could be because you paid attention during last year’s campaign to get genetically engineered foods labeled in California.

He was front and center of the “No on Prop 37” campaign, posing as a Stanford professor in TV commercials and flyers, telling California voters that the ballot measure was “arbitrary,” “completely illogical,” and “ill conceived.”

In reality, he’s not a Stanford professor; he’s a research fellow at the Hoover Institution, a conservative think tank that happens to be housed on the Stanford campus. Furthermore, Stanford has a policy to not take positions on candidates or ballot measures, and does not allow political filming on campus. The campaign’s TV ad was eventually pulled due to the misrepresentation of Miller.<sup>9</sup> He also has a long history<sup>10</sup> of defending toxic chemicals such as DDT, in addition to working for Big Tobacco.

If you care about your right to know what’s in your food, your right to choose organic, and your right to learn how your food is being produced, I suggest you etch the names Jay Byrne and Henry Miller into your memory, so you know exactly who is speaking when you come across their industry PR pieces, because nowhere do either of these men fess up their close ties to the industries they defend.

The Science Media Centre—the Dark Side’s PR Center

Another not-so-independent source of information is anything generated by the Science Media Centre (SMC).<sup>11</sup> Headquartered in the UK, there is also a US-based outlet.<sup>12</sup> The SMC<sup>13</sup> claims to be “an independent press office helping to ensure that the public have access to the best scientific evidence and expertise through the news media when science hits the headlines.” Yet their list of funding sources reads like a Who’s Who of big biotech<sup>14</sup> -- multibillion dollar giants like:

The organization lays claim to being objective and non-biased because they don’t receive more than five percent or so of their funding from any one company, organization or individual. But how non-biased can you possibly be when so much of the funding comes from different companies and front groups within the same industries? Their highly conflicted panel of “experts” represent the funding industries and are NOT providing the media with objective academic feedback. Why would any company pay to have some independent,

objective expert speak out against them? In short, the SMC has one agenda, and that is to deceive you with corporate propaganda.

For example, they provide handy tips to their “independent” experts in a document<sup>15</sup> called “Communicating Risks in a Soundbite: A Guide for Scientists.” It explains how to respond to media questions by downplaying problems. For example, if a reporter asks, “Is it risky?” the scientist should get the journalist to instead ask about the benefits by replying, “the benefits outweigh the risks.” Another suggested answer: “It is a very small risk. So small that I believe it is safe.”

Not exactly players with an objective view of science.

This might explain why the Science Media Centre pounced<sup>16</sup> on the French study showing organ damage and massive cancer tumors in rats fed GE corn. This was the first lifetime feeding study that has ever been conducted with GE food, so it was sure to be a major embarrassment to Big Biotech. The very same day the French report was published came a press release<sup>17</sup> from the Science Media Centre claiming “anomalies throughout the paper” despite the authors having been through the usual peer review process.

In short, you can bet if there’s a harmful substance out there that makes money, there are at least one or more front groups, posing as independent non-profit organizations, disseminating anything but independent safety reviews and information pertaining to it. It’s high time to pull back the curtain and see who’s really pulling the strings and levers.

I hope you will support not only this web site by reading and sharing what you learn here with others, but also any number of other health journalists reporting the results of research that Big Business would rather you didn’t know. It’s quite clear that many of us have targets on our proverbial backs, and the attacks are quickly escalating. Now is the time to stand together, form a united front, and show them that we simply will not be cowed by their thinly-veiled threats.

Why Does Monsanto Hate Americans?

Interestingly, Monsanto seems to be fine with supporting GMO labeling when there’s no other choice. Here’s a Monsanto ad from the UK, letting British consumers know how much the company supports the mandatory labeling of their goods—even urging Britons to seek such labels out—ostensibly because Monsanto believes “you should be aware of all the facts before making a decision.” What’s the difference between British shoppers and American shoppers? Why does Monsanto support one nation’s right to know but not another?

Last month, in a stunning setback for the biotechnology industry, **a federal court ruled that genetically modified (GMO) sugar beets should never have been approved for introduction into the food supply.** The court found that GMO sugar beets would inevitably contaminate natural and organic sugar supplies, making it impossible for farmers and consumers who simply want to eat the same safe, natural sugar they always have.

Despite the court's finding, the leading U.S. candy makers Hershey's and Mars have refused to commit to avoiding sugar from GMO beets, even though numerous polls show that most consumers don't want to eat GMO food.

Other food companies have rejected GMO sugar, including Organic Valley dairy, the nation's largest farmer-owned food company, and PCC Markets, the nation's largest consumer-owned grocery chain.

As if that's not bad enough, **candy that's made for and sold almost exclusively to Latino children, is still contaminated with lead.** That's right: companies allowing lead – one the most potent neurotoxins known to science – into products that young children are eating, and they are profiting from this. Absolutely appalling.

Along with our allies at the Environmental Health Coalition, CEH sued the manufacturers and distributors of these unconscionable products and forced them to commit to legally binding, safe standards. And now we're also going from store to store in Latino neighborhoods in our backyard (the San Francisco Bay Area), to check which suspicious candy products are still in stores. Today's San Francisco Examiner highlights how important this work is. According to

the Examiner, just a small percentage of stores are actually taking the threat seriously and committing to protect kids from lead in candy. Whether it's GMOs, pesticides, lead, our children, or our neighbors' children, we all need to stay aware this Halloween season and take action wherever we can. ### **GMO alert: top 10 genetically modified foods to avoid eating**

## **High Fructose Corn Syrup**

**(NaturalNews) There is a conspiracy of selling out happening in America. Politics and personal interest it would seem determine government policies over and above health and safety issues. When President Obama appointed Michael Taylor in 2009 as senior adviser for the FDA, a fierce protest ensued from consumer groups and environmentalists. Why? Taylor used to be vice president for Monsanto, a multinational interested in marketing genetically modified (GM) food. It was during his term that GMO's were approved in the US without undergoing tests to determine if they were safe for human consumption.**

### **The danger of GMO's**

**The question of whether or not genetically modified foods (GMO's) are safe for human consumption is an ongoing debate that does not seem to see any resolution except in the arena of public opinion. Due to lack of labeling, Americans are still left at a loss as to**

whether or not what is on the table is genetically modified. This lack of information makes the avoiding and tracking of GM foods an exercise in futility. Below are just some of the food products popularly identified to be genetically modified:

1. Corn - Corn has been modified to create its own insecticide. The U.S. Food and Drug Administration (FDA) has declared that tons of genetically modified corn has been introduced for human consumption. Monsanto has revealed that half of the US's sweet corn farms are planted with genetically modified seed. **Mice fed with GM corn were discovered to have smaller offspring and fertility problems.**

2. Soy - Soy has also been genetically modified to resist herbicides. Soy products include soy flour, tofu, soy beverages, soybean oil and other products that may include pastries, baked products and edible oil. **Hamsters fed with GM soy were unable to have offspring and suffered a high mortality rate.**

3. Cotton - Like corn and soy, cotton has been designed to resist pesticides. It is considered food because its oil can be consumed. Its introduction in Chinese agriculture has produced a chemical that kills cotton bollworm, reducing the incidences of pests not only in cotton crops but also in neighboring fields of soybeans and corn. **Incidentally, thousands of Indian farmers suffered severe rashes upon exposure to BT cotton.**

4. Papaya - The virus-resistant variety of papaya was commercially introduced in Hawaii in 1999. Transgenic papayas comprised three-fourths of the total Hawaiian papaya crop. Monsanto bestowed upon Tamil Nadu Agricultural University in Coimbatore technology for developing papaya resistant to the ringspot virus in India.

5. Rice - This staple food from South East Asia has now been genetically modified to contain a high amount of vitamin A. Allegedly, there are reports of rice varieties containing human genes to be grown in the US. The rice will create human proteins useful for dealing with infant diarrhea in the 3rd world. China Daily, an online journal, reported potential serious public health and environment problems **with genetically modified rice considering its tendency to cause allergic reactions with the concurrent possibility of gene transfers.**

6. Tomatoes - Tomatoes have now been genetically engineered for longer shelf life, preventing them from easily rotting and degrading. **In a test conducted to determine the safety of GM tomatoes, some animal subjects died within a few weeks after consuming GM tomatoes.**

7. Rapeseed - In Canada, this crop was renamed canola to differentiate it from non-edible rapeseed. Food stuff produced from rapeseed includes rapeseed oil (canola oil) I used to

process cooking oil and margarine. Honey can also be produced from GM rapeseed. German food surveillance authorities discovered as much as a third of the total pollen present in Canadian honey may be from GM pollen. In fact, some honey products from Canada were also discovered to have pollen from GM rapeseed.

8. Dairy products - It has been discovered that 22 percent of cows in the U.S. were injected with recombinant (genetically modified) bovine growth hormone (rbGH). This Monsanto created hormone artificially forces cows to increase their milk production by 15 percent. Milk from cows treated with this milk inducing hormone contains increased levels of IGF-1 (insulin growth factors-1). Humans also have IGF-1 in their system. Scientists have expressed concerns that increased levels of IGF-1 in humans have been associated with colon and breast cancer.

9. Potatoes - Mice fed with potatoes engineered with *Bacillus thuringiensis* var. *Kurstaki* Cry 1 were found to have toxins in their system. Despite claims to the contrary, this shows that Cry1 toxin was stable in the mouse gut. When the health risks were revealed, it sparked a debate.

10. Peas - Peas that have been genetically modified have been found to cause immune responses in mice and possibly even in humans. A gene from kidney beans was inserted into the peas creating a protein that functions as a pesticide.

#### The GMO link to strange disease

As early as 2008, NaturalNews.com reported about a condition called Morgellon's disease. The article went on to report the symptoms of the disease as follows: crawling, stinging, biting and crawling sensations; threads or black speck-like materials on or beneath the skin; granules, lesions. Some patients report fatigue, short term memory loss, mental confusion, joint pain and changes in vision. Furthermore, there have been reports of substantial morbidity and social dysfunction leading to a dip in work productivity, job loss, total disability, divorce, loss of child custody and home abandonment.

Prior to its reporting, the condition was dismissed as a hoax, but upon further investigation, the evidence pointed out that the disease was real and may be related to genetically modified food.

Despite this link being established, the CDC declared Morgellon's disease of unknown origin. Worse, the medical community could not offer any information to the public regarding a cause for the symptoms.

When a research study was conducted on fiber samples taken from Morgellons patients, it was discovered that the fiber samples of all the patients looked remarkable similar. And yet, it did not seem to match any common environmental fiber. When the fiber was broken down, and its DNA extracted, it was discovered to belong to a fungus. Even more surprising was the finding that the fibers contained Agrobacterium, a genus gram-negative bacteria with the capacity of transforming plant, animal and even human cells.

Morgellon's disease is not the only condition associated with genetically modified foods. A growing body of evidence has shown that it may cause allergies, immune reactions, liver problems, sterility and even death. Moreover, based on the only human feeding experiment conducted on genetically modified food, it was established that genetic material in genetically modified food product can transfer into the DNA of intestinal bacteria and still continue to thrive.

### Heeding the warning

Time and again, the American Academy of Environmental Medicine (AAEM) has warned that GMOs pose a serious threat to health, and it is no accident that there can be a correlation between it and adverse health effects. **In fact, the AAEM has advised doctors to tell their patients to avoid GMOs as the introduction of GMOs into the current food supply has correlated with an alarming rise in chronic diseases and food allergies.**

This should come as no surprise. More than 30 years ago a food supplement called L-tryptophan killed 100 people and affected 5,000 to 10,000 more. The cause was narrowed down to the genetic engineering process used in its production. If the symptoms had not had three simultaneous characteristics - namely, they were unique, acute and fast-acting - the disease could never have been identified.

If science could assure us with certainty that serious consequences do not wait for us at the end of the line, it might be to our best interest to let this opportunity pass. Progressive thinking in terms of profit is certainly not wrong. But to brush off precaution on the convenient argument that there is not enough evidence to prove that GM food is indeed harmful is sheer irresponsibility. It certainly is a lame excuse to offer in the event that GM foods are indeed proven to contain health hazards.

## **Doctors Warn About Dangers of Genetically Modified Food**


A large number of studies and incidents have implicated GM foods in a wide variety of health problems, including accelerated aging, immune dysfunction, insulin disorders, organ damage and reproductive disruption.

For example, female rats fed a diet of GM soy experienced a drastically higher infant death rate, and their surviving infants were smaller and less fertile than the offspring of rats fed on a non-GM soy diet. Male rats fed the GM soy had their testicles change from pink to blue, and the GM soy was also observed to damage the DNA of sperm and embryos. Fertility problems such as abortion, infertility, premature delivery, prolapsed uteri, infant death, and even delivery of unformed infants (bags of water) have been observed in farm animals fed GM cottonseed and corn.

Animals consuming crops that have been genetically modified to produce the pesticide Bt (approved for human consumption in the United States) have died by the thousands, while animals grazing on a non-GM version of the same crops remained unharmed. Upon autopsies, researchers have found black patches in the animals' livers and intestines, internal bleeding and other signs of Bt poisoning. Farm workers in India have begun developing allergic reactions upon handling Bt corn, similar to the effects experienced by people exposed to Bt spraying.

In addition to these risks, GM soy and corn contain significantly higher concentrations of allergens than unmodified varieties. Evidence also suggests that the genetic abnormalities of GM foods may transfer to bacteria in the human gut, thereby exposing people to their detrimental effects long after a **food** has been consumed.

Yet in spite of all this evidence and the prevalence of GM crops in the U.S. food supply not a single clinical trial of any GM crop has ever been published.

### Wikileaks: Saudi princes engage in sex, drug parties

*According to leaked diplomatic cables, secret, underground parties involving alcohol, prostitutes are “thriving, throbbing.”*



Where's the party tonight? A Saudi Prince welcomes Hillary Clinton to the Islamic kingdom of sin. There seems to be no end of its wickedness.

United States diplomats have described a world of “sex, drugs and alcohol” in which the official religious individuals of Saudi Arabian loyalties engage in, according diplomatic cables recently published by Wikileaks on Wednesday.

According to the leaked dispatches, officials from the Jeddah consulate detailed an underground Halloween party in which alcohol and prostitutes were readily available. The party, attended by over 150 Saudi men and women mostly in their twenties and thirties, was organized by a member of the Saudi royalty, a wealthy prince from the Al Thunayan family.

The party was held in a heavily secured villa and some of the funding was contributed by a US energy drink. The diplomat recommended the prince’s identity remain secret.

The dispatch was signed off by Martin Quinn, the consul in Jeddah.

“Alcohol, though strictly prohibited by Saudi law and custom, was plentiful at the party’s well-stocked bar,” explained the cable. “The hired Filipino bartenders served a cocktail punch using sadiqi, a locally-made “moonshine”. It was also learned through word-of-mouth that a number of the guests were in fact ‘working girls’, not uncommon for such parties.”
