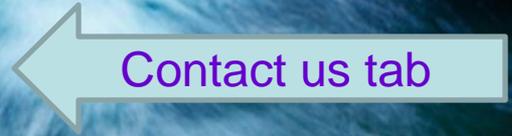

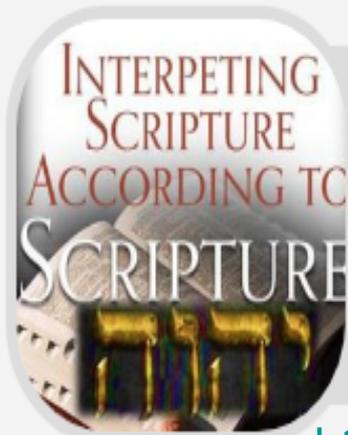

In part B of our study on "Do not continue to steal", we will be examining the consequences of ignoring this instruction by looking at the real world example of Bernie Madoff.

We are also using "The Eighth Instruction" from the Bible Illustrator as a templet of other forms of stealing to help us guard this instruction and keep us squarely on the path.

## To Steal - Ga-Nab

- To take without permission anything that belongs to another
- To deceive
- To do by stealth
- To snare by flattery or deceit. i.e. matters of the heart



- This includes stealing information, kidnapping, illegal organ harvesting, someone's honor or reputation,
- Keeping information hidden to steal away another's ability to make the best decisions.
- This action can be done with a swiftness to avoid detection

## The Eighth Instruction – Bible Illustrator 5/8/2021

There is the evading of government taxes and custom-house duties by making defective or ambiguous returns — a mode of stealing which, I regret to say, is not altogether unfashionable among people of position..



**A lawyer, Peter worked as the chief compliance officer and a senior managing director at his brother's firm. Prosecutors said he helped create false and misleading documents designed to make it appear that the firm had an effective compliance program. He also transferred millions of dollars within the Madoff family to avoid tax payments to the IRS and also put his wife on the firm's payroll in a no-show job.**

**"I am deeply ashamed of my conduct," Peter said at his sentencing. "I accept full responsibility for my actions."**

Peter Madoff was sentenced in 2012 to 10 years in prison after pleading guilty to criminal charges that included conspiracy to commit securities fraud for falsifying the books and records of the investment advisory company founded by his brother.

**He was released from home confinement in 2020 after serving nine years of his sentence. He had been transferred to home confinement from the Federal Correctional Institution in Miami in November 2019.**

# 2014 California Proposition 47

**Legal Definition:** (a) Notwithstanding Section 459, shoplifting is defined as entering a commercial establishment **with intent to commit larceny while that establishment is open during regular business hours, where the value of the property that is taken or intended to be taken does not exceed nine hundred fifty dollars (\$950).**

For a person to be convicted of a violation of PC 459.5, the prosecution must show that:

- 1. You entered a commercial establishment;**
- 2. When you entered the commercial establishment, it was open during regular business hours;**

**AND**

- 3. When you entered the commercial establishment, you intended to commit theft.**





## II. What does this mean?

You do not need to have actually have committed theft as long as you entered the business with the intent to do so. A person enters a structure if some part of his or her body or some object under your control penetrates the area inside the structure's outer boundary. A structure's outer boundary includes the area inside a window screen.

To intend to steal from the establishment, it must be shown that you intended to deprive the owner of it permanently/to remove it from the owner's or owner's agent's possession for so extended a period of time that the owner would be deprived of a major portion of the value or enjoyment of the property. If you do not enter a commercial establishment with this intent, you cannot be found guilty of Shoplifting.

An example of this would be a person who enters a book store with the intent to put four books into their bag and to sneak out of the store without paying for them.

## III. Penalties

A violation under PC 459.5 is a misdemeanor offense. If you are convicted under this section, you can be sentenced to up to 180 days in County Jail. You would be required to serve 50% of that sentence. You can also be fined up to \$1,000, as well as payback restitution for whatever items you took from the business. However, if you have certain serious prior convictions on your record as found under Prop 47, then 459.5 PC may be punished as a California felony. These serious prior convictions include homicide, forcible sex crimes, and any crime that requires you to register under PC 290.

## Effects [ edit ]

The measure's main effects were to convert many nonviolent offenses, such as drug and property offenses, from felonies to misdemeanors. These offenses include shoplifting, writing bad checks, and drug possession. The measure also required that money saved as a result of the measure would be spent on "school truancy and dropout prevention, victim services, mental health, and drug abuse treatment, and other programs designed to keep offenders out of prison and jail."<sup>[3]</sup> The measure included exceptions for offenses involving more than \$950 and criminals with records including violence or sex offenses.<sup>[4]</sup> For example, forgery had previously been a "wobbler" offense that could be charged by the prosecutor as a misdemeanor or a felony. Now with the passage of Proposition 47, prosecutors cannot charge a forgery involving less than \$950 as a felony unless the defendant has a criminal record.<sup>[5]</sup>

The measure both affects future convictions and allows for people currently incarcerated for crimes covered by the measure to petition for re-sentencing.<sup>[6]</sup> In November 2015, a report by the Stanford University Justice Advocacy Project authored by the co-author of Proposition 47, found that Proposition 47 had reduced the state's prison population by 13,000 and that it would save the state about \$150 million that year.<sup>[7]</sup>

For impact on crime rates, see below.

The provision allowing past offenders to petition for resentencing would have expired on November 4, 2017, though governor Jerry Brown approved a bill that extended the deadline to November 4, 2022.<sup>[8]</sup>

The take away here is that the state of CA was trying to save 150 million per year by letting people steal from you. Nice.



A March 2016 report released by the Center on Juvenile and Criminal Justice concluded that it was still too early to determine whether Proposition 47 had an effect on California's crime rates.[25]

A study in June 2018 by the Public Policy Institute of California found evidence that Proposition 47 may have contributed toward an uptick in larceny and auto break-in thefts.[26]:2[27] **The study indicates it found a decline in recidivism and no evidence of an increase in violent crime linked to Proposition 47. [26]:2**

However, a 2018 study from the University of California, Irvine, maintains that Prop 47 was not a "driver" for recent upticks in crime, based upon comparison of data from New York, Nevada, Michigan and New Jersey (states that closely matched California's crime trends) **1970 to 2015, but that "what the measure did do was cause less harm and suffering to those charged with crime."**[28]

Numerous media outlets have continued to report an increase in retail theft related to the passage of Prop 47. Large retailers Safeway, Target, Rite Aid and CVS pharmacies reported in 2016 that shoplifting increased from 15 percent to (in some cases) over 50 percent since voters approved Proposition 47.[29] The Los Angeles Times reported in 2017 that the California Supreme Court ruled that a person convicted of a felony for stealing a car may have that conviction reduced to a misdemeanor if the vehicle was worth no more than \$950,[30] and in **2018 that researchers found Prop 47 contributed to a jump in car burglaries, shoplifting and other thefts.[31] The San Francisco Chronicle reported in 2018 that Prop. 47 led to a rise in the larceny theft rate of about 9 percent compared to the 2014 rate.[32]**

**5/8/2**By 2019, organized retail theft was on the rise; police attributed it to Prop 47.[33]

## Shoplifting Laws (PC 459.5) in California



Just 4 years later and the obvious consequences were quite visible when ignoring this Instruction from Yahuah.

Progressives in California in recent years have strengthened property rights—to other people's property. Shoplifting has essentially been decriminalized, and retailers that apprehend thieves can be sued. The result: Another Walgreens store in San Francisco, the seventh this year, is closing after its shelves were cleared by looters.

Some retailers have adopted a policy of private decriminalization, in many cases prohibiting their security guards from physically apprehending shoplifters. Liability losses, they believe, outweigh property losses. When I asked the manager of Seattle's 96,000-square-foot Target if employees followed a "no touch, no chase" policy, he responded: "Officially, I can't tell you our policy, but if you watch our front door for an hour, you'll see pretty clearly what's happening." According to reports, the store likely has ten to 40 "security incidents" a day, including a dramatic incident last year when a drug-frenzied man went on a 15-minute rampage, destroying displays and merchandise, only to walk out the door with duffel bags full of goods. Police never arrived.

By 2019 with the ease of shoplifting to purchase drugs and decriminalization of drug crimes, this policy created quite a mess. Most of all hurting those this was supposed to help by ramping up the addictions, but everyone pays in prices going up to cover losses, increased crime and decreased safety.


Unfortunately, as West Coast cities grapple with an addiction epidemic, the shoplifting boom has only accelerated because of decriminalization. California's Proposition 47, approved by nearly 60 percent of voters statewide in 2014, reclassified many drug and property felonies as misdemeanors, effectively decriminalizing thefts of \$1,000 or less. Many criminals now believe, justifiably, that they can steal with impunity. For example, in San Francisco, police reported 33,000 car break-ins last year; the city now leads the nation in overall property crime. In Portland, a repeat offender nicknamed the "Hamburglar" stole \$2,690 worth of meat in one year. He bluntly told police officers: "I know the law. I know the rules. I know what I can and can't do . . . I'm never going to get over \$1,000 at any store." The Portland Police Department, which doesn't assign officers to retail theft cases, admits that official statistics vastly underreport actual crime.

The shoplifting crisis isn't limited to the West Coast. Retailers across the nation **report** \$16.7 billion in losses to shoplifting. In many cases, they simply pass along the cost to consumers, with one **study** suggesting that this “shoplifting tax” costs the average family \$400 a year. In Seattle, the shoplifting boom has forced some retailers to **close stores** in the downtown commercial district, citing massive losses and the threat of violence against employees. Another store, Outdoor Emporium, called 911 more than 200 times last year, but the city **prosecuted** only one of the incidents. Other retailers have stopped reporting shoplifting altogether—in a **recent survey**, downtown Seattle businesses reported “less than 5 percent of the daily crime they experience.”

Never-the-less, Lindell says he can prove the election was stolen on many levels. **150 million** have already watched his first voter and election fraud documentary called “Absolute Proof.”

And now let me pass from official stealings to what I may call associated or corporate stealings. There is something in the very nature of the organization of a company which somehow tends to the extinction of personal responsibility. Property records indicate the first three homes were bought under Ms. Kahn-Cullors name, but the fourth estate just north of Malibu, California, was purchased using a limited liability corporation she controls, according to FBN.

All aspects of your user experience are reduced to mechanical **algorithms** focused on "engagement," with little-to-no regard for the larger consequences and long-term impact. You are left to suffer the ramifications, **while they are allowed to profit**. We live in a world where it is nearly impossible to engage digitally **without having our data collected**. That doesn't mean we should accept the status quo. Like any resource, personal data should be used as a tool to benefit and enhance our lives. At the core of this conversation, we don't need five, 10 or 100 reasons why you should profit from your data. **We just need one -- owning your data is your right.**



## THE BIGGEST PONZI SCHEME IN WALL STREET HISTORY: BERNARD MADOFF




In hindsight, one wonders how no one could see Madoff's lies? But you can't blame them. The answer is that they all fell for his reputation, and his secret to always win trades, somehow.

But there was one persistent man who worked for a competing investment firm, and he got fed up with Bernie's perfect numbers.

A long road to justice

That man was **Harry Markopolos**, a former executive of the securities industry, forensic accounting, and financial fraud investigator. He and his team had crunched the numbers and **were confident that Madoff was running a huge Ponzi scheme.**



Madoff's wizardry didn't blind Markopolos, and he knew it was impossible to always be on the winning side of stock trades like Madoff reported. It was too good to be true.

Very much indeed, none of it was true. **Madoff never executed a single trade with all that money. Those monthly reports of ever winning trades, with stocks from prestigious companies, were all fake. False. Fugazi.**

Bankers had gotten greedy and took high risks for years to get fat profits and bonuses. They gave **mortgages to anyone back then without asking any questions**. They just wanted to loan money and then profit out of those loans in the securities market.

The motto was, "who doesn't pay their mortgage?" Based on that, **banks made filthy gains out of the loans**. An initial transaction of one or two million dollars was turned into hundreds of millions like nothing, using **controversial, custom-made, financial instruments**.

All that led to the burst of a **financial bubble worth trillions of dollars that didn't exist**. It **all fell apart when people couldn't pay their mortgages, and the real value of assets came to light**.

In this grim panorama of recession, the Madoff fund **investors thought their money was safe and wanted to redeem it**. But Madoff knew it was the end, as he could never have the liquidity to pay so many investors back.

While the financial world was being set on fire, **he took a few days to distribute the last assets among family accounts and some valued clients, before confessing to his family**. The day after, his sons turned him in to the authorities. It was the end.

They both had cut ties with their mother, Ruth Madoff, after the scandal. She was particularly criticized for trying to hold on to some of the money that Madoff had moved to family accounts.

The role of Madoff's family in the fraud was a gray area for a long time. At first, everyone assumed that his wife and sons knew everything and were accomplices. But they didn't. They were just more of the victims that Madoff managed to keep in the shadows.

The two sons worked in the legitimate part of the business, on the 19th and 18th floors of the iconic Lipstick Building in New York. Madoff directed the fraud in between, but they didn't even have the security card required to access the 17th floor. Whenever his sons, or anyone, confronted Madoff with questions, he would get upset and elude the answers, arguing that they didn't need to know. And of course, no one wanted to upset Bernie, so they just stopped asking questions.



Sure, there must have been red flags all over, but his family was used to seeing their dad being praised as a Wall Street eminence, not accused of running scams.

The false Madoff statements, representing what investors believed they owned, was a total balance of approximately \$64 billion. In a series of payments, obtained through legal action, victims have recovered \$9.16 billion, more than half of the \$17.5 billion reportedly invested.

So, that's good. But people can only hope to recover their original investment. All the returns that Madoff promised them for years and that they counted on just never existed.



Markopolos presented evidence to the U.S. Securities and Exchange Commission, 48 the SEC, as soon as 2000. Nothing happened, so he went back in 2001.

After inconsequential, routine audits, the SEC supposedly found nothing wrong with Madoff's business and gave more people the green light to keep giving him money.


**The SEC is the federal agency founded after the financial crisis of 1929 to restore investor confidence by ending misleading practices like stock manipulation. Or Ponzi schemes. Yet, they did nothing with the evidence that Markopolos put together for them.**

For almost a decade, he insisted on giving them all they needed to uncover the scam and save more victims from coming in. Do you remember butt-whooping the SEC got from the U.S. Congress when the scandal blew up in the verge of the financial crisis?

That's right; it took a major economic crisis to expose Madoff lies. The year 2008 saw one of the worst global banking crises in history, with the collapse of Wall Street symbols like Lehman Brothers, Bear Stearns, and financial institutions around the globe. It was the end of an era of obscene greed and corruption in financial institutions. Or at least we hope it was.

## A Madoff Son Hangs Himself on Father's Arrest Anniversary

Mark Madoff, the older of Bernard L. Madoff's two sons, **hanged himself in his Manhattan apartment on Saturday, the second anniversary of his father's arrest for running a gigantic Ponzi scheme that shattered thousands of lives around the world.**

"Mark Madoff took his own life today," Martin Flumenbaum, Mark Madoff's lawyer, said in a statement. "This is a terrible and unnecessary tragedy." **He called his client "an innocent victim of his father's monstrous crime who succumbed to two years of unrelenting pressure from false accusations and innuendo."**

According to Deputy Police Commissioner Paul J. Browne, officers responded to a 911 call made just before 7:30 Saturday morning from Mr. Madoff's apartment building at 158 Mercer Street. Mr. Browne said Mr. Madoff's body was found hanging from a black dog leash attached to a metal beam on the living room ceiling. He said there was no evidence of foul play.

Mr. Madoff's 2-year-old son was asleep in an adjoining bedroom, Mr. Browne said.



Law enforcement officials said Mr. Madoff had sent e-mails to his wife in Florida sometime after 4 a.m. Saturday. “It was more than one,” said an official, who added: “He basically tells his wife he loves her and he wants someone to check on the child.”

A person in close contact with the family who had spoken with Mark Madoff frequently in the last few weeks said he had been in “**an increasingly fragile state of mind**” as the anniversary of his father’s arrest approached. The person said Mr. Madoff had expressed both continuing bitterness toward his father and anxiety about a series of lawsuits that were filed against him, his brother Andrew and other family members.

Just last week, Mr. Madoff, 46, was among the directors and officers of a Madoff affiliate in **London who were sued by the trustee seeking assets for victims of the scheme.**

It was **the second lawsuit filed against him by the trustee**, Irving H. Picard, who had initially sued him last year seeking to recover approximately \$200 million that the family had received in salaries, bonuses, expense-account payments and gains in their own investment accounts at the Madoff firm.


Mr. Madoff was particularly **upset that the trustee had named his young children as defendants in a lawsuit filed in late November seeking the recovery of money** Bernard Madoff had paid out to his extended family over the years, according to the person who recently spoke with him, who insisted on anonymity because he was not authorized to speak on behalf of the family.

The person said Mr. Madoff had also been **upset at some recent news coverage speculating that criminal charges against him and his brother were still likely.**

Charges have not been filed against any of the immediate family members, and their lawyer has said publicly **that neither Mark Madoff nor his brother has ever been notified by prosecutors that they were the subjects of a criminal investigation.**

Nevertheless, there has **been speculation** that members of the Madoff family were vulnerable to being **prosecuted for tax-law violations**, given the variety of low-cost loans and generous expense-account payments that were part of the office culture at the Madoff brokerage firm.

The person who had recently spoken with Mr. Madoff said that there was also growing discouragement about finding a job. **“He had concluded he was unemployable,”** the person said.



Mark and his brother immediately consulted a lawyer and were advised they had to report their father's confession to law enforcement. They did so, and the following morning their father was arrested at his Manhattan penthouse.

The public fury over the stunning crime [Bernard Madoff estimated the losses at \$50 billion [was not limited to its mastermind. Mark Madoff, his mother and his brother were all the subject of constant media speculation. Many articles speculated that they had been involved in their father's crime, or at least were aware of it.

The lawsuits that are pending against Mr. Madoff will not necessarily be derailed by his death. Typically, the litigation would continue against the estate of any deceased defendant.

Gregarious and handsome, Mark was the more outgoing of Mr. Madoff's two sons. At the University of Michigan, his social circle included students largely from other well-to-do East Coast families.

He graduated in 1986 and moved to New York to join his father's firm. Most of his friends rented cramped studios, but Mark lived in an apartment his father had bought for him in Sterling Plaza, a luxury high-rise on Manhattan's East Side developed by Sterling Equities. Sterling is controlled by Fred Wilpon, the owner of the New York Mets, whose family was friendly with the Madoffs and whose businesses had invested hundreds of millions of dollars in the Ponzi scheme.



Peter Chavkin, a lawyer for **Ruth Madoff**, Mark's mother, said simply: "Ruth is heartbroken."

Mark Madoff had been a licensed broker at his father's firm since June 1987. **A number of Mark's oldest childhood friends from Roslyn, N.Y., invested with the Madoff firm and lost their savings** in the fraud, said another person who was close to the family. **This destroyed those relationships and caused Mr. Madoff great pain**, the person said..

And on the advice of his lawyer, Mark Madoff has had no contact with his parents since the day before his father's arrest two years ago.

The steps that led to that arrest began when he and his brother, Andrew, confronted their father over his plans to distribute hundreds of millions of dollars in bonuses to employees months ahead of schedule.

Prosecutors reached an agreement with Bernie's wife, Ruth Madoff, to keep \$2.5 million and a small home.

According to documents filed by the F.B.I. at the time of the arrest, that meeting led to a private conversation on Dec. 10, 2008, in which Bernard Madoff told his sons that all the wealth and success the family seemed to possess were based on a lie — an immense Ponzi scheme that was crumbling under the pressures of the financial crisis.



His brother **Andrew** was considered more cerebral and reserved than Mark, and served as co-director of trading with his brother. He, too, joined his father's firm after earning an undergraduate business degree from the Wharton School at the University of Pennsylvania.

The civil lawsuit Mr. Picard filed last year said Bernard Madoff's firm "operated as if it were the family piggy bank." It said **Mark received at least \$66.9 million of improper proceeds, including approximately \$30 million in compensation since 2001, from his father's firm.**

Mark and his relatives were "completely derelict" in carrying out their roles at the firm, the suit said.

At the time, Mr. Flumenbaum, Mark's lawyer, said in a statement that his client "**strongly disagreed with the trustee's baseless claims.**"



# Andrew Madoff, Who Told of His Father's Swindle, Dies at 48

**Andrew H. Madoff**, the last surviving son of the convicted swindler Bernard L. Madoff, **died on Wednesday in a Manhattan hospital, where he had been undergoing treatment for cancer. He was 48.** A family lawyer, Martin Flumenbaum, said the cause was mantle-cell lymphoma, for which Mr. Madoff had been treated since early 2013. His older brother, Mark, committed suicide in 2010.

After the arrest, it became clear that his fraud was one of the largest Ponzi schemes in history, with paper losses of almost \$65 billion, cash losses of about \$17 billion and tens of thousands of victims ranging from Swiss private bankers to labor union pension funds to notable charities and universities. After Bernard Madoff's arrest, both sons denied any knowledge of the scheme, **which federal prosecutors later said had probably begun when they were children. No criminal charges were ever filed against them.**


**In the only judgment rendered so far, a British judge in 2013 rejected the trustee's case there against the Madoff sons, affirming their "honesty and integrity" and ruling that there was no evidence that they were involved in the crime.**

Neither of his sons ever visited the senior Mr. Madoff after his arrest, and just last year, Andrew Madoff told a writing seminar at Princeton University, "My father is dead to me." In an earlier interview, he told The New York Times that **his father's fraud was "a father-son betrayal of biblical proportions."**

But **the suspicion and harsh publicity that followed** the arrest became a heavy burden for the family. In December 2010, on the second anniversary of the arrest, Mark Madoff hanged himself in his Manhattan apartment, sending a last note to Mr. Flumenbaum contending that **“no one wants to believe the truth.”**

Andrew, too, acknowledged the **damage the case inflicted on him, blaming it for the return in December 2012 of the cancer he had fought off in 2003.** “One way to think of this is the scandal and everything that happened **killed my brother very quickly,**” he said in a People magazine interview last year. **“And it’s killing me slowly.”**

But unlike his brother, Andrew refused to cringe from the spotlight or hide from critics. He helped his fiancée, Catherine Hooper, build a consulting firm to advise others on dealing with life-shattering developments. He joined with Ms. Hooper and his mother, Ruth Madoff, in promoting an authorized family biography, which was published in fall 2011.



When his cancer returned, he detailed his experience with stem-cell transplant treatments in a private blog made available to family and friends.




After a series of optimistic reports, the final blog post, dated Aug. 9, noted that he had been hospitalized again but also said that he and Ms. Hooper had taken advantage of the summer's beautiful weather to take several hiking trips. "Getting away from the city crowds and breathing fresh, clean air is a godsend for me," he wrote. "I can feel my body healing as I drink it in."

Fishman told Market Watch. “At one point, he cornered the hot chocolate market. He bought up every package of Swiss Miss from the commissary and sold it for a profit in the prison yard. **He monopolized hot chocolate! He made it so that, if you wanted any, you had to go through Bernie.**”

In phone interviews with The Washington Post at the time, Mr. Madoff expressed remorse for his misdeeds, saying he had “made a terrible mistake.” “I’m terminally ill,” he said. “There’s no cure for my type of disease. So, you know, I’ve served. I’ve served 11 years already, and, quite frankly, I’ve suffered through it.”




Mr. Madoff's enormous fraud began among friends, relatives and country club acquaintances in Manhattan and on Long Island — a population that shared his professed interest in Jewish philanthropy — but it ultimately grew to encompass major charities like Hadassah, universities like Tufts and Yeshiva, institutional investors and wealthy families in Europe, Latin America and Asia.



Buttressed by elaborate account statements and a deep reservoir of trust from his investors and regulators, Mr. Madoff steered his fraud scheme safely through a severe recession in the early 1990s, a global financial crisis in 1998 and the anxious aftermath of the terrorist attacks in September 2001. But the financial meltdown that began in the mortgage market in mid-2007 and reached a climax with the failure of Lehman Brothers in September 2008 was his undoing.

The victims of his fraud, some of whom went overnight from comfortable wealth to frantic desperation, numbered in the thousands and were scattered from Palm Beach, Fla., to the Persian Gulf.

More than money was lost. **At least two people, in despair over their losses, died by suicide. A major Madoff investor suffered a fatal heart attack after months of contentious litigation over his role in the scheme.** Some investors lost their homes. Others lost the trust and friendship of relatives and friends they had inadvertently steered into harm's way.



Besides the human toll, **professional reputations were destroyed**. More than a dozen prominent hedge funds and money managers, including **J. Ezra Merkin and the Fairfield Greenwich Group**, had to admit that they had forwarded their clients' money to Mr. Madoff without detecting that he was running a fraud. **Swiss private bankers, global commercial banks and major accounting firms were dragged into court by clients who had relied on them to monitor their Madoff investments.**



The Securities Investor Protection Corporation, the industry-financed organization set up in 1970 to provide limited protection to brokerage customers, spent more on the Madoff bankruptcy than on all its earlier liquidations combined — and was fiercely attacked by victims, who felt they had been wrongly denied compensation.

And for the Securities and Exchange Commission, which unsuccessfully investigated more than a half-dozen credible tips about Mr. Madoff's fraud scheme since at least 1992, **it was the most humiliating failure in its 75-year history.**

But there was no sign of distress in the Madoff family lifestyle. While not conspicuously ostentatious by Wall Street standards, the Madoffs lived well. Besides a duplex penthouse on the Upper East Side of Manhattan, they owned a handsome beach house on Long Island, a vintage mansion in Palm Beach and an apartment near the Mediterranean in the south of France; several large powerboats; and a share in a corporate jet.




They were respected philanthropists as well, contributing to cancer research and making major gifts to Yeshiva University, where Mr. Madoff was a trustee and the chairman of the Sy Syms School of Business. He had also served on the boards of several Wall Street organizations, including the National Association of Securities Dealers, now known as Finra.

Before being sentenced on June 29, 2009, in a Manhattan federal courtroom packed with spectators and victims, he read from a statement he had prepared with his defense lawyer, Ira Lee Sorkin.

“I am responsible for a great deal of suffering and pain, I understand that,” he told the court. “I live in a tormented state now, knowing of all the pain and suffering that I have created. I have left a legacy of shame, as some of my victims have pointed out, to my family and my grandchildren.”

Mr. Madoff is survived by his wife, Ruth; his brother, Peter; his sister, Sondra M. Wiener; and several grandchildren.

He leaves nothing of his former wealth behind. As part of its criminal case, the government sought more than \$170 billion in forfeited assets, a figure that apparently includes all the money that moved through Madoff bank accounts — for whatever purpose — during the years of the fraud.



**December 2010:** Picard sues JPMorgan Chase & Co, Madoff's main bank, for \$6.4 billion, saying it enabled Madoff's fraud.

**January 2011:** A bankruptcy judge approves a \$7.2 billion settlement with the estate of Florida investor and former Madoff friend Jeffrey Picower, the largest single recovery obtained for Madoff's victims. The estate provides \$5 billion for Picard to distribute, and forfeits \$2.2 billion to the U.S. government.

**October 2011:** Picard begins payouts to former Madoff customers with an initial \$312 million distribution.

**November 2013:** The U.S. government sets up a \$2.35 billion Madoff Victim Fund, which is funded mainly with money from the Picower settlement. Former SEC Chairman Richard Breeden is appointed to oversee the fund.

**January 2014:** JPMorgan agrees to pay \$2.6 billion to settle with Picard and the U.S. government. Some of this money goes to the Madoff Victim Fund, which grows to \$4.05 billion.

**November 2014:** Picard's recoveries surpass \$10 billion.

**June 2015:** The U.S. Supreme Court declines to hear Picard's appeal from a lower court's refusal to let him try to recoup more than \$4 billion from some Madoff customers.

**June 2017:** The estates of Mark and Andrew Madoff and related defendants reach \$23 million of settlements with Picard.

**November 2017:** The Madoff Victim Fund begins payouts.

**February 2020:** Madoff asks for compassionate release from prison. His lawyer says Madoff suffers from terminal kidney failure and other ailments and has fewer than 18 months to live.

~~June~~ **2021:** Judge Chin denies compassionate release.

**April 2021:** Picard has reached more than \$14.4 billion of settlements, and paid out more than \$13.5 billion on 2,654 allowed claims. The Madoff Victim Fund has paid out almost \$3.2 billion to more than 36,800 individuals and entities.

**April 14, 2021:** Madoff dies.



We have given you some ranging applications of "Do not continue to steal", and we are sure there are many more. As we have seen the consequences go far beyond what any could have imagine. Death, despair, prison, humiliation and shame. No one gets away with it forever.

As we let this percolate in our spirits, let us be broad minded in identifying what stealing is.

There are consequences to consider even for the ongoing smallest offense. The larger habitual offenses create wars, famines, economic, political, medical and societal disasters. If we are quick to identify if a person has this character flaw, maybe our future will hold a brighter promise.




